On 3-10-67, EUGENE G. LINK, 10 Deerpath Rd., Charlottesville, Va., who is Regional Representative, Office of Surplus Property Utilization, Department of Health, Education and Welfare, Regional Office, Charlottesville, Va., advised that he and his wife had resided in Dallas, Texas, during the period of the assassination of President KENNEDY. He advised that his wife had recently received a phone call from MARCELLA INSUA of 3710 W. Beverly Dr., Dallas, Texas, with whom his wife had been closely associated in the Cuban Catholic Resettlement Committee in Dallas around the time of the Presidential assassination. LINK advised that as a result of his wife's conversation with MARCELLA INSUA and the recent newspaper publicity given to the investigation being conducted by the New Orleans, Louisiana District Attorney GARRISON, that MARCELLA INSUA had suggested that perhaps her files relating to the Cubans who had settled in the Dallas area might possibly be of interest in any investigation pertaining to the assassination of President KENNEDY.

LINK advised that MARCELLA INSUA had indicated that she had no information which would in any way link any of the individuals of Cuban origin who had resettled in the Dallas area, were in any way involved in the assassination, however, she desired to make available the background information in those files if they might be of interest to the FBI. LINK advised it is his understanding that the Cuban Catholic Resettlement Committee is now defunct, but that MARCELLA INSUA has possession of all records pertaining to the various individuals handled by the Committee.

LINK advised that MARCELLA INSUA had also requested him to contact GARRISON in New Orleans and advise him of the location of those records if they were of a matter of interest to him. LINK stated he had telephonically attempted to contact GARRISON, at which time he left his number, but had not received any phone call in reply. LINK stated that as a result of lengthy conversations with his wife regarding the matter, she knows of no possible implication of any of the individuals on whom INSUA maintains records with the assassination of KENNEDY.

Since the foregoing would not appear to be of a substantive nature in relation to the investigation of the assassination of KENNEDY, no LHM has been submitted to the Bureau and the foregoing is being furnished to the Dallas Office for their information and for whatever action they may consider appropriate.
