Four Indicted in Test Of Cuba Travel Ban

The federal grand jury in Brooklyn which for a month has been investigating the recent trip to Cuba by 58 American students handed down four indictments on Sept. 27. The charges are阴谋 to commit and arrange for the trip.

The announcement of the indictment was made in Washington by Attorney General Robert Kennedy and by the federal prosecutor's office in Brooklyn.

Three of those indicted — Levi Louis 24, Phillip Abbott Levy 26 and Stefan Marinoff, 24, had gone on the trip to Cuba. The fourth defendant, Anatol Schleser, 26, did not go.

Two others, Salvatore Cucchiari, 19, and Ellen Irene Shultz, 29, were named as co-conspirators but were not indicted.

The indictment alleged 21 overt acts of conspiracy such as organizing a committee to promote the trip meetings in New York and Buffalo; distribution of application forms etc.

There is no law forbidding travel to Cuba. There is a State Department edict. Thus the prosecution had to base the indictment on the purpose of the trip.

Civil Rights Forces Seek New Ways to Press Fight

The Birmingham events and the Kennedy administration's handling of them have made many people question whether the movement led by Martin Luther King Jr. has reached a standstill and a search must be made for new goals.

The debate involves the question of non-violence versus self-defense, political action, the approach to Congress and Kennedy's civil rights bill, and tactics of civil disobedience.

The doctrine of non-violence, under all circumstances, is being openly challenged even by church leaders. For example, Rev. Dr. Eugene Turner, pastor of the African Methodist Episcopal Zion Church, declared in Louisville that the Birmingham events have shattered the hope that law and order would be maintained in the Deep South in the face of integrated schools and public

"We call upon members and friends to be in the forefront of this activity and to urge their organizations for the collection of urgently needed aid.






THE EXTREME LEFT'S reversal of the decision of 500 Negro students arrested at a demonstration in Oromondale, B. C., three years ago, strikes a blow against the use of state "break of the peace" statutes against civil rights demonstrators.

The problem is the same old of segregation between a black middle class and a white middle class. The former is a federal law which makes the Junior League, the Knights of Columbus, the Moose, the Elks and other organizations, despite many good intentions, do little to help Negroes. The latter is a state law which makes the police and politicians do little to help Negroes.

Consequently, despite many good intentions, Negroes are discriminated against and given less opportunities than whites. This is the basic reason for the Negroes' desire to change their status quo.
