Re: SA JOHN W. FAIN, 7/10/62, Dallas, in the case entitled "LEE HARVEY OSWALD, IS-R", and prior communications in that matter. The subject in the captioned case is OSWALD's wife, married to him in the Soviet Union, and, along with their infant daughter, brought by him to the United States upon his return to this country.

A file has been opened in the Dallas Field Division on subject under the SOBIR program. The files of INS, Dallas, have been checked. These revealed no information not already known and reported in referenced report on subject's husband.

The case on LEE HARVEY OSWALD is in pending status and he is to be reinterviewed. It is not believed any active investigation of his wife or interview of her under the SOBIR program is logical or advisable at this time. It is felt her activities can be sufficiently followed at this time in connection with the case on her husband. It is noted there are no subversive references on any member of the husband's family, and, under present circumstances she will be closely and intimately associated with them. According to INS records she is proficient presently only in the Russian language.

In view of the foregoing, the case on subject will be maintained in a pending inactive status in the Dallas Field Division for a period of six months, SACR. At the expiration of that time, it will be reopened and considered for further warranted or advisable action.



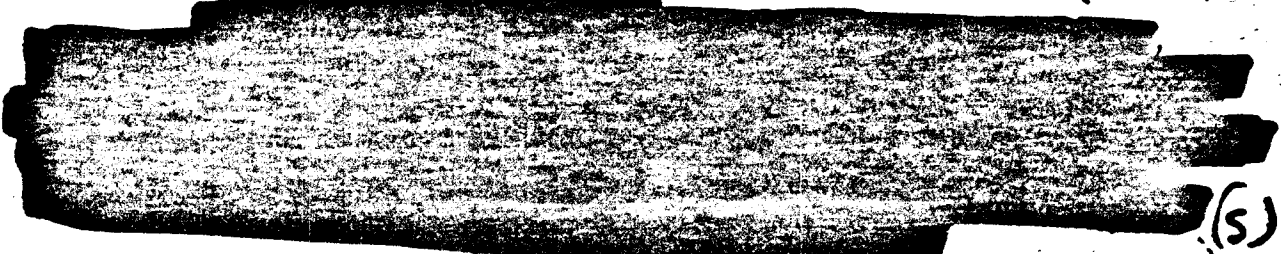

For the information of Little Rock and Legat Mexico, subject LEE HARVEY OSWALD received an undesirable discharge from the U. S. Marine Corps on 8/17/60 after attempting to defect to Russia and denounce his United States citizenship at the U. S. Embassy, Moscow, Russia, on 10/31/59. Subject and his Russian born wife, MARINA MIKOLAEVNA OSWALD, and their daughter, born 2/15/62 at Minsk, Russia, returned to Fort Worth on 6/14/62. Following his return to the United States, subject, LEE HARVEY OSWALD, was a subscriber to "The Worker", and was in contact with the Fair Play for Cuba Committee. In May of 1963, subjects moved to New Orleans, Louisiana. New Orleans reported that on 9/25/63 subject and his wife vacated their apartment in New Orleans, Mrs. OSWALD reportedly returning to Texas.
