On 8/22/61, the passport file of LEE HARVEY OSWALD was reviewed by SA VINCENT P. DUNN and found to contain the following info: (U)

By letter dated May, 1961, to the American Embassy, Moscow, USSR, OSWALD advised he had no intention of returning to the U.S. unless he was given a guarantee that he would not be prosecuted for any act pertaining "to this case." He also indicated he married a Russian girl born in Leningrad and wanted to bring her to the U.S. with him. (U)

On 7/10/61, OSWALD executed an "Application for Renewal of Passport" at the American Embassy in Moscow. His residence at that time was USSR, Britsa Kalinina 4, Apt. 24, Minsk. This renewal application indicated that OSWALD was issued U.S. Passport #17332 on 9/10/59, at Washington, D. C. The subject's renewal application was referred to the State Department for consideration and decision. (U)

On 7/10/61, OSWALD appeared at the American Embassy in Moscow at which time he stated he was employed in the Belo-Russian Radio and Television Factory in Minsk as a metal worker in the research shop. He stated he took no oath or allegiance of any kind to the Soviet Union, nor was he required to sign any paper in connection with his employment. He gave his earnings as 90 rubles per month. (U)

OSWALD said that he intended to apply for an exit visa immediately upon his return to Minsk. He also stated that he desired to bring his wife with him to the U.S. (U)

By memo dated 8/18/61, the State Department authorized the American Embassy in Moscow to renew OSWALD's passport for direct travel to the U.S. (U)

On 9/5/61 the following inquiries were made at Fort Worth, Texas, by SA JOHN W. FAIN:

JERALD M. PLUMMER, 1612 Hurley Street, advised that Mrs. MARGUERITE OSWALD, subject's mother, resided at 1612 Hurley Street, Fort Worth, for several weeks following her return to Fort Worth from Boyd, Texas, beginning about April 1, 1961. She was employed for a short period for the Ables' Cleaners, but is understood to have left Fort Worth three or four months ago for employment on a ranch somewhere in the vicinity of Munday or Benjamin, Texas, exact address unknown to Mr. PLUMMER.

LOUISE ABLES, Ables' Cleaners, 1621 - 8th Avenue, stated that Mrs. OSWALD worked as an alterations employee for approximately one or one and a half weeks during about April 1961, but she resigned three or four months ago and went to a ranch located somewhere in northwest Texas in the Wichita Falls, Texas, area, where she had prospects for keeping house for some unknown couple on a ranch.

Mrs. DOROTHY REEDER (protect identity), Assistant Superintendent of Mails, U. S. Post Office, Fort Worth, advised that on 6/3/61 Mrs. MARGUERITE OSWALD, 1612 Hurley Street, Fort Worth, left a forwarding address of "General Delivery, Crowell, Texas."

On 9/18/61, R. L. OSWALD, 7313 Davenport, Fort Worth, where he continues to be employed as a sales coordinator, Marketing Department, Acme Brick Company, stated that he had just received a letter, dated 9/10/61, from his brother, the subject, wherein

subject mentioned that he was working in an electrical shop at Minsk, Russia. Subject mentioned that he owns a shot gun and occasionally goes hunting. According to R. L. OSWALD, subject has been married to a Russian girl, an orphan, by the name of MARINA, age about 18 or 19. Subject has written R. L. that MARINA was a nurse. According to R. L. OSWALD, MARINA seems to be very intelligent and from her photograph appears to be nice looking. This girl, prior to her marriage resided with her uncle and aunt. R. L. OSWALD stated MARINA desires to come to the United States with subject. R. L. OSWALD stated subject's letter was not too optimistic for his chances of getting to come back to the United States at an early date and subject indicated his belief that the Russians were "holding up" his return to the United States. R. L. OSWALD stated that subject has been severely critical of the Russians in his letter and he was surprised that the Russians would allow him to make criticisms.

R. L. OSWALD stated that his mother is residing at Crowell, Texas, but that he has no information as to the name of the people with whom she is residing and that on her letter of 7/19/61 she merely placed a return address of "Crowell, Texas."

Rerep SA JOHN W. FAIN, 7/10/62, Dallas, in the case entitled "LEE HARVEY OSWALD, IS-R", and prior communications in that matter. The subject in the captioned case is OSWALD's wife, married to him in the Soviet Union, and, along with their infant daughter, brought by him to the United States upon his return to this country.

A file has been opened in the Dallas Field Division on subject under the SOBIR program. The files of INS, Dallas, have been checked. These revealed no information not already known and reported in referenced report on subject's husband.

The case on LEE HARVEY OSWALD is in pending status and he is to be reinterviewed. It is not believed any active investigation of his wife or interview of her under the SOBIR program is logical or advisable at this time. It is felt her activities can be sufficiently followed at this time in connection with the case on her husband. It is noted there are no subversive references on any member of the husband's family, and, under present circumstances she will be closely and intimately associated with them. According to INS records she is proficient presently only in the Russian language.

In view of the foregoing, the case on subject will be maintained in a pending inactive status in the Dallas Field Division for a period of six months, UACB. At the expiration of that time, it will be reopened and considered for further warranted or advisable action.

On 9/28/62, [redacted] a source who has furnished reliable information in the past, made available photographs of names and addresses of subscribers maintained by "THE WORKER," an East Coast communist newspaper. Included was the name of LEE H. OSWALD, 2703 Mercedes Street, Fort Worth, Texas.

On 3/4/63, MR. JEFF WOOSLEY, Supervisory Clerk, INS, Dallas, Texas, advised that MRS. MARINA OSWALD as of January, 1963, resided at Apartment 2, 602 Elsbeth, Dallas, Texas. On 3/11/63, MRS. M. F. TOBIAS, Apartment Manager, 602 Elsbeth, Dallas, Texas, advised that on 3/3/63, LEE HARVEY OSWALD and his wife MARINA moved from that apartment building to another apartment building in Dallas, Texas. MRS. TOBIAS advised that they had considerable difficulty with MR. OSWALD, who apparently drank to excess and beat his wife on numerous occasions. MRS. TOBIAS advised that they had a small child and that MRS. OSWALD apparently spoke little or no English and seldom associated with any other individuals. They had had numerous complaints from the other tenants due to OSWALD's drinking and beating of his wife.

called me today. I have known [REDACTED] for some time and he is a very conscientious and sincere person. He said he had consulted with the Episcopal Diocese of which he is a leader relative to religious people doing something to rehabilitate the wife of Lee Harvey Oswald, assassin of President Kennedy. He said he thought it would be well if Christian leaders took an approach to this widow in order to explain to her more fully the free way of life we enjoy and also to make available to the widow religious thought, materials and religious good will made manifest through constructive action on her behalf. He asked me if we would have any objection to this particular religious approach to Mrs. Oswald.

I told [REDACTED] that we had nothing to do with any such matter and that it would have to be a matter for themselves to decide. He discussed the desirability of taking steps to teach her English; give her some practical education, say in secretarial work; and help her secure a position with probably some religious institution in a section of the country other than Texas. He asked me if there was any branch of the Government that might have an interest in Mrs. Oswald, to which he could talk. I suggested he take the matter up with the Immigration and Naturalization Service.

Attached is my personal check for \$10.00. I would like for you to make whatever arrangements are necessary to forward it to Mrs. Oswald, of Dallas, Texas.

Like the rest of the world I am disturbed and angered by the assassination of my President. Further I am greatly disturbed by the killing not only of officer Tibbit, but by what seems to be a pattern of disrespect for and violence to all law enforcement officers.

My personal respect and admiration for your men stems from being in a position to watch them work for many years. The nation's faith in, and respect for, the men of your department and the men of the secret service has been well earned often under trying circumstances.

I have no way of knowing whether Mrs. Oswald is in any way personally involved in this situation. Knowing the philosophy of your department I know that if she is, you will find it. If she isn't, you will find that too.

However as one innocent until proven guilty, at this point she is the suddenly widowed mother of two small children in a strange country. If she is innocent of any part or knowledge of her husband's activities, she is to be pitied even more than Mrs. Kennedy and Mrs. Tibbit. Her faith in mankind must have been horribly killed. Her children are as innocent as Caroline and John-John. She seems to be without either financial resources or the traditional American sympathetic and helping hands.

If from your position of knowledge Mrs. Oswald should not receive this way I request that you apply it to whatever benefit organization is sponsored by your men, or if you prefer, forward it to Mrs. Tibbit. I have contributed to the local police department's fund which is being raised for Mrs. Tibbit.

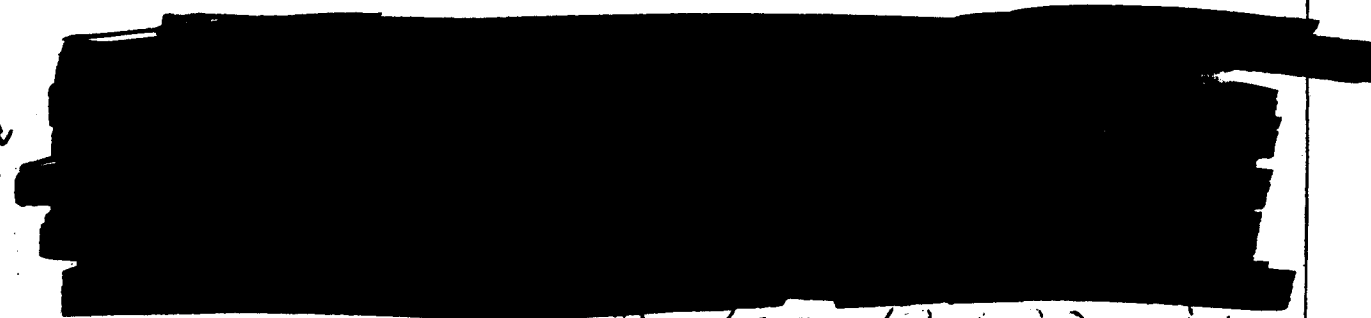

SUBJECT: ASSASSINATION OF THE PRESIDENT

Inspector Burl Peterson of the Secret Service called. He handles the press for Jim Rowley. Peterson told me that pressure was building up from the news media regarding possible interviews of Mrs. Marina Oswald. He stated thus far they have resisted all attempts to interview her and they planned to continue this policy.

Peterson wanted to know what I thought about his telling the New York Times that Mrs. Oswald is being protected by the Secret Service for obvious reasons, that her time was taken up fully and that she will not be made available to the press for interview.

I told Peterson that regardless of what he said to the New York Times he would undoubtedly get a bad press, however, that his position was undoubtedly sound and that it would seem rather foolish for the FBI or Secret Service to pre-empt the President or the Presidential Commission by shooting off our mouths at this stage of the game. Peterson agreed and stated they would hold the line. He indicated that the FBI would not be mentioned in any contacts with the press unless he cleared with us first.



SUBJECT: ASSASSINATION OF PRESIDENT KENNEDY

Deputy Attorney General Katzenbach telephoned. He advised that he had been contacted by representatives of the American Bar Association with whom he deals regularly in connection with the qualifications of persons being considered for the Federal bench.

He was told that the American Bar Association had received several contributions for the benefit of Mrs. Oswald and her children. The total amount involved is between \$1,000 and \$2,000. Katzenbach has been asked by the Bar Association officials as to his recommendation for handling these contributions. One of the questions raised is whether Mrs. Oswald had been completely cooperative with the Government. Katzenbach asked if we could give him any guidance in this regard.

Katzenbach was informed that the facts as we developed them were set forth in our report and this report would have to speak for itself.

Katzenbach said that there were some difficulties here in that it was necessary to go through an intermediary as Mrs. Oswald didn't speak English and he didn't know whether she had an attorney. After thinking the matter over, Katzenbach said he was just going to suggest to the Bar Association that they proceed by contacting a local attorney in Texas and follow through on whatever advice the private attorney might furnish.

On December 12, 1963, SA COOPER telephonically contacted a woman at 18601 Concord, Detroit, who said she was BERNICE PETERS and that she had sent several such letters to various neighborhoods in the Detroit area. She was asked how the donor could be certain that any money sent to her would be forwarded to Mrs. OSWALD, and she said that she was maintaining a list of all donors and the list would be later published in "The Detroit News," a Detroit daily newspaper. She said that was the reason for the request to sign for any donations sent. She further said she was going to mail the money to "~~Mrs.~~ PAINE in Texas," the woman with whom Mrs. OSWALD had made her home.

SA COOPER did not identify himself and utilized a pretext of [REDACTED] <sup>Ruth</sup> 67E

No further action is being taken by Detroit and the foregoing is for the information of the Bureau and Dallas in the event any inquiry is received concerning this matter.

Inspector Tom Kelly, Secret Service, telephonically advised that Secret Service was seriously considering removing the detail that they had assigned in Dallas looking after the safety of Marina Oswald. Kelly stated before doing so, he desired to discuss this matter with the Bureau as to whether it would affect the Bureau's work in any manner.

Inspector Kelly was advised that the matter of looking after Mrs. Oswald by the Secret Service was one that was strictly up to the Secret Service; that any matters being handled by the Bureau would proceed regardless of whether Secret Service had been assigned to Mrs. Oswald or not. Inspector Kelly mentioned the possibility that if the detail is removed there might be considerably more difficulty in handling the interview that the Bureau was conducting with Mrs. Oswald. Inspector Kelly was told that while his comments were undoubtedly accurate, the Bureau was not in a position to request Secret Service to either continue or to discontinue their physical custody of Mrs. Oswald.

Inspector Kelly indicated that he would probably take this matter up with the Department of Justice and in all probability with Deputy Attorney General Katzenbach.
