## Mrs. Oswald's Father Is a Colonel — In Red Military Intelligence

WASHINGTON—The father of Mrs. Lee Harvey Oswald is a colonel in the Soviet military intelligence service, on duty in the Minsk region.

Oswald lived for some time in that area during his three years in Russia.

The disclosure regarding Mrs. Oswald's father is among the most startling in the unpublished 127-page FBI report titled "Investigation of the Assassination of President Kennedy."

Beyond reporting what had been gleaned from Mrs. Oswald regarding her father's occupation, the FBI does not delve further into the matter. There is no indication in the FBI study of any connection between this information and the murder committed by Oswald.

Another significant disclosure in the FBI report is the estimate of \$3,560 as the killer's income in his last 14 months. This figure was based on his widow's accounting.

Mrs. Oswald will be personally questioned by the special commission headed by Chief Justice Earl Warren. This interrogation will be private.

No consideration has yet been given to holding public hearings.

The commission will hold some public sessions, but not until after the trial of Jack Ruby, slayer of Oswald. The commission already has decided on that. It has given no thought as yet to witnesses to be heard at the open sittings.

Similarly the FBI report, now in the hands of the commission, will eventually be published. But this may not be until the commission makes its own report.

The FBI study consists of six "books": two containing a largely chronological recital of events leading up to and following the assassination, and four mostly of exhibits.

U. Lee Rankin, general counsel of the commission, is compiling a list of questions on the basis of the FBI report. These questions apply to both Oswald and Ruby, and deal with a number of "unanswered gaps." Foremost among them is Oswald's mysterious trip to Mexico last fall (September 26 to October 3).

The Central Intelligence Agency has reported he was accompanied by two women and a man, the latter subsequently flying to Cuba. The CIA also ascertained that while in Mexico City, Oswald applied to the Cuban consul-general for a transit visa to Moscow. He was told he would first have to get a visa from the Soviet, but so far as is known he did not seek that.

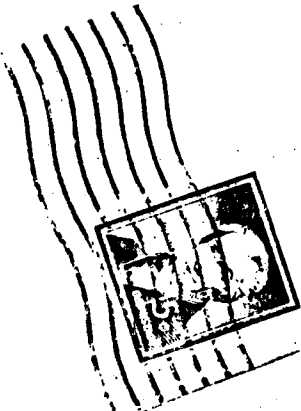
At the special commission's request, the FBI has resumed its probing of both Oswald and Ruby. These investigations are proceeding simultaneously.

Dear Mr. O'Bierne:

It certainly was a pleasure talking to you last Friday morning regarding our proposed plan for helping Marina Oswald and her two children. Such a program not only would help these three innocent victims, but as you agreed should be helpful in restoring the prestige lost by the assassination of Oswald.

I feel that our National prestige has suffered a severe blow. We are encouraging the underdeveloped and newly formed nations to accept and apply democratic forms of government, and by one vicious and notorious act we tell the world we no longer respect the laws of our land. Instead, we tell them that we believe in individual action when it best suits our needs. Obviously, this is not the true condition as exists in our Country, but it certainly is the condition that we so effectively advertised to all the world. Our apparent lack of respect for law is extremely serious. The foundation on which democracy is built is the respect of citizens for the laws of the land.

I believe that by our accepting Marina Oswald and her two children as respectable individuals and helping them to become good and useful American citizens we would be doing much to enhance our prestige throughout the world.

Attached is a copy of my letter to Mrs. Kennedy's Secretary, Miss Pamela Turnure, which explains the problem with which I am faced. In order to promote this program it is essential that I have a statement from some national figure or from some government agency merely stating that Mrs. Oswald and her two children are deserving of help. Could you find some way to give me the letter that I need without doing anything contrary to your Agency's policy? If not, could you obtain for me a letter from some other agency that would serve my purpose? I hate to have to make this request of you but I am sure you can appreciate my problem. I certainly do not want this program to die - it must not!

None of us believes in guilt by association. If we fail to receive a statement, knowing that she is deserving of our assistance, isn't our silence condemning her because of her association? Surely this is not the way we Americans think and act!

I want to thank you for the time you gave me last Thursday and for your interest in our proposed program for helping Marina Oswald and her two young daughters. The following day while enroute to Honolulu I again stopped in Dallas and had a lengthy discussion with her Attorney, and her Business Manager, and I now am convinced even more that she is an innocent victim of the tragedies and is deserving of help.

On returning to Honolulu I reported to my Rotary Club friends details of my various visits on the trip. They were much interested but feel that before Rotary can sponsor such a project it is essential that some national figure or government agency state that the Oswald family is deserving of help. I have discussed this matter in detail with Mr. Gordon Shanklin of the F.B.I. in Dallas and Mr. J. W. O'Bierne in Washington. Both spoke well of the way Mrs. Oswald has been conducting herself and in the manner she has cooperated with the F.B.I. Both gentlemen pointed out that the function of the F.B.I. is to collect information and not to give opinions. In view of my desperate need for help I am writing to Mr. O'Bierne today asking him if he could give me some letter that would not be contrary to the policies of the F.B.I., or else ask some other agency to send me a letter that would be helpful to us.

I still feel that you are correct in your feeling that this matter should not be brought to Mrs. Kennedy's attention at this time--it would be unkind--but there is the possibility that at most any time she may make a sympathetic comment voluntarily regarding Mrs. Oswald's family. If such should occur and if Mrs. Kennedy would have no objection I would be most grateful for any statement you could give me.

I hate to see such a worth while project die because of a technicality. Surely the fate of this innocent young mother and her two infant children should not hang by the thread of a technicality.

Again, thank you for your kindness and attention shown me last Thursday.

## REVIEW *and* OUTLOOK

### The Third Widow

Moved by a medley of uncertain impulses, we sat down one evening last week and sent a small sum to a minister in Plainfield, N.J. At that moment we felt grateful for the iron privacy of the mailbox; we weren't sure what our friends and neighbors would think upon seeing, in our own handwriting, an envelope destined for the minister's Mrs. Lee Oswald Fund.

Now we've had more time to sort out our own feelings, and learn that we were not alone. What emerges is a conviction that this minister's gesture, and the response to it and others like it, is a glimpse of America's best side in action.

Much nonsense has lately been expressed by some about the nation's dark side, the collective sins that supposedly culminated in Lee Oswald's infamous act. There are some, perhaps, who would vent their outrage in vengeance against even an innocent wife and children men do not easily overcome the primitive force that drives them sometimes to punish—at the least, to shun—all those near an outrageous malefactor.

But this has never for long been the way of the American people. One hundred years ago the people, if not every

one among them, rose above the temptation to take their vengeance on Edwin Booth, distinguished brother of a despised assassin. In our own time the nation rejected the ugly and vindictive proposals to exact a Carthaginian victory out of World War II to the injury of innocent men. Instead, America went to the aid of its fallen enemies.

This, even in a moment of great emotion, is still the way of the American people. No one holds this young woman or the children she bore responsible for the evil in a murderous man. Born in an oppressed land, she married him in hope and came to our country with a dream. For her, the hope had faded long before a fatal Friday afternoon shattered so many dreams forever. And when she too walked to a graveyard—alone, destitute, not even speaking the language of the country that was once her shining hope—good men could not but share a little of their grief with a mother and children denied even the solace of pride.

We don't know how much all this will be understood by those who rush so quickly to denounce America. But it matters to us that so many people show a deeper feeling for the nation's heart.

On January 17, 1964, the captioned individual visited Bureau Headquarters and spoke to SA John W. O'Beirne of the Crime Research Section,

b7c [REDACTED] indicated that he is a member of the Rotary Club in Honolulu and has approached the headquarters of Rotary concerning its view as to whether or not it would support a fund drive for the benefit of Mrs. Lee Harvey Oswald. He said that immediately after President Kennedy's assassination, he felt most sympathetic to Mrs. Oswald because of the actions of her husband and noted that she was not in any way sympathetic and, as a matter of fact, felt remorse over the death of the President at the hands of her husband. He advised he was moved to send a check for \$1,000 to her through an attorney in Philadelphia who he learned was coordinating contributions for Mrs. Oswald. It was [REDACTED] observation that some of the prestige lost by the United States through Oswald's murder could be recouped if a fund drive for Mrs. Oswald was publicized widely, thereby demonstrating the goodness of the American people in the face of a great personal loss which they suffered through the President's assassination.

b7c [REDACTED] wanted to know what the FBI's feelings were regarding Mrs. Oswald and had she been cooperative. He felt a need for some kind of a statement from some public figure in order to enlist the support of the Rotary and his friends in developing a fund for Mrs. Oswald. [REDACTED] was advised by O'Beirne that it is not the FBI's role to endorse any person or thing and, in addition, the entire matter of the President's assassination was presently being considered by the commission appointed by the President.

O'Beirne is now in receipt of a letter dated January 22, 1964, recalling his visit to Bureau Headquarters and asking that O'Beirne furnish him with a statement from some National figure or some Government agency merely stating that Mrs. Oswald and her children are deserving of help. Enclosed with this letter is a copy of one he sent to Miss Pamela Turnure, Mrs. Kennedy's personal secretary, in which he advises her he has requested O'Beirne to furnish him with some kind of a letter that would not be contrary to the policies of the Bureau regarding Mrs. Oswald.
