Bennett said he had just received a most urgent request from his New York office requesting that he contact the FBI to see if we could make available any photographs of Marina Oswald. He said that she was to be Time's "cover subject" next week and the magazine was urgently seeking photographs. Bennett then laughed and said that he, of course, knew the answer before he called but had to go through the motions. Leinbaugh told Bennet that he was right that as he well knew we could not make information or photographs available to them.

SUBJECT: ASSASSINATION OF PRESIDENT

b7D At 3:55 p. m., [redacted] who is an announcer for CBS, called and spoke to Kemper in my office. He said that he had seen somewhere that Maria Oswald's father was a Russian intelligence official and wondered if we had any comment. Kemper told him we had no comment on it.

b7D [redacted] said he also heard that Oswald had an excellent memory and had memorized all of the codes when he was stationed with the Marine Corps on the West Coast. He was advised we could make no comment.

b7D [redacted] said that he had just come from a news conference where Maria Oswald had been interviewed. She told the press as follows:

1. That her husband told her that he had shot General Walker.
2. When asked why she did not report this to the police, she said "I am a wife."
3. She said she did not know whether her husband was trying to shoot the President or Governor Connally, that he had never said anything bad about either one of these individuals.

b7D [redacted] said that she seemed a little nervous but was very self-possessed.

Dear Mr. Hoover

My letter is a surprise for you. But let me please at first great you and furthermore apologize for my writing. I know it isn't well 100% but I guess you will understand it and I do hoping the letter will reach you.

Why DO I write to you? It must have a reason! Yes there is one. I go briefly into further details. I like to make a true story and would need your help. Please. I do hoping I will get it, please.

The story has two points. At first right now there are investigations in the murder case of the assassinated President Mr. Kennedy and I learn a lot from newspapers and ask myself why no editor here has some questions and columns? What are they.

- a) I learned Lee Oswald was abnormal as he returned from Russia. I miss here some questions: Which one... Why did he live in Minsk? I haven't seen a column here about this. Why and why he lived at Minsk
- 2) The widow of Lee Oswald gets sent money so some \$ 55,000. But has any editor check from where the money is coming? no column about this.

**** My question is to you the following: I please you to have an interview with the widow of Lee Oswald because I would like to ask her some questions really hot ones and questions which I have found out here in papers have never been asked to her.

Why I say this about the questions. I'm myself an editor I mean I was a former editor in sport but I have lived under Occupation and something is just plain true when you live under Occupation. Besides this it gives you a different kind of feeling because editors here have never dealt with some kind of problems here. So they can't know it.

I do hope it is clearly enough said by me. **** Dear Mr. Hoover please apologize now but I just write what I feel. In the past I have had some hot news and all have been rejected because it was always told me it isn't important but later on it was frankly the true and I just found that in newspapers. Papers which I have read in libraries

**** I do not write down here the questions but have it ready what I do like to ask and by her answers I would have new another questions

* I know the widow is protected by agents and it will be hard to get there but that's the reason why I wrote to you.

**** My second key question is. I like to write a story about "Spies" in the past and ask for your help. Why this. The historic proved that with the beginning of so called "Peace Organizations" it started to undermine freedom and ended with the overruling of free governments. I felt this on my own body. But really true. If you can't believe it.

Let me explain just one of my feeling so you understand my letter better:

** Few days ago it happened at New York that the leader of the school strike in New York and as I have learned Organizer

2) But my feeling is that some newspaper columns about the riots. Papers write there is nothing wrong but that is wrong and written against the US.

**** My answer:

SO some weeks ago african students rioted at Moscow on the red square against the commies.

What would have happened if the american ambassador in Moscow would have invited the leader of the african student riot for a party at the american embassy in Moscow.

I bet for 1000000% that after few hours Mr. Krutchev would have been on the air and broadcast the the "american capitalists" have organized the riot of the african students and maybe he would have told for to violate some laws to leave the ambassador and maybe there would have been a big politic struggle.

*** NO american editor who wrote as Mr. Rustin invited the russian UN Mission has realized that what he did was wrong. Instead some editors wrote there is nothing wrong as he attended a champagne party...

But I guess you understand me now what I mean.

**** Dear Mr. Hoover. I'M NOT a politician NOT member of parties NOR connected with somebody else. But I see that some kind of writers really dont realize whats really going on and that they are writing with unknowledges or with knowledge just for the other side and their own country.

***** THIS is important now; I DO HOPE NOW please you will NOT say to me now what; I'M criticize or because in the past when I have said something like this it always was told me it is nonsense or I criticize or it was rejected.

***** But from my own feeling I have experience because I was occupied and know where the so called "Peace committees and which other names they all have" have their headquarters and who directs them. There are so many here in the US and all have one destination...to help to bury like the chairman of this committees always points out. This peace committees must "little wheels" on the road to get really the whole world under a iron curtain.

**** As I know from my own; Freedom is lost very easy which you loose by wakers to much relaxing and to turn down everything until you find out it is to late. TO many millions have died for this; TO much relaxing wakers and to much believing in the word Peace.

I guess dear Mr. Hoover if ever the letter reach you you will understand me.

I'M just a little wheel a little zero in the world but who is shocked to see the same process working now the same process who has brought millions under the control of the reds.

Again please dont think I criticize because I'M afraid really to say something because in the past I was turned down to much when I have had some important stories.

Will I have the interview? I'M hoping very much and I would show you only the questions before I'M interviewing. I'M sure it will be a good interview and bring some light into new aspects. I repeat I'M just a little wheel but I would be glad to do so.

McCormack had evidenced interest in the case. He has been affiliated with numerous newspapers as a free lance sports writer in Hungary, Poland, Czechoslovakia, Bulgaria and Yugoslavia dating back to 1951. On interview with The American Embassy he admitted he had attended Youth Festivals in Europe, supposedly to report sports events but appeared reluctant to being questioned about his participation in such Youth Festivals. (105-7-252-93) No other pertinent references located in Bufiles.

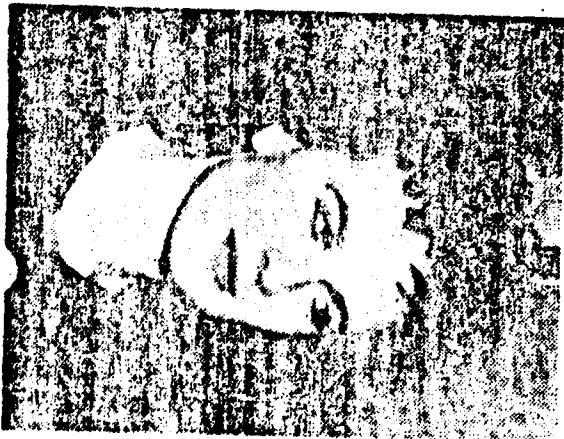
The only way in which rumors, lies, and slanders against the Society can be dispelled is for people to think for themselves instead of being merely parrots who take in and give out exactly what

SUBJECT: ASSASSINATION OF THE PRESIDENT

b7c [redacted] called and spoke to Kemper in my office on 3/3/64.

b7c [redacted] said that he is retired and was an employee for 30 years with [redacted]. He said he is partially blind and is very active in the work of the Presbyterian Church in Washington, D. C. He said that there had been quite an uproar caused in the various local churches because a directive has come from the head of the Presbyterian Church in Chicago urging that all churches put a piece in the church letters and take up a collection for Marina Oswald. He said he is greatly opposed to this and wondered if there is any information which we could give him which would indicate that Oswald was the assassin and which would help him in his fight against taking up such a collection. He said he called the "Dallas News" and had learned that Mrs. Oswald, wife of the assassin, had already received \$40,000 and that she was going to get \$50,000 from syndicated newspaper items.

b7c [redacted] felt that the Presbyterian Church could find better use for its money.

b7c Kemper explained to [redacted] our position in this matter in that the President had appointed a commission and we had no facts we could give out as to the guilt or innocence of Oswald.
