Marina Oswald Enters U of Michigan Class

ANN ARBOR, Mich. (AP) —

The pretty University of Michigan coed wore a babushka-like scarf around her head and a blue skirt and sweater as she met with newsmen for a brief chat.

Although she resembled most of the thousands of other coeds on the Ann Arbor campus, the student was Marina Oswald, 23, widow of the assassin of President John F. Kennedy.

The Russian-born Mrs. Oswald began classes Tuesday in the university's English Language Institute, which specializes in teaching the language to foreigners.

Chalgren, Lund Practice Adds Third Psychiatrist

An experienced neurologist and psychiatrist with a military, Mayo Clinic and state institution service record, has joined the Mankato medical community.

Dr. Carl A. Schwartz, formerly of Austin, now is associated with Drs. W. S. Chalgren and J. B. Lund, 460 Martin building, in the practice of neurology and psychiatry.

A native of Pennsylvania, Dr. Schwartz has been a Minnesota resident for the past 11 years. He is a product of Ursinus college and University of Pennsylvania school of medicine. After graduation in 1947 he interned and had two years of special training in pathology and internal medicine at Geisinger medical center, Danville, Pa.

Following two years of Navy medical corps duty Dr. Schwartz was a fellow at Mayo Clinic in Rochester, 1953-57.

He served as acting clinical director and chief of psychiatric service at Anoka state hospital 1957-59. Since 1960 he has been the psychiatrist at Mower county mental health clinic in Austin; served as medical director of Northwest Iowa mental health center, Decorah, Iowa; consulting psychiatrist to Luther College, Decorah, Iowa, to Red Wing State training school for boys and to Minnesota Security hospital in St. Peter.

Dr. Schwartz is a member of the Minnesota State Medical As-

sociation, American Medical Association, American Psychiatric Association, Academy of Psychosomatic Medicine, Association for Adolescent Psychiatry and Juvenile Officers Association of Minnesota.

He also has served on the governor's council on youth and delinquency, the mental health planning council for Minnesota and on the committee on forensic psychiatry of the state medical association.

Married 14 years, Dr. and Mrs. Schwartz are the parents of one son, age 10, and two daughters, two and one.

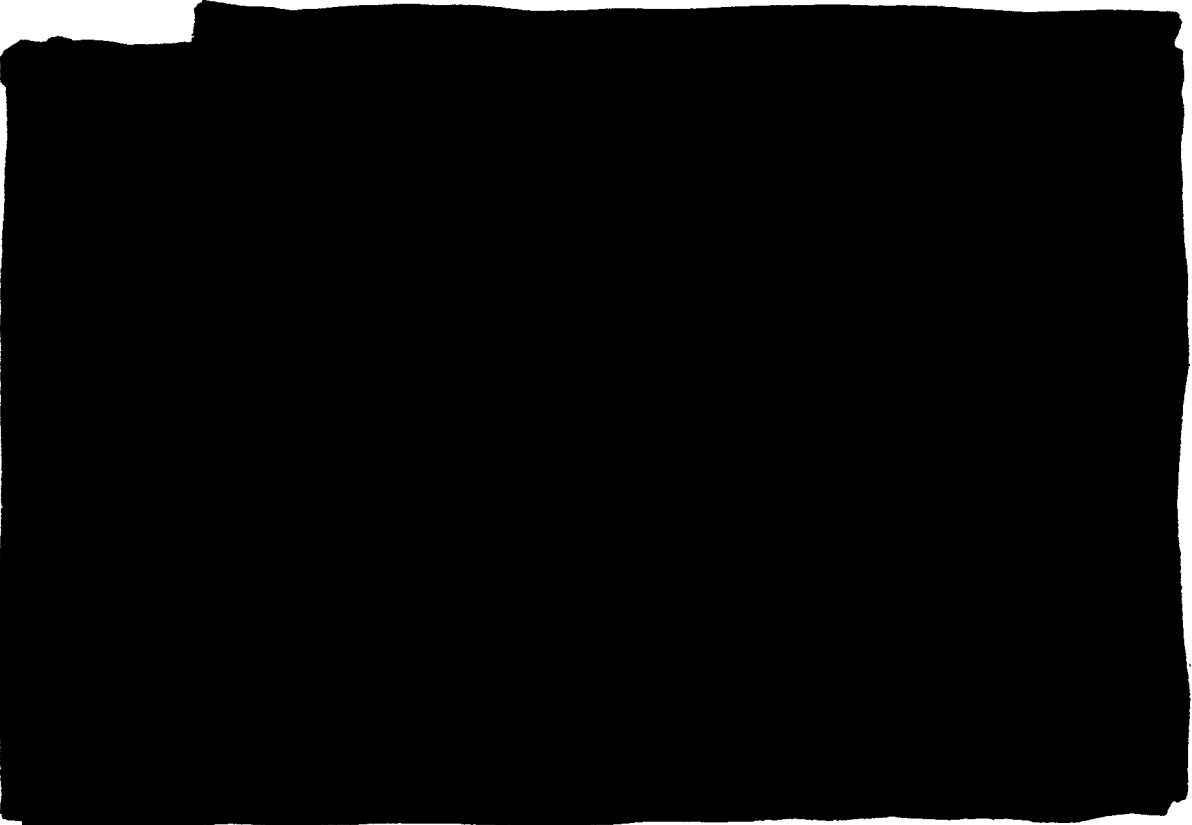
III. REVIEW OF RECORDS, UNITED STATES

Mr. DECLAN FORD, 14057 Brookcrest, Dallas, Texas, who is the agent and advisor of MARINA OSWALD, advised 2/1/65 MARINA OSWALD's present plans are to return to Richardson, Texas, at the end of February, 1965. He stated he does not have a great deal of information concerning MARINA OSWALD's present activities other than she is attending her classes at University of Michigan. FORD said he did not know of any acquaintances MARINA OSWALD had in Ann Arbor or Detroit, Michigan, at the time she entered the University of Michigan. He stated he could not identify any person who might be a brother of a close friend of MARINA OSWALD in Dallas.

FORD advised his wife and he, along with MARINA OSWALD, had attended a New Year's Eve party with various actors from the Dallas Theater Center. He advised MARINA OSWALD had become acquainted with various of these actors and it is very possible one of these actors had a friend or relative in Detroit with whom he suggested that MARINA contact upon her arrival in Michigan.

FORD advised he would contact Dallas Office concerning any information he receives concerning activities of MARINA OSWALD.

Bureau liaison learned from INS on 4/5/65 that Lois A. Turney, Information Section, INS, Washington, D. C., received an anonymous telephone call on that date containing a threat against the life of Marina Oswald. The telephone call was received at 1:20 p.m. by Turney from an unknown man. He said that if Marina Oswald becomes a U. S. citizen, he would kill her with his own hands. According to Turney, the man repeated this several times. Turney suggested the caller put his threat in writing and have it made a part of the records but the caller said he wouldn't sign anything. The caller also said that Marina Oswald had made enough money and INS should let her get out of the country, like Liz Taylor has done.

INS advised Bureau liaison that it had notified Secret Service Headquarters. INS also stated it had notified its Dallas Office of the call and instructed its Dallas Office to advise the Dallas Police Department. You should immediately bring this information to the attention of appropriate Police Department responsible for law enforcement in Richardson, Texas, where Marina Oswald resides.

Many American people are worried about Mrs. Marina Oswald and wonder if there is not some way that she may be deported to Russia. We are sorry for her experience as the wife of the late Mr. Oswald and this sympathy was shown in the many gifts to her at the time of his death.

This marriage to a young man, twice divorced, and now her claiming the rifle which killed the late President Kennedy because she has been offered \$20,000 for it, makes her an undesirable person for the United States and it is the opinion of many that her ties are with Soviet Russia. Also, this husband being an employe of Texas Instruments, a concern having millions of dollars worth of contracts for Government use instruments, makes one wonder if there isn't something which bears watching. I trust that your department and that of the Attorney General never let up in checking her movements if legally she cannot be returned to Russia. I am not the type of person who sees Communism in everything which happens, but when a person has been reared under that source, there is a question if he or she ever becomes anything except a Communist.

Marina's Mate A 'Swell Guy'

The new Mrs. Kenneth Jess Porter is married to a "swell guy," according to friends and neighbors of the former Mrs. Lee Harvey Oswald who greeted her marriage Tuesday by trying to shield the couple from news- men.

"He's the nicest guy you ever met," said a long-time friend of the 27-year-old, 6-foot electronics technician. "If he has any bad habits, it's fishing."

And Marina and Ken, as his friends call him, do a "lot of fishing and boating together."

The couple met on the patio of a comfortable brick home at 1249 Donna St. in suburban Richardson two months ago. She had just returned from Ann Arbor, Mich., and an eight-week course in English to buy a home at 1245 Donna.

CHECKED NEIGHBORS

"She went around the neighborhood before buying the house to make sure no one would mind," recalled a neighbor. "And we didn't. It's a friendly neighborhood and she's a very sweet person."

It was at the home of Bill Clark, where Mr. Porter was renting a room, that the courtship began.

The couple had coffee together there, relaxed with the Clark family—whose son Joe works with the bridegroom at Texas Instruments—and perhaps it was the Clark family which first knew of the impending wedding.

"Marina said over coffee one day, about a month ago, 'I love Ken,'" Mr. Clark said. "And I figured they might get married when Ken stopped seeing any other girls but Marina."

An ex-landlady, who was called by the FBI about her former tenant before the wedding even took place, recalls him as "a very clean cut and quiet young man."

PROMPT WITH RENT

"He lived here at the Trade-

winds Apartments (108 S. Bowser in Richardson) for more than a year, and he always paid his rent on time," the manager said (she did not want to be named). "He was very quiet and kept an immaculate apartment."

"He was a loner and didn't use the pool," she said. "He just fished and worked and didn't mix with the other tenants."

The former Greenville High School student has another hobby, and excels in it.

He is a drag racing enthusiast with a room full of trophies from Greenvalley, Whitehouse, Valley Mills, and other drag strips. This may be one reason that newsmen who tried to follow the couple to their wedding Tuesday were left far behind whenever they came upon the 1965 red sports sedan being used for the trip.

Marina has fished with Mr. Porter on Lake Tawakoni and Lake Texhoma and "she seems to enjoy it," another friend said.

About his job, his friends know little. "He just doesn't talk about it," one said.

NAVY VETERAN

Mr. Porter is a Navy veteran. He is very fond of the two Oswald children—June Lee, 3½, and Rachael, 1.

Friends say he intends to adopt the two children at the earliest possible time.

Mr. Porter, who was divorced in January, 1964, has two children by that marriage. His former wife, Wanda, declined to comment on the wedding, but still resides at their former home on Rustic Circle in Richardson.

Other neighbors are very happy for the couple, and Mrs. Peek—a friend who was keeping the Oswald children—said telegrams, flowers and cards were arriving from throughout the United States wishing the young couple luck.

Marina, Groom Put Trust in Fate

FATE — Fate (Rockwall County, Texas, that is) smiled on Marina Oswald and her new husband, Kenneth Jess Porter, by offering them privacy from pursuing newsmen for a simple wedding ceremony.

The 148 men, women and children of this rural community were not aware that one of the world's most famous women was being married by their justice of the peace at 6:45 p.m. Tuesday.

Scores of newsmen were roaming the north central part of Texas searching for the couple as 41-year-old Peace Justice Carl Leonard Jr. solemnized the marriage vows.

"She said she just wanted a simple ceremony, in a hurry, before the reporters caught up with her," Mr. Leonard said.

PLOWING INTERRUPTED

He was surprised to find who he was to marry after leaving his plowing at the request of Rockwall County Sheriff W. J. Price.

"I didn't recognize Marina when I stepped out of my pickup until the sheriff introduced me," he said.

Sheriff Price, along with his daughter, Judy, a college sophomore, accompanied Marina, Mr. Porter and two men and a woman from nearby Rockwall in the sheriff's car.

"I was plowing behind my house when the sheriff called to ask if I could marry a couple," Mr. Leonard said. "I still had on my work clothes when I got to the office."

The office, in which the civil "double ring" ceremony took place, is a small white frame building 12 feet by 12 feet. It is simply furnished with an old roll-top desk, a few chairs and a framed fire department citation on the wall.

Justice of the Peace Leonard, who said he was "naturally surprised," talked briefly with the pair and noted: "Marina was very pretty in a white dress and she said she was very, very happy." Mr. Porter wore a sports shirt.

LICENSE IN SHERMAN

They presented a Grayson County marriage license signed by Mary Chumbley and issued in Sherman earlier Tuesday.

Mr. Leonard, who also farms and operates a tire store at Fate, has married 50 couples since becoming Justice of the Peace in 1957, and he said it was his policy never to disclose "how much the fee was in a wedding."

An unidentified woman was Marina's maid of honor and one of the two men with the couple, known to the Justice of the Peace, only as "Mr. Wooldridge," was the best man.

The tiny room was filled with the wedding party, which left Fate in the sheriff's car immediately after the ceremony.

"I read from the standard marriage ceremony 'what God has joined together let no man put asunder,' pronounced them man and wife, and they kissed and left," the justice of the peace said. "It only took about 10 minutes and they were gone. It sure has been a day to remember. The telephone calls from all over the United States began then."

Marina's Marriage 'Surprise'

As Marina Oswald hopefully began a new life today as the wife of a Dallas electronics worker, Mrs. Marguerite Oswald protested any possible changing of the names of Lee Harvey Oswald's two children.

"Lee's children are very wealthy in their own right. If Marina's husband adopts Lee's children, he might get control of their money," said the mother of President Kennedy's assassin.

"I have a right to speak out on this point. I'm those children's grandmother," she said.

Mrs. Oswald also said she would have hoped that Marina would have married an older man with "no prior family."

KENNETH J. PORTER, 27, divorced and the father of two children, married Oswald's widow yesterday in a quiet ceremony in the office of a peace justice in Fate (Rockwall County).

"This was a quickie marriage. Just two weeks ago, I heard Marina was going with an insurance salesman," said the grandmother, who has "dedicated my life to clearing Lee's name and setting history straight on the assassination."

"The whole thing (Marina's marriage) was quite a shock to me. It does affect me because I am the grandmother of Lee's children. My only interest is in my grandchildren. I was shocked to learn that Mr. Porter is divorced and has two other children to support. That's something to consider," continued Mrs. Oswald.

Mrs. Oswald has not seen the grandchildren since Nov. 28, 1963, six days after the assassination in Dallas.

THE MOTHER of the assassin also said she was "shocked again" when she learned that Mr. Porter had not told his own mother of his marriage. "When a boy doesn't tell his mother—well, that's something to consider," she said.

Returning to the subject of her son, slain by Jack Ruby two days after the president was killed, Mrs. Oswald said: "Lee's father was a wonderful person. I only hope Mr. Porter will be that kind of father to Lee's children."

MRS. OSWALD REPORTEDLY REMARRYING

Marina Oswald, widow of accused presidential assassin Lee Harvey Oswald was reported planning to remarry Tuesday in Oklahoma.

J. W. Golden, police chief in Richardson where Mrs. Oswald lives, said the widow and a 27-year-old Richardson man came by the chief's office Monday.

"Mrs. Oswald and Kenneth Porter came by and said they had decided to get married June 7 in Oklahoma," said the chief.

There was no official confirmation of the actual ceremony in Oklahoma.

Mr. Porter is an employe of the Texas Instruments semi-conductor division.

Last week, Mr. Porter told a Times Herald reporter that he knew Mrs. Oswald and that they were neighbors.

He denied at that time, however, that they had marriage plans.

A worker in Mr. Porter's department at TI said Mr. Porter was not at work Tuesday.

Chief Golden emphasized that Mrs. Oswald's informing him of her intention to get married was not in any official capacity.

"They just stopped by yesterday on a personal visit," he said. "It was just a personal thing."

He said he became acquainted with the widow because of her need for identification and other matters in the past.

Mrs. Oswald Has a Day

Mrs. Marina Oswald and a 28-year-old electronics technician, who rode into the widow's life on horseback 1½ months ago, were married Tuesday night in the tiny farm community of Fate in nearby Rockwall County.

The widow of presidential assassin Lee Harvey Oswald, and Kenneth Jess Porter, who was divorced here in January, 1964, were married by Justice of the Peace Carl Leonard Jr.

The day ended in the quiet community between Rockwall and Royse City after the couple and three companions raced from suburban Richardson to Oklahoma and back into North Central Texas.

The couple obtained a marriage license in Sherman Tuesday afternoon. Earlier they underwent blood tests and lunched at nearby Durant, Okla.

Their whereabouts were unknown until shortly after 7 p.m. when word got out that they were married at 6:45 p.m.

MRS. BILL CLARK, with whose family Porter has been living for several months at 1249 Donna in Richardson, said she introduced the couple.

Mrs. Oswald had moved from another Richardson home to a house at 1245 Donna.

Mrs. Clark said she and other members of her family were visiting with Mrs. Oswald in their backyard when Porter rode up on horseback.

Porter, who works with the Clarks' son,

Joe Clark, at Texas Instruments, was described as being quiet, reserved and very intelligent.

HE WAS DIVORCED in January, 1964. He and his former wife have two children—a daughter, 7, and son, 4. Sources said he was first married at the age of 17 to a Greenville girl. The marriage lasted only a short time.

In Fort Worth, Mrs. Marguerite Oswald, mother of the assassin, said she "doesn't care what Marina does with her life. I do want my children to have a decent father. Except for the children, I'm not interested in her affairs." She said she had not seen Mrs. Marina Oswald or her grandchildren since shortly after Oswald was gunned down by Jack Ruby.

The assassin's widow, who in recent months came out of seclusion and was
