

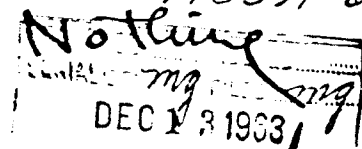

Will you please do something for me? Will you see that the enclosed letter is properly addressed to reach Marina Oswald? I have written to her in Russian and I am sending her a small sum of money.

Somehow, through all this tragedy of our President's death by assassination, my sympathy has been drawn most to Marina. This is a small town, and when I mentioned this in company of friends, I found I'd spoken to a hornet's nest of hostility. One lady threatened to turn me in to the FBI.

frightening in that, but her hate directed towards "that Russian girl" was.

Marina did not ask to be born in an atheist land - perhaps if we show her Christian love, it will help her and us, too. I cannot see how showing her charity will hurt our nation. From what little I've read and heard, I believe Marina has cooperated with the FBI. From what little I know about Russia and Communism, I doubt that she would find safety in her homeland. And from what I saw of her mother-in-law on TV, I don't think there is anything good for her from that quarter!

So my judgement in this matter is not based on much more than intuition - and my acquaintance with a Russian family here. Their escape from Communism is a hair-raising

story, and I have learned from  
them to appreciate freedom and liberty  
all the more. I have also learned  
a little Russian language from Ben,  
hence my ability to write a few  
words to Marina, lest you think  
I am a Red-lover. I'm not.
