Dear Mr. Thomson:

After the service Sunday evening, one of our Elders gave me the enclosed check for Mrs. Lee Oswald. Dr. Wilcox (Ph. D. in cancer research) is a very mature Christian, and has done outstanding work with our Senior Highs. She felt great compassion for Mrs. Oswald and her children, strangers in our country, facing the horrible stigma of her husband's act. (Whether he's guilty or not, she will never live it down.)

She asked that I telephone a minister in Dallas and ask him to handle it, so that it would reach her. I don't happen to know anyone in Dallas, although my uncle, E. P. Smith, served in the National Missions in East Texas for many years.

I selected your name because from the name of the church I guessed that yours is a down-town church, and you might be more likely to have contacts which would enable you to get in touch with her. I realize that this is an unusual request, and may involve some difficulty, but I feel that it is certainly in the spirit of the Master, and is a tiny gesture of the reconciliation which is so essential in the present stress. We will appreciate your help.

This morning in our memorial service I reminded our people of the guilt all of us must share in creating a society which produces such hatred and violence, and challenged them to take up Christ's ministry of reconciliation, after being first reconciled to God through Christ.

We are adding a small amount to Dr. Wilcox's gift, and hope you can get it to Mrs. Oswald, to let her know that there are some who do feel compassion for her.





Enclosed for Dallas is a letter, dated 1/7/64, from the Dallas Office addressed to "Occupant, 13508 Superior Road, East Cleveland 12, Ohio," which advises that the addressee's letter addressed to Mrs. MARINA OSWALD, c/o FBI, Dallas Office, will be delivered by the Dallas Office.

Miss ANN SWANSON, 13508 Superior Road, East Cleveland, Ohio, on 1/14/64, furnished the enclosed letter to the Cleveland Office. She advised that the letter was delivered to her apartment but obviously was meant for one of the other two tenants of this address. She identified the other tenants as Mrs. LILLIAN B. PHILLIPS, an unemployed widow in her late 70's or early 80's, and a Miss MILDRED A. KORMUTH, a factory worker employed by the General Electric Company, Cleveland.

She has no idea who addressed the letter to the subject's wife in care of the FBI, Dallas, however, mentioned that MILDRED KORMUTH has had a nervous breakdown and appears emotionally disturbed, whereas LILLIAN PHILLIPS leads a secluded life with very little social contact. Based solely on her personal knowledge of the two women, she believes that MILDRED KORMUTH is the writer of the letter.

The indices of the Cleveland Office contain no references identifiable with SWANSON, PHILLIPS, or KORMUTH.

I thank you for your letter of January sixth acknowledging the receipt of the gifts which had been sent to Mrs. Oswald.

or a most valuable adviser, perhaps both.

The truth is, Mr. Shanklin, here is a man 69 years old, with the financial ability to, the desire to, the temperament to make him worthy of being included among Mrs. Oswald's most immediate friends. in fact, the desire is to be more than that, financial ability, need have no bearing on friendship.

Two letters have been sent to Mrs. Lyndon B. Johnson relative to the possibility of her, or her representative, acting as intermediary between Mrs. Oswald and myself regarding the subject of our being together by our, I mean both Mrs. Oswald and the children, in my home.

In addition to the things which have been sent to Mrs. Oswald in your care, there have been some books sent in care of Mrs. Johnson at the time it seemed Mrs. Oswald would soon be in Washington.

I revealed a great deal about my- self to Mrs. Johnson. I now wish to do so to you

I, too, have been a loser much of my life. A life in which there was little security from the age of five years.

My mother died when I was five years old. Her brother - my uncle, of course, and his wife adopted me. There are nice memories of the love bestowed upon me in those early days.

When the mother died when I was five years old, this caused a Gropel-Hyde Transformation in my father, so bitter was he over his loss. From that time forward, he worshipped at the feet of Mammon. His worst marriage magnified feelings of insecurity.

At that time an adopted child enjoyed status only slightly above that of illegitimacy. And how often people relished reminding me of the fact.

Then there were still early incidents which had their effects.

My aunt sent me for a spool of thread for which the storekeeper said the price was the dime which she had given

me. When I told her there wasn't any
change, she accused me of appro-
priating the nickel.

Then, in spite of the fact that
the one good thing which my father
had inculcated into me - respect for
older people - he thrashed me when
it was reported I had sworn at
two neighbor ladies. The same
treatment due to the report that I
had been seen playing with children
who were in quarantine. Both false.

In those days I hardly knew
whether I was fish or fool. Daily
my cousins stirred into my ears
the refrain Maxwell & Charles Pottery
beautiful, Ball Mc Kay. I still don't
know the name of the Bradford allusion.

The girl who married me was
pushed into it by an avaricious
mother. So much so can be judged by
the fact that the morning after the
ceremony, she asked my cousins who
had remained overnight in the ship,
"Just how much is Max's father
worth." I think God this was not

revealed to me until after the de-
noce.

This has an illuminating side
light. When I informed her that such
action had been started she asked, "Why?"
I said that among the reasons was
the fact that for the past two years
her ^{own} bedroom relationship had afforded
me no more satisfaction than would
have that of a prostitute. She replied
"I can understand, my cooperation has
been based on nothing more than
refusal to do so would be grounds
for divorce." I quietly let her pro-
ceed on an uncontacted cross bill in
which she complained that I worked
to hard for the sake of my health.

So whatever justification in seek-
ing refuge in such security there
has been a vast amount of it. How-
ever, I know many of my mistakes
have been committed long after I should
have taken contrary action on my own.

But I have come out just all
in such a manner as to make me
sorrowful, at least temporarily

to someone in Mrs. Caswell's position,
that is, while she is getting ad-
justed to life here. I know if she wanted
a change, I would be glad to help,
even though it would be to see
those two little girls leave.

Now as far as finances are
concerned.

I would want to be responsible
for all food, the children's clothing,
their minor medical expenses, the
premium on two one thousand dollar
insurance policies for each of the
children and the cost of a Birthday
in England for Mrs. Caswell. In regard
to anything further, I cannot be as
liberal as I would like to at this
time. There is a surplus - when
all rentals are accounted - of about \$250
per month after mortgage payments
and budgeting for taxes. Two of those
mortgage payments will be "dead debts"
in a little more than two years.

Since writing to Mr. Johnson, I
have by means of a paragraph in my
will arranged for a bequest of \$500.00 for

for Mrs. Oswald. Her is to remain
even though she does not choose
to associate with me. It would be
increased by \$500 each year we need
together if she does come.

You may wonder why this
concern for her future finances
in view of what has already come
to her. I think that in my first
letter to your office I expressed my
hope that this at least the major
part of it would be put into a trust
fund for the girls.

Of course, Mrs. Oswald, who
as I understand is a pharmacist,
would undoubtedly get a job as soon
as she learned our language -
even from perhaps seeing that pre-
scriptions are written in Latin. Part of
even two little girls needed the
constant care of their mother, it
is then two.

Just last Fall before I came out
here I saw two who had been deprived
of it.

This couple had lived with me
over
