

She asked that I telephone a minister in Dallas and ask him to handle it, so that it would reach her. I don't happen to know anyone in Dallas, although my uncle, E. P. Smith, served in he National Missions in East Texas for many years.

I selected your name because from the name of the church I guessed that yours is a downown church, and you might be more likely to have contacts which would enable you to get in touch vith her. I realize that this is an unusual request, and may involve some difficulty, but I feel hat it is certainly in the spirit of the Master, and is a tiny gesture of the reconciliation which is so essential in the present stress. We will appreciate your help.

This morning in our memorial service I reminded our people of the guilt all of us must hare in creating a society which produces such hatred and violence, and challenged them to take p Christ's ministry of reconciliation, after being first reconciled to God through Christ.


