

PETER MC LAUGHLIN, 160 Magnolia Avenue, Jersey City, New Jersey, by letter dated December 27, 1963, to the Attorney General of the United States, Washington, D. C., asked if LEE OSWALD was a red-haired man. He indicated he was in Mexico from October 3, 1962, until November 3, 1962, at which time he met a young American who told him he had been in the United States Marines. He also noted this man had a barracks bag full of books.

Mr. MC LAUGHLIN was contacted on January 21, 1964, at the above address and he stated he sent the letter since he had never read in the newspaper regarding the color of OSWALD's hair but did read he had been in Mexico during the above period of time in 1962. When advised that OSWALD's hair was not red in color, he stated it was definitely not OSWALD whom he had met but recalled the name given by this individual as JOHN OTTO BRIDGE. He stated he had met BRIDGE in Mexico City in October, 1962, and had been told by him he had been in the United States Marines. He noted BRIDGE had a Boston accent and was very interested in reading.

MC LAUGHLIN volunteered he was fifty-nine years of age; was born in a small town twelve miles from Glasgow, Scotland; came to the United States in 1927 after attending school until fourteen years of age and working in a steel mill in Scotland; was in the U. S. Army Air Force from 1942 to 1945 as a radio operator; has had different jobs in various parts of the United States, in particular in the Transit Bureau of Philadelphia, the Scioco Golf Club, Columbus, Ohio; and at the present is employed as a kitchen helper at the Harvard Club, 27 West 44th Street, New York, New York.

SPAS THEODORE RAIKIN, 47 Irving Avenue, Englewood Cliffs, New Jersey, vacation address GV Hotel, Manasquan, New Jersey, advised he was employed as a Case Worker, Travelers Aid, New York City, in 1962, and recalled he was told to meet the "SS Maasdam" of the Holland American Line when it docked at Hoboken, New Jersey, on June 13, 1962, in order to assist LEE OSWALD and his family who were arriving from Russia.

Mr. RAIKIN stated he tried to contact OSWALD through the Immigration and Naturalization Service at the pier, but since OSWALD was a citizen of the United States, he was cleared before the ship docked. He had OSWALD paged but there was no response with the result he went to the Customs Inspection location where the luggage was assembled in alphabetical order and waited alongside OSWALD's luggage.

Mr. RAIKIN declared he met OSWALD, his wife and child when they came for the luggage and was with them for nearly one hour attempting to get bus transportation for them to the Port Authority Terminal, New York City.

He recalled OSWALD did not have enough money to get to Fort Worth, Texas, to contact his mother or brother. He also recalled OSWALD was met at the Port Authority Terminal by Case Worker Mr. F. PIERRE, who would have taken OSWALD to the New York City Welfare Department.

Mr. RAIKIN advised that while he was with OSWALD during the above period of time, OSWALD was very reticent to do any talking, but he did state he had been a guard at the American Embassy in Moscow, Russia, and had been kidnapped by communist agents. Mr. RAIKIN could not recall any further statements by OSWALD concerning this situation and he did not ask OSWALD any questions since he did not believe what OSWALD was telling him.

SPAS THEODORE RAIKIN advised OSWALD told him he was with the United States Marine Guard at the United States Embassy, Moscow, USSR, and on further recollection, Mr. RAIKIN recalls OSWALD may have said he deserted from the Marine ~~rather~~ rather than that he was kidnapped by communist agents. However, due to the lapse of time and the fact he handled so many other cases for Travelers Aid, he would not want to completely vouch for an accurate recollection of statements made by OSWALD. He stated the reason he did not go into detail with OSWALD regarding the statements he made was because he did not believe them to be true and felt that OSWALD made up the story to cover up the fact he had defected to the USSR which was known to Mr. RAIKIN.

Mr. RAIKIN noted OSWALD was very "close mouthed" and securing any information from him was very difficult.

Mr. RAIKIN stated he furnished this information in his report to Travelers Aid at the time and did not know if Mr. F. PIERRÉ added anything further to the report on OSWALD.

Mr. RAIKIN declared he had searched his memory regarding this situation and could not recall any further statements or incidents which could be added to what he has already furnished.

Further he believed statements made to cover fact OSWALD deserted to USSR. RAIKIN reported this matter to Travelers Aid at the time.

DETAILS:

SPAS THEODORE RAIKIN, 47 Irving Avenue, Englewood Cliffs, New Jersey, vacation address GV Hotel, Manasquan, New Jersey, advised he was employed as a Case Worker, Travelers Aid, New York City, in 1962, and recalled he was told to meet the "SS Maasdam" of the Holland American Line when it docked at Hoboken, New Jersey, on June 13, 1962, in order to assist LEE OSWALD and his family who were arriving from Russia.

Mr. RAIKIN stated he tried to contact OSWALD through the Immigration and Naturalization Service at the pier, but since OSWALD was a citizen of the United States, he was cleared before the ship docked. He had OSWALD paged but there was no response with the result he went to the Customs Inspection location where the luggage was assembled in alphabetical order and waited alongside OSWALD's luggage.

Mr. RAIKIN declared he met OSWALD, his wife and child when they came for the luggage and was with them for nearly one hour attempting to get bus transportation for them to the Port Authority Terminal, New York City.

He recalled OSWALD did not have enough money to get to Fort Worth, Texas, to contact his mother or brother. He also recalled OSWALD was met at the Port Authority Terminal by Case Worker Mr. F. PIERRE, who would have taken OSWALD to the New York City Welfare Department.

Mr. RAIKIN advised that while he was with OSWALD during the above period of time, OSWALD was very reticent to do any talking, but he did state he had been a guard at the American Embassy in Moscow, Russia, and had been kidnapped by communist agents. Mr. RAIKIN could not recall any further statements by OSWALD concerning this situation and he did not ask OSWALD any questions since he did not believe what OSWALD was telling him.

SPAS THEODORE RAIKIN advised OSWALD told him he was with the United States Marine Guard at the United States Embassy, Moscow, USSR, and on further recollection, Mr. RAIKIN recalls OSWALD may have said he deserted from the Marine rather than that he was kidnapped by communist agents. However, due to the lapse of time and the fact he handled so many other cases for Travelers Aid, he would not want to completely vouch for an accurate recollection of statements made by OSWALD. He stated the reason he did not go into detail with OSWALD regarding the statements he made was because he did not believe them to be true and felt that OSWALD made up the story to cover up the fact he had defected to the USSR which was known to Mr. RAIKIN.

Mr. RAIKIN noted OSWALD was very "close mouthed" and securing any information from him was very difficult.

Mr. RAIKIN stated he furnished this information in his report to Travelers Aid at the time and did not know if Mr. F. PIERRÉ added anything further to the report on OSWALD.

Mr. RAIKIN declared he had searched his memory regarding this situation and could not recall any further statements or incidents which could be added to what he has already furnished.

TRANSLATION FROM RUSSIAN

Item D-248

Dear Marina,

My mother has written me, that you may live in her house. This house is vacant now while she is in school. (Until February.

My brother called me on Tuesday to say, that you may live in Yellow Springs, Ohio, where he is. People are good there. He said that someone there speaks Russian. They teach Russian language in Antioch College. I was in school in Antioch (Antioch). I want to go to Philadelphia to see what kind of work and if an apartment is possible to find there. It is true, I am contemplating moving there in the summer, but not now, but it would be useful now to find a position as a teacher for the school-year of 1964-5.

If you want to fly East, I can go with you, in order to help you with the language. For example, if you want to live for the time being with Mr. Nunson in Camden, New Jersey.

This paper is an invitation for you from "Stern" magazine in Germany (not standard as I thought at first) to speak with him about your life and memoirs of Lee. It would be difficult for you to talk about it. But \$10,000 would help. This is completely your business. If you want to sign this paper, I advise you to have an attorney who would watch over it. If you want to sign it, Stern magazine will send two men from Germany. It is necessary to sign two copies of the paper, and have another signature by an officer of the Irving Police, your attorney, or somebody else.

Another matter:

"Standard" from Germany wants (Skala?) to pay you \$10,000 for the history of you and Lee. "Life," too, wishes to buy something and also the "Daily Express," London. I do not even want to write you about this but ... I do not know. Mr. Neunson said, that he would pay bus fare for you and the children. I will tell you that flying is better. It is not convenient to travel by bus with children. I can buy you a plane ticket. I am afraid that you never want to see me again. It is true, we have horrible memories. It is probably better that we do not live together again.

Oswald Recalled

Jersey GI Tells of Interest in-Castro

Washington Bureau.

WASHINGTON—An Army non-commissioned officer, stationed at a New Jersey missile base, was one of the witnesses who told the Warren Commission about Lee Harvey Oswald's life in the Marine Corps.

The testimony of SP/4 Nelson Delgado was taken April 4, 1964, while he was with D Battery, 4th Missile Battalion, 71st Artillery at Hazlet, N.J., according to Volume 8 of the commission's hearings released yesterday.

Delgado, of Oakwood Road, Leonardo, N.J., served in the U.S. Marines before his Army service. He was stationed at the Marine Air Control Center in Santa Ana, Calif. with Oswald, accused assassin of President John F. Kennedy, in the late 1950's.

Tells of Meeting

Delgado, a cook at the New Jersey Army installation, told the commission he speaks and writes Spanish fluently. Of his meeting with Oswald in California at the Marine post he said:

"We had basic interests. He liked Spanish and he talked to me for a while in Spanish or tried to, and since nobody bothered, you know—I was a kind of a loner myself, you know. I didn't associate with too many people."

Much of Delgado's testimony was about his efforts to teach Oswald to speak Spanish and of their discussions about Fidel Castro and his conquest of Cuba.

"He was a complete believer that our way of government was not quite right—I don't know how to say it, it's been so long," Delgado testified. "He didn't think our government had too much to offer."

Delgado said he was an early sympathizer for Castro and that he and Oswald had "barracks dreams" of going to Cuba after they got honorable discharges and becoming officers in the Cuban forces.

Became 'Scared'

The army non-com said he started "getting scared" when Oswald began "actually making plans and how we would go about going to Cuba and where we would apply."

Delgado said he felt that Castro was "starting to change opinions" so he was no longer sympathetic to the Cuban

leader, but Oswald insisted that newspapers were distorting the facts about the Cuban situation.

Delgado was questioned in detail about Oswald's marksmanship and said that he did not think Oswald had ever shown much proficiency with the rifle.

When he was asked if he thought Oswald was an intelligent person, Delgado answered:

"Yes, I did. More intelligent than I am, and I have 117, supposedly IQ and he could comprehend things faster and was interested in things I wasn't interested in; politics, music, things like that, so much so like an intellectual. He didn't read poetry or anything like that, but as far as books and concert music and things like that he was a great fan."

THE STRANGE DEATH OF JOHN F. KENNEDY

For many years there has been an awareness of the need for a thorough investigation and housecleaning regarding security risks in the Department of State. One of the key individuals responsible for permitting Lee Harvey Oswald to return to the United States from the U. S. S. R. was known to be a security risk and had been reported as such by the late Scott McLeod five years earlier, although the fact that he was a security risk had been known for sixteen years.

On October 31, 1959, Lee Harvey Oswald appeared at the U. S. Embassy in Moscow, at which time he turned over his U. S. passport, and submitted the following statement:

"I Lee Harvey Oswald do hereby request that my present citizenship in the United States of America, be revoked.

"I have entered the Soviet Union for the express purpose of applying for citizenship in the Soviet Union, through the means of naturalization.

"My request for citizenship is now pending before the Supreme Soviet of the U. S. S. R.

"I take these steps for political reasons. My request for the revoking of my American citizenship is made only after the longest and most serious considerations.

"I affirm that my allegiance is to the Union of Soviet Socialist Republics.

(signed) Lee H. Oswald"

In a report to the Department of State made on November 2, 1959 from the U. S. Embassy in Moscow by Richard Snyder and approved by Edward L. Freers, Charge d'Affairs, these facts were made known. The report and copies were sent to the Bureau of Security and Consular Affairs, Office of State Department Security, Central Intelligence Agency and other interested government departments. It showed that Oswald's manner was "aggressive, arrogant and uncooperative," and that he stated he had been a radar operator in the U. S. Marines and had already told Soviet officials that he intended to give them all the information he possessed. This would have included some very confiden-

tial data learned in the service. The report stated Oswald is "presently residing in non-tourist status at the Metropole Hotel in Moscow."

In a report written on April 7, 1964 for the Warren Commission, John A. McVicar, now Principal Officer in the U. S. Consulate in Bolivia, and formerly assigned as Secretary-Counselor at the U. S. Embassy in Moscow, pointed out: "Russian visas are given to tourists at \$30.00 per day for individual tours or the applicant must join a group. A regular visa is issued only after checking with Moscow and usually takes several months." (Oswald had obtained a visa at Helsinki immediately.) Mr. McVicar also stated that Helsinki was a port of entry of the type the Russians themselves would have chosen for Oswald. Oswald entered the Soviet Union at Vyborg on October 16, 1959, using U. S. passport #1733242 and had obtained a Soviet Visa #4173339 within less than forty-eight hours. In Moscow Oswald lived in the Hotel Berlin and the Hotel Metropole.

On October 21, 1959, Oswald was admitted to the Botkin Hospital in Moscow for an alleged attempted suicide. He had a small superficial type cut on his left forearm which required four stitches. He, nevertheless, remained in the hospital until October 28, 1959, and during a portion of this time was in the psychiatric division of the hospital.

It is a well established intelligence circles that the Soviets make a practice of having a psychiatric study and interrogation made of defectors and candidates for intelligence training to help eliminate the possibility of their being double agents. Oswald's whereabouts became a mystery shortly after his hospital sojourn as shown in a dispatch from R. E. Snyder, U. S. Embassy, Moscow, to the State Department, Washington, D. C., dated March 28, 1960, which reads: "The Embassy has had no contact with Oswald since his departure from the Metropole Hotel in Moscow in November 1959 and has no clue as to his present whereabouts."

If the U. S. Embassy in Moscow considered Oswald as a U. S. citizen rather than a definite defector, they could easily have asked the Soviet Foreign Office as to his whereabouts, since the Embassy does keep track of U. S. citizens while they are in the Soviet Union.

Under date of March 28, 1960 the Department of State in Washington, D. C. sent a dispatch to the U. S. Embassy in Moscow as follows:

"An appropriate notice has been placed in the look-out card section of the Passport Office in the event that Mr. Oswald should apply for documentation at a post outside the Soviet Union."

After the assassination of President Kennedy, an investigation of the "look-out card" and what happened to it brought this reply from the State Dept. to the Warren Commission; "Miss Bernice Waterman prepared a 'refusal' sheet and an Operations Memorandum which show that she authorized the preparation of a lookout card; however, investigations, to date, fail to reveal any other indication or evidence that a lookout card was ever prepared, modified, or removed. -- it appears that someone in the Files or Clearance Section missed the 'Refusal' prepared on March 25, 1960, and failed to follow standard operating procedures to prepare a lookout card or that the 'Refusal,' after it left the Foreign Operations Division, was misplaced or misguided in transit--"

Another explanation made by the State Department through Abraham Chayes, Legal Adviser, stated: "A 'lookout card' was probably prepared on Oswald on the ground that he might have expatriated himself, but this cannot be determined with certainty and no such card is now in the 'lookout file'. A memorandum dated Mar. 28, 1960 from the Department to the Embassy in Moscow states that a card was prepared, and the customary forms dated Mar. 25, 1960 were completed directing the preparation of a card. The usual notation on such forms indicating filing of a 'lookout card' was not made, however, nor was a notation placed on the slip that the card was withdrawn, also a usual practice."

Immediately after Oswald's arrest for the Kennedy assassination, Abba Schwartz, head of the Bureau of Security and Consular Affairs, reportedly removed Oswald's file, and it has never been returned, a reliable source states.

Oswald eventually turned up in Minsk, Russia, where he allegedly worked in the experimental section of a radio factory, doing assembly work.

During the month of March 1961 Oswald met a Russian girl named Marina Nikolaevna Prusakova. By April 20, 1961 they had applied for permission to marry. According to statements given the Warren Commission by Marina, she was dating other men during the month of March 1961; and Oswald was a patient in Clinical Hospital #4 at Minsk. He was admitted at 10 A. M. on March 30, 1961, had a nasal operation and an ear infection taken care of, and was discharged from the hospital April 11, 1961. This would have allowed but a very short time for a courtship between the niece of an important Soviet official and a non-Soviet citizen.

They were married on April 30, 1961. Marina, whose parents were deceased, had been living for the previous four years with her mother's brother, Lt. Col. Ilya Vasilevich Prusakov of the K. G. B. (Soviet Intelligence) who reportedly was in charge of security for the Soviet lumber industries in the area. She lived with her aunt and uncle, who were childless, in Apartment 20 at 39 Kalinin St., Minsk. After her marriage, she and Oswald lived at Apartment 4 at 20 Kalinin St., Minsk. (In some documents their address is listed as House 4, Apt. 24, Kalinin St., Minsk.)

By some coincidence Oswald had already been a neighbor of Col. Prusakov before he met Marina. On Page 605 of Vol. XVIII of the Warren Commission Reports, Marina describes his apartment (in which they lived after their marriage) as follows: "He had a small darling one room apartment with a balcony, a bathroom, gas, kitchen, and a separate entrance, quite enough for two, especially if they were young."

Marina continued to work as an assistant in the pharmacy of the Clinical Hospital at Minsk, according to Soviet records supplied to the Warren Commission. According to Oswald's diary, he was very popular with Marina's uncle, Col. Prusakov, who used to give him vodka to drink free. Oswald referred to Col. Prusakov as "my father-in-law."

According to the State Department report to the Warren Commission, Exhibit #950, the Moscow Embassy had no knowledge of the address, activities or any other information about Oswald in the U. S. S. R. from the time he left the Hotel Metropole in Moscow in November, 1959, until they received a letter from him postmarked Minsk, U. S. S. R., dated February 1961. In this letter Oswald stated:

he desired to return to the United States. He closed the letter with the following paragraph, "I hope that in recalling the responsibility I have to America that you remember yours, in doing everything you can to help me since I am an American citizen."

On May 25, 1961 the U. S. Embassy in Moscow received another letter from Oswald which stated: "I am asking not only for the right to return to the United States but for full guarantees that I shall not, under any circumstances, be persecuted for any act pertaining to this case."---"I would not leave here without my wife so arrangements would have to be made for her to leave at the same time I do."---"So with this extra complication I suggest you do some checking up before advising me further."

On July 8, 1961 Oswald appeared at the U. S. Embassy in Moscow where he was interviewed and filled out a questionnaire form. He applied for a visa for his wife, Marina, a few days later.

On July 11, 1961 a three-page Foreign Service Dispatch, #29, was sent by diplomatic air pouch from the U. S. Embassy in Moscow to the Department of State in Washington, D. C. regarding the Oswald case. It was signed by Boris H. Klosson, Counsellor for Political Affairs. The subject of the dispatch was "Citizenship and Passports - Lee Harvey Oswald." It contained statements and comments by Mr. Klosson. This three-page dispatch paved the way for Oswald to return to the United States where he attempted to take the life of Maj. Gen. Edwin A. Walker, and succeeded in taking the life of President John F. Kennedy.

On Page 2, Paragraph 3 of Dispatch #29 is stated: "Oswald was married on April 30, 1961, to Marina Nikolaevna Pusakova, a dental technician." It is important to note that in this vital communication the name of Oswald's wife is not spelled correctly, nor is her occupation listed correctly. Klosson, who signed the dispatch on behalf of the Ambassador, allowed her name to be spelled "Pusakova" instead of "Prusakova" and her occupation to be listed as "dental technician" instead of "assistant pharmacist."

Klosson closed the long dispatch with the following: "Twenty months of the realities of life in the Soviet Union have clearly had a maturing effect on Oswald. He stated frankly that he had learned a hard lesson the hard way and that he had been completely relieved of his illusions

acquired a new understanding and appreciation of the United States and the meaning of freedom---" The report showed Oswald as having earned only ninety rubles per month and having saved two hundred rubles for part of his return fare. This was also incorrect, as Oswald made much more than this and Oswald had lost none of his arrogance.

Since officials in the U. S. Embassy in Moscow were aware that the Soviets conduct training schools for agents and assassins to murder statesmen in the Free World, Klosson's utter disregard for the truth and failure to verify facts concerning Oswald is especially sinister. Who is Boris Klosson?

Boris Hanson Klosson was born in Buffalo, N. Y. on January 21, 1919, the son of Michael M. Klosson and the former Miss Kenena Hanson. He received a BS Degree from Hamilton College in 1940 and a MA Degree from Fletcher School of Law and Diplomacy in 1941. He had studied for one year (1938-9) at the Institut Universitaire de Hautes Internationales, Geneva, Switzerland. On May 3, 1947 he married Miss Harriet F. Cheston. From 1942-3 he was an analyst for a U. S. Aircraft Company and then went into the U. S. Army, became a lieutenant and was assigned to the O. S. S.

In the O. S. S. he worked for and came under the influence of Gerold T. Robinson who was O. S. S. Chief of the U. S. S. R. Division of Research and Analysis. Robinson was under investigation by U. S. intelligence agencies because of his pro-Soviet activities. He was a Director of the American-Russian Institute, 56 West 45 Street, New York, N. Y. (along with Avraham Yarmolinsky, father of Adam). This organization was cited as communist by the Attorney General of the United States. The Senate Internal Security Sub-committee stated it was closely linked with the Institute of Pacific Relations. In 1946, in filling out a federal employment application, Klosson gave as a personal reference his friend, tutor and associate, Prof. Gerold T. Robinson.

Louise Morley, identified communist, who has taken the Fifth Amendment over forty times, is also known as Mildred Vidor and Mildred Linton. She was long suspected of being engaged in espionage activities on behalf of the Soviet Union. In 1943 she had made a trip out of the country under suspicious circumstances. Upon her return it was learned she had on her person a very confidential address book of contacts, among whom Boris Klosson was listed. Durin

O. S. S., he was reported as being responsible for the leaking out to unauthorized persons of secret and confidential information to the detriment of the United States.

Klosson came into the State Department in 1945 and immediately was assigned with the Division of Research on U. S. S. R. and Eastern Europe, doing highly confidential work. He was promoted many times and worked his way up to become Chief of the Research (Intelligence) Division for U. S. S. R. On July 26, 1959 he became First Secretary of the U. S. Embassy in Moscow and at the time of the report referred to was Counsellor for Political Affairs.

Klosson is now Counsellor and Consul at the U. S. Embassy in Kingston, Jamaica, having been assigned to this post October 14, 1962. Klosson, who speaks fluent Russian, had been reported by the F. B. I. in an investigation which showed derogatory information concerning his background. In 1956 the late Scott McLeod had reviewed his file and "Klosson" is one of the names on his list of 847 security risks in the State Department.

For conclusive evidence that Oswald was not rehabilitated or "relieved of his illusions about the Soviet Union" as security risk Klosson would have us believe, we submit the following letter, written by Oswald to the Soviet Embassy in Washington, D. C. less than two weeks before he murdered President Kennedy. It is dated November 9, 1963, and states:

"This is to inform you of recent events since my meetings with comrade Kostin in the Embassy of the Soviet Union, Mexico City, Mexico. (Kostin is a high official in the K. G. B.)

"I was unable to remain in Mexico indefinitely because of my Mexican visa restrictions which was for 15 days only. I could not take a chance on requesting a new visa unless I used my real name, so I returned to the United States.

"I had not planned to contact the Soviet embassy in Mexico so they were unprepared, had I been able to reach the Soviet Embassy in Havana as planned, the embassy there would have had time to complete our business.

"Of course the Soviet embassy was not at fault, they were, as I say unprepared, the Cuban consulate was guilty of a gross breach of regulations, I am glad he has since been replaced.

"The Federal Bureau of Investigation is not now interested in my activities in the progressive organization 'Fair Play For Cuba Committee', of which I was secretary in New Orleans (state Louisiana) since I no longer reside in that state. However, the F. B. I. has visited

Agent James P. Hasty warned me that if I engaged in F. P. C. C. activities in Texas the F. B. I. will again take an 'interest' in me.

"This agent also 'suggested' to Marina Nichilayeva that she could remain in the United States under F. B. I. 'protection', that is, she could defect from the Soviet Union, of course, I and my wife strongly protested these tactics by the notorious F. B. I.

"Please inform us of the arrival of our Soviet entrance visa's as soon as they come.

"Also, this is to inform you of the birth, on October 20, 1963 of a DAUGHTER, AUDREY MARINA OSWALD in DALLAS, TEXAS, to my wife.

[redacted], telephone number [redacted] ^{b7D} appeared
at the Camden Resident Agency and was interviewed by the
writer. He advised that he is employed [redacted]
[redacted] Camden, N.J. ^{b7c} ^{b7D}

[redacted] stated that on Thursday, 9/9/65, he was ^{b7c}
in Atlantic City, N.J., during the week of the Miss America ^{b7D}
Pageant. He entered the [redacted] located at [redacted] ^{b7c}
[redacted] approximately 10:00 p.m., at which
time he observed a woman customer in the bar. It was his
belief at that time, which he later determined through her
conversation to be true, that she was a prostitute, and that
this was the location where she met her customers. He advised
that he did not know the correct name of this person, but that
she was well known to everybody in the bar, and that they called

[redacted] stated he became acquainted with [redacted] at the bar and talked with her for a short time that evening, during which time he bought her approximately three or four drinks. During this time she talked about her general background and spent about two hours with [redacted] discussing her background and activities. b7c

b7c(D)
[redacted] stated that he returned to the [redacted] on Friday night, September 10, and again met [redacted] and was with her in the bar from approximately 11:30 p.m. to 5:00 a.m. He stated they went from the [redacted] to Rockie Castellani's in Atlantic City, and that he left her at 6:00 a.m., at which time she was in the company of two wrestlers. During their conversation at the [redacted] on Friday evening, [redacted] stated that she had worked as a striptease dancer in various locations around the country. During the conversation she mentioned that she had been employed as a stripper in JACK RUBY's Bar, The Carousel in Texas shortly before the assassination of President JOHN F. KENNEDY. She stated at this time that, "JACK RUBY was a communist and I hope they hang the (obscene)." She continued at this time and stated that OSWALD and JACK RUBY were acquainted with each other and that the assassination of President KENNEDY was planned by them; that RUBY shot OSWALD to shut him up and that there are "big people" behind RUBY and they are going to get RUBY released from prison. b7c

b7c(D)
[redacted] advised that during this conversation [redacted] was drinking heavily, but did not appear to be intoxicated at any time.

b7c(D)
[redacted] stated that on Sunday, September 12, he telephoned [redacted] at the [redacted] Atlantic City, N.J., and invited her to a party at his apartment in the [redacted] on Sunday afternoon, and that also present in the apartment were two friends of his, [redacted] and [redacted] whom he became acquainted through [redacted] and who is from [redacted]. He stated that at the party they had a tape recorder, and for purposes of amusement interviewed [redacted] on the pretext of being a radio interview and that from this interview and during this period additional conversation developed concerning her allegations concerning RUBY and OSWALD. b7c b7D

^{b7c} [redacted] stated that during this so called "interview" he asked her to repeat to his friends what she had told him about the assassination of President KENNEDY. She stated that although they had a tape recorder present he did not record her conversation originally at which time she stated that LEE HARVEY OSWALD had worked for RUBY in The Carousel Bar, and was a "manager of sorts of this bar." She did not further discuss this alleged knowledge of OSWALD's activities, but did state that OSWALD was "on pills" at that time, but did not further describe these pills. During this conversation she again repeated that RUBY was a communist, and further stated that OSWALD had fired her and four other strippers from The Carousel Bar a few days before KENNEDY's assassination. She stated that one of the girls that was fired with her was BLAZE STARR. She told ^{b7c} [redacted] and his friends that she then went to Miami, and a few days later learned of the assassination of President KENNEDY.

^{b7c} [redacted] stated that [redacted] did not state if she had ever discussed this with anyone else, or had ever reported it to officials. [redacted] stated that during this period ^{b7c} [redacted] was drinking constantly and consumed approximately four or five scotch drinks. He stated however, that she was not intoxicated.

^{b7c} [redacted] stated that during this period she had removed her outer garments and was very gay, but denied that there was any sexual activity with her during this period. He described her as a very hyper-active personality and a manic type. He described her activity as "always speedy." He stated however that he considered her to be an intelligent person, who was familiar with a number of current topics.

^{b7c} [redacted] stated that Sunday evening his two friends drove [redacted] back to Atlantic City, and dropped her at the [redacted] and he has not seen nor heard from her since. He advised that she lives in a hotel approximately one block from the [redacted] although he does not know the name of this hotel. He stated that it is his recollection that the name of the hotel begins with a "T". He stated that she could be easily contacted at the [redacted] since she is well ^{b7c} known to the management and the great majority of customers at the bar.

[REDACTED] advised that he was unable to offer any opinion of the mental status of [REDACTED] stating only that he considered her to be an intelligent person, but did not know if she was suffering from any mental disturbance of any kind. He was unable to account for her failure to apparently report her information to authorities previous to this time.

[REDACTED] stated that he had advised his lawyer [REDACTED] of this b7D information, who advised him that he intended to call ARLEN SPECTOR who served on the Warren Commission as a general counsel and who is the current Republican candidate for District Attorney in Philadelphia, Pa. He stated that he has heard nothing further from his attorney, and that he had personally called a friend in Los Angeles, [REDACTED] a radio personality in the Los Angeles area who is well known for engaging in controversial topics. He stated he called [REDACTED] on this Sunday evening after being with [REDACTED] all day, and that [REDACTED] indicated that he would bring this matter to the attention of MELVIN BELLI the attorney for JACK RUBY in his murder trial in Dallas, Texas. He stated he has heard nothing further from [REDACTED] regarding this alleged contact with BELLI. b7C

b7C
[REDACTED] advised that he was unable to furnish any additional information concerning the information furnished by [REDACTED] and stated that the only information he could give concerning the manner in which she could be contacted would be an attempt to contact her through the [REDACTED] in Atlantic City, N.J. b7C

Observation of this individual and the description of work which she claimed she has performed indicated strongly that she was primarily a prostitute who has utilized these other descriptions of jobs as a cover up for her activity as a prostitute.

She advised she was born [REDACTED] She stated she had left home at the age of 16 and gone to Atlanta, Ga. and subsequently traveled around the country doing various jobs as previously described. b7C b7D

[REDACTED] refused to identify any member of her family, her current residence, or her personal history other than the nature of her previous employments. When questioned as to if she had ever worked in Dallas, Tex., or the vicinity of the Carousel Night Club in that city, she immediately became very petulant and refused to furnish any information concerning possible activity on her part in that city. She became very upset at [REDACTED] at this time and immediately accused him of having furnished confidential information to the FBI. b7C b7D

During interview [REDACTED] appeared to be very emotionally unstable and extremely difficult to interview. She became extremely petulant, as previously noted, when questioned concerning any knowledge she might have of activity in Dallas, Tex., and refused to state if she had ever been in that city. She denied knowledge in any manner of any of the circumstances surrounding the death of President KENNEDY and denied that she had ever stated that she knew JACK RUBY or LEE HARVEY OSWALD. b7C b7D

Observation of [REDACTED] during interview indicated that although she did not appear to be mentally incompetent in any fashion, she did appear to be a very unstable individual. It does not appear that she has any information concerning the assassination of President KENNEDY and that any information she had allegedly furnished to [REDACTED] prior to this time, was public-source information and that she was merely utilizing this as a come on for any individual who had expressed an interest in her alleged knowledge of this assassination. b7C b7D

In view of the results of this interview, it is not felt this information should be disseminated since it is obvious, based on interview of this individual, that she does not have any knowledge concerning the assassination of President KENNEDY and refuses to discuss any allegations she had previously made concerning this incident.

It is recommended that no additional investigation be conducted in this matter in view of the obvious unstable nature of the individual involved.
