In addition, he was advised that Mr. FORD had advised our Agents that if all of her furniture were moved in tonight, she would move to that address on the 28th or 29th. Mr. FORD also advised that the phone company had informed him they would not install a telephone at that address until MARINA went to the phone co. and signed for the phone. He stated they intend to do this on the 28th.

The misur number will be different, and we are to send to Bureau by letter, the time and date of installation on that, and the symbol number for same. The Bureau needs written communications on both of them to complete their file.

I inquired as to how information obtained should be reported, and Mr. BRANNIGAN stated it should be reported in report form, using a T symbol and then identifying same on the administrative page. He instructed that the information be paraphrased so it doesn't appear she is talking on the telephone. He stated he realized this is difficult, but to make an effort. The same would be true of the misur.

I asked if when Dallas sends in anything on this by teletype, should it be encoded? Mr. BRANNIGAN stated, "No. This is an installation made with the OK of the Attorney General."

I called Assistant Director W. C. SULLIVAN this morning and pointed out to him that a minimum of 75% of the coverage we were receiving from the tech and mike was in Russian, and it was necessary for us to have this translated here in order to promptly notify the Bureau. I advised him that we were at the present time utilizing Agent BOGASLAV in this capacity; that BOGASLAV's services are supposedly needed back in New York, and that we could use a translator to handle this phase in place of BOGASLAV.

Mr. SULLIVAN stated that he would make a recommendation that a Russian translator be sent to Dallas so that SA BOGASLAV could be released to return to his office in New York.

During the same conversation, I pointed out to Assistant Director SULLIVAN that of course MARINA, now having a home [redacted]

however, I pointed out that at the present time of course the trial of RUBY is going on and that everything here in Dallas is very charged up, and I did not believe it would be worth the risk [redacted]. He stated he agreed, but if they decided otherwise, he will let me know.

At 12:20 PM, 3/8/64, Attorney WILLIAM MC KENZIE telephonically contacted me and stated that he was having some difficulty with MARINA because of the fact that she would apparently let anyone who knocks on the door in, and he had become somewhat apprehensive as of course, if some nut wanted to harm her, he could probably do so without any trouble as it is apparently now generally known where she is living in Richardson. He stated that he had told her not to let anyone in the house without contacting him. He was actually wondering if we could give her some protection. I pointed out to him that that was not within our jurisdiction.

He then wanted to know if the FBI might know of some Russian speaking woman who was alright that he might contact to hire as a housekeeper. I told him again that we could not make any recommendation.

He then pointed out that he was leaving at approximately 2:30 PM for Washington, D.C. on another matter and that while there he was going to contact LEE RANKIN, pointing out to him the problem of protecting MARINA. I told him again that of course we can make no recommendation.

I called Assistant Director WILLIAM C. SULLIVAN and pointed out to him the above conversation. I also suggested that in view of MC KENZIE's attitude, I felt that it would be possible to tell him that we might make a security check of the house if he would make it available to us and get everybody out, and in that manner, we could remove the installation. He said that he would let me know in this regard later.

Assistant Director W. C. SULLIVAN called at 1:40 PM today and stated that the physical surveillance should be discontinued and that the tech should be discontinued when we can.

Mr. SULLIVAN instructed that we maintain a spot check on MARINA's activities, and suggested that MC KENZIE, for instance, could furnish considerable assistance in this regard.

Regarding my suggestion that we make a security check of the house (since MC KENZIE seems apprehensive for MARINA's safety), Mr. SULLIVAN stated that the Bureau wouldn't go along with this idea as we would be held responsible.

Mr. SULLIVAN agreed that we are going to have to keep the tech on as long as the mike is on to protect ourselves, and he said there is no indication now that MARINA is going to called back to Washington.

Mr. SULLIVAN asked if MC KENZIE raised the question about checking MARINA's house. I told him that MC KENZIE had said he would like for us to check the place as he is worried about the thing; that we could tell him to get MARINA out of there and I would send a couple of men out there, and no one is to know it but you (McKENZIE). There is all this talk about whether THORNE and MARTIN might be trying to find out what is going on. I could suggest that if McKENZIE would get her down to his office where my men can interview her, we could make the check of the house. Mr. SULLIVAN said he did not like the fact that MC KENZIE would have knowledge that we went into MARINA's house on illegal entry.

Mr. SULLIVAN said to hold up on the thing and we will see if the trip to Washington doesn't materialize.
