On June 6, 1972, at 6:30 PM, [redacted] telephonically advised that on June 5, 1972 he had received a telephone call from Clay Shaw in New Orleans, Louisiana, and Shaw asked him to assist him in killing the President of the United States. [redacted] stated he advised Shaw that he did not want any part of this conspiracy to kill the President. He stated that Shaw wanted him because he is a sharpshooter.

[redacted] further stated that the Russian Embassy and the Communist Party have contacted him and offered him \$100,000.00 to assist in the assassination of the President.

[redacted] stated he did not want any part in this conspiracy and wanted to advise the Federal Bureau of Investigation.
