Dear Gary:

We are moving toward suit. I have one case in court with a researcher, and you must take very seriously this warning: You are in danger of being sued for criminal conspiracy and criminal liable and slander.

You need to know my history of past federal law suits until I broke their back.

We can and must work together. As far as you had to recognize the effects on my mind of the enormous slander campaign perpetrated against me by several leading researchers for many years, up to and including false statements that I had 1) done time in prison, 2) done time for molesting children, 3) molested Groden's children. (Better talk to Larry Howard about this, as he got the real story out of Groden.)

I just returned from Dallas with three police officers from here. We will be back there soon, as we have been going every month with various under cover individuals. If any of those accusations were true, they would not be working with me. They got the Dealey Plaza news boys and got the real story from them with regard to the slander against me, which was also perpetrated inside the ASK conference.

The sort of thing that Davis and Roland Swenson perpetrated is criminal assault. He does not have to hit me in order to assault me. You caused all of this, and your attempt to load it on me is a crime.

Let's face just where you are coming from. My police officers obtained from high level sources in Dallas that the murder of JFK came from prominent Texans. They obtained direct testimony of large pay-offs being offered to researchers in Dallas. Your book directs attention away from these people, and what you wrote at the end of it is damning evidence against you and your motives. You erect at these ASK conferences various fakers and hoaxers.

They have a right to be heard, but so do I. You do not have a legal right to close me out of all of these conferences. I am telling you the following, but I may very well prosecute Mary Ferrell for the stories she is repeating. This old gossip is saying things about me

planted there by Lifton and Groden that are completely untrue. Under certain circumstances, people can be arrested for certain forms of slander and liable. You are **ENGAGING IN A CRIMINAL CONSPIRACY** with Doug Carlson to close me out of that conference.


The experience of having my reputation and my very soul nearly destroyed just before the Dallas doctors forum last June 4 means nothing to you.

You lied about the circumstances of my being involved with the last ASK conference. You are simply afraid of what I have to say. You do not have the right to close me out and to do all that you are doing. My new book will be a powerful counterattack on all aspects of this case and is slated to be the biggest book of the year this fall. I will spend every cent I have to right the wrong all of you have perpetrated on me, and for the way this is happening.

I expect you to work this out. I want to address the assembled gatherings at these conferences, and you do not have the right to participate in a criminal conspiracy to prevent that.

You do not have the right to set me up in a trap as you did at ASK or in any other way to hurt me.

God damn you, Shaw. Who the hell do you think you are?
