Dear Mr. Weisberg:

This is in further response to your request, pursuant to the Freedom of Information Act for records concerning the assassination of President John F. Kennedy.

We have completed the review of the additional records from file 129-11 (Sections 38 and 39) not previously scheduled, as well as records contained in Department of Justice Files numbered 186-19-0 and 186-54-0. Our search also located three transcripts of testimony before a Congressional Committee (items 2602-2604). The attached documents are being made available to you in full or in part. A copy of a schedule of documents is also enclosed which supplements the schedule previously furnished to you. The documents which are being released to you in part (as indicated on the schedule) are subject to deletion, pursuant to 5 U.S.C. 552(b)(7)(C), of material the release of which would constitute an unwarranted invasion of the privacy of a third party.

Access to items 2583 and 2584 is denied to you pursuant to 5 U.S.C. 552(b)(5) (Intra-agency correspondence which reflects the deliberative processes of the Department) and 5 U.S.C. 552(b)(7)(C).

Items 2602, 2603 and 2604 (located in Enclosures File 51-16-1113) are unrevised and unedited records of the Civil Rights and Constitutional Rights Subcommittee of the Committee on the Judiciary, United States House of Representatives, and were loaned to the Criminal Division for use in a pending investigation. They are stamped "Not for Quotation or Duplication". They are records of the Congress, rather than of the Department of Justice, and are not available under the Freedom of Information Act. In the event you want copies, we suggest you make request for them to the House Committee on the Judiciary.

This is also in reference to your letter dated July 8, 1981.

In our letter to you dated July 2, 1981, we misstated that there were seven enclosures to file 129-012-3. There are only six enclosures to this file. Enclosure six is complete as it was received by you.

In regard to item 2517, we have no dated copy of this item in our files.

Pursuant to Department regulations, you have a right to appeal this partial denial of your request. This appeal must be made within thirty days in writing and addressed to the Assistant Attorney General, Office of Legal Policy (Attention: Office of Privacy and Information Appeals) United States Department of Justice, Washington, D.C. 20530. The envelope and letter should be clearly marked, "FOIPA Appeal". If on appeal your request is denied, judicial review will thereafter be available to you in the district in which you reside or have your principal place of business or the district in which the records denied to you are situated or the District of Columbia.
