One copy of this report is being furnished the New Orleans Division in accordance with their request in view of considerable investigation being conducted that division.

ADMINISTRATIVE

THIS REPORT WILL SUPPLEMENT THE PREVIOUS REPORT OF SA ROBERT P. GEMBERLING, DATED NOVEMBER 30, 1963, AT DALLAS, WITH RESPECT TO INVESTIGATION IN CONNECTION WITH THE ASSASSINATION OF PRESIDENT KENNEDY.

All Agents of the Dallas Office participated in this investigation, as well as numerous Agents from other surrounding offices, and their identities are reflected in this report.

The security aspects concerning LEE HARVEY OSWALD have previously been reported in separate reports of SA WARREN C. DE BRUEYS, dated December 2 and 8, 1963.

All subsequent reports pertaining to the investigation in connection with the assassination of President KENNEDY and the security aspects with respect to OSWALD will be included in the same reports under instant caption.

It is recognized that only seven copies of this report are designated for the Bureau, although it carries an IS - R - CUBA caption, but this is due to the fact that at

the time of the preparation of the various pages of this report, it was anticipated that the report would be submitted under the AFO caption. This also accounts for the fact that the majority of FD-302's bear the file number 89-43 instead of 100-10461.

In connection with this report, it should be borne in mind that the Dallas Office has a separate case in connection with the shooting of LEE HARVEY OSWALD, captioned "JACK L. RUBY, aka.; LEE HARVEY OSWALD, aka. (DECEASED) - VICTIM, CR", Dallas file 44-1639.

The overlap of the period of this report with that of referenced report of SA ROBERT P. GEMBERLING was occasioned by the fact that material from other offices was not included in the initial report.

In certain instances this report may contain information from sources, the identity of whom would ordinarily be concealed and identified in the administrative section of the report. However, due to the gravity of this matter and the fact that President LYNDON B. JOHNSON requested the FBI conduct investigation and the Governor of the State of Texas was also wounded at the time the President was assassinated, it is felt that the sources can be revealed without embarrassment in anticipation of possible dissemination of this report.

The possibility of any employee at the Texas School Book Depository (TSBD) Building seeing LEE HARVEY OSWALD with wrapping paper in the shape of a large bag on November 22, 1963, as he came to work or thereafter was fully explored

during the course of the interviews with employees at the TSBD Building.

No local dissemination of this report is being made to the United States Attorney or to the local United States Secret Service in Dallas. Extra copies of this report have been made by the Dallas Office in the event the Bureau directs that a copy of this report should be disseminated to both the local Secret Service and the United States Attorney's Office at Dallas. It is suggested that in view of the fact that considerable information is set forth in this report with respect to allegations regarding other persons (Section VIII), that the Bureau may desire to disseminate a copy of this report on a national level to the United States Secret Service Headquarters, Washington, D. C.

On page 172, certain data obtained from records of the Selective Service is set forth, and the identity of the source of such information is identified. However, in view of the fact that OSWALD had in his possession altered or fictitious Selective Service cards, it is felt that the source of such information can be revealed without embarrassment.

The source abroad referred to as having requested an examination by the FBI Laboratory, under date of December 3, 1963, is the Legat at Mexico City.

The information concerning the account of JACK and GERTRUDE ARNOLD, Hillcrest State Bank, Dallas, Texas, was furnished by Mr. DON R. PORTER, Executive Vice President; on November 29, 1963.
