

ABSTRACTS - received 3/29/80

2754. With regard to an abstract entirely withheld as a referral to the CIA, on which it never acted, I note elsewhere that the information there withheld by those means also is made available by the FBI. This pertains to foreign operations, about which the FBI and CIA have always improvised explanations of convenience to justify entirely unnecessary withholdings. These are attributed to the need to protect foreign operations and cooperation from alleged revelation. These matter always have been public, including in legislated appropriations, public information. The abstract for 2754 contains exactly the kinds of information the FBI and CIA claim the need to withhold. I add exactly that which you swore in G.A. 78-0249 it is necessary to withhold because it is properly classified. This abstract discloses a CIA operation in Italy and the cooperation of the local police, down to the district level. Of course it also discloses the FBI's Italian operation. Consultation with the underlying record discloses the fact that the various Italian police and intelligence components are identified by name, as are other cooperating Italian organizations and their cooperating personnel.

2896. Abstract of 5/3/68 HM TT to St. Louis, responding to its 4/30 request for authorization to obtain information the nature of which is obliterated under (7)(D) claim. These underlying records and others indicate that it is telephone information, at least billings of long distance calls. The information obtained is disclosed in later underlying records, with obliterations. (Sup. 4)

3006. All the content of the abstract is obliterated under (7)(G) and (D) claim. On the underlying record, a Chicago TT to FBIHQ and other field offices, the entire first paragraph on the first page, part of the second paragraph on the second page and a few words and phrases on the third page are obliterated. The TT is devoted largely to coverage of Jerry Ray. From what is not obliterated on the third page it is no great trick to guess what it is from what the FBI itself has disclosed in other records. (But I agree with that withholding nonetheless because those people are not what you call players.) The rest, however, is improperly withheld in this case. The OPR's note shows this: "Example of Bureau's full coverage of Ray's relatives." I am confident that if

you examine the unexercised abstract you will find that there is reasonably segregable information in it (the FBI does not use the form claiming otherwise) and that the information is within the surveillance items of my request. There has not been any search to comply with those ~~items~~ <sup>items</sup> that has been reported. You will find that the total excision of this abstract serves only to protect or seek to hide the improper withholdings in the underlying record, probably all in the first paragraph. You will find that in comparable instances, where there was partial disclosure in the underlying record the abstract was made to be consistent with it rather than totally obliterated, as in this case.

3078. In checking the withholding from this abstract (with which I agree) I note disclosure in the underlying record of precisely the kinds of information you and the FBI have sworn must be withheld lest there be the most disastrous consequences, serious and irreparable injury to the "national security." This includes that the FBI is operational in Mexico, has its agents on the scene in the MURKIN investigations, including at Campeche, that he reports "maximum cooperation being received from Campeche State Judicial Police and State Highway Police," and even the communications facilities they possess and use for the FBI. The operations extended to Ciudad Obregon, Sonora, Guaymas, and other places on Sonora. Well, Mexico hasn't broken diplomatic relations, which the FBI swore would be the consequences of admitting even the fact of any cooperation, and I am not aware of another other consequences - other than negating the fact and deceiving and misleading the courts.

3195. This abstract is atypical in that the information in use is not the first paragraph but rather comes from the third of the four pages of the underlying record, an internal HQ record to which the cited psychiatric report, mentioned elsewhere in what I provide pertaining to the abstracts, also is not attached. Elsewhere I also refer to what the FBI disclosed about the late Louis Lomax. On page 2 of the underlying record it states that he "was at the penitentiary at Joliet, Illinois, on larceny charges from 2/19/50 until 5/9/56. Ray was at Joliet from 6/13/52 until 7/19/52. It is not known whether they were acquainted." But most of the underlying record is devoted

to excised reporting of what Ray allegedly told fellow prisoners. Hoover added this note, atypically not included on the abstract: "Let me have memo on Lomax. H" What is withheld is ~~disclosed~~ disclosed by the Department in the OER's notes, which duplicate what was within the public domain in any event: " . . . prison mate places Ray in Mexico, smuggling from Brownsville, Texas on fishing boat owned by Mateo Lopez Garcia; Stein may be involved in narcotics..."

3136. (7)(C) is claimed to withhold the name of a person which is disclosed by reference to the "Tuskegee Tribune" because in other records, not this underlying record, the FBI has disclosed her name. This is confirmed by the OER note disclosed by the Department: "Bureau attempt to interview Mrs. Lomax negative." (As I recall it her name is something like Almeida, but it is disclosed.) I took this withholding up with the FBI at the time ~~had~~ provided its own record in which it disclosed her name. It did not replace the improper withholding and now seeks to hide that impropriety by repeating it with the abstract.

3164. There is a withholding pertaining to a tip about who killed Dr. King. In the abstract the name "Weisberg" that is withheld in the underlying record is not withheld. This leads to what can be, shall I say confusion? The OER note identifies this person as Aaron Weisberg. I think the possibility of confusion, if not worse, ought be eliminated in the reading room copies as well as mine.

3419. The name is withheld in the abstract, as in some but not all underlying records, of the man who went to the N.O. field office because he was suspected of being behind the King killing. He is identified as one of those who financed <sup>J</sup>in Garrison. This creates suspicions regarding others who financed <sup>G</sup>arrison. Particularly because the FBI did disclose his name elsewhere this matter came up during the depositions, to the accompaniment of tirades and objections from <sup>D</sup>epartment counsel. The name was then correctly provided by me but now the FBI perpetuates the problems by still another improper withholding in its attempt to justify the improper withholdings in the underlying record. The OER confirms that this is Cecil M. Skilstone, with other details.

I believe that particularly because of his involvement in the JFK assassination group known as ~~EEEE~~ "Truth and Consequences," Shilstone is a public personality.

3425. Total withholding of the text of the abstract led me to examine the underlying record. I find that of 11 pages only three were provided. Withholdings on these three pages, which are extensive, clearly include the kind of information that also is disclosed in other records pertaining to checking Ray in Los Angeles and the phone calls he made on his trip from there to New Orleans the preceding December.

Re 2897, first page, above: the OPR note concludes: "But check these person's telephone records for past 6 mo. or as far back as available." Earlier parts of the note pertain to the persons involved. (The note pertaining to Max Ray follows on the OPR records. It is referred to in connection with abstract withholdings in toto.)

Re Bureau routing slips 4-17-68 and 4-19-68, which transmitted photographs and a press release on JAMES EARL RAY, aka. These items were received by Legat, Rome, on 4-22-68.

On 4-23-68 photographs of JAMES EARL RAY and the authorized press release were furnished to ROBERT C. CUNNINGHAM, Managing Editor of the Rome Daily American, an English language newspaper published in Rome and circulated throughout Europe, the Middle East, and some African countries. The photographs and information contained in the press release were published in the 4-24-68 edition of the Rome Daily American.

The same material was furnished on 4-23-68 to ELVIZIO BIANCHI, Managing Director of Agenzia Giornalistica Italia (AGI), which is the equivalent of UPI or AP in the United States. BIANCHI transmitted the information to the Italian newspapers which AGI services throughout Italy, and much of the data furnished to him was noted in the Italian press on 4-24-68.

For the Bureau's information, CIA, American Embassy, Rome, had been advised by its headquarters on 4-20-68 to disseminate detailed information of JAMES EARL RAY to Italian police sources. CIA promptly alerted the Division of Confidential Matters (DAR), Italian National Police, Rome, and the Italian Defense Intelligence Service (SID), Rome, and also informed Legat of the action taken.

Both DAR and SID, knowing of FBI interest in this matter, checked with Legat to determine whether this

office would also submit a request inasmuch as the alerting of all police districts in Italy with detailed information involves a communication expense of almost \$2000. Both sources were advised that CIA had coordinated this matter and that they should honor CIA's request. DAR and SID have instructed all police districts to determine if subject has visited Italy in the past and to remain alert for any current travel on subject's part.

These sources have been requested to notify this office immediately of any positive information developed.

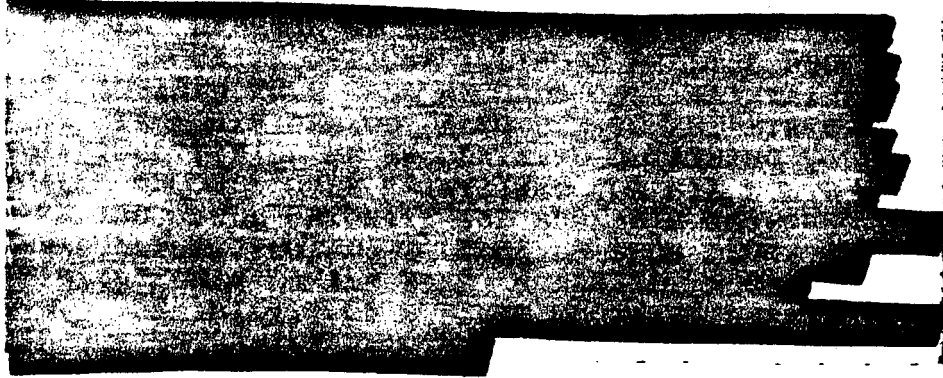

[REDACTED] requested his identity be concealed and advised as follows. In [REDACTED] was [REDACTED] at Missouri State Penitentiary. Ray had aspirations of making a big haul and retiring to Mexico where he intended to live frugally on beans and beer.

Ray told [REDACTED] he wanted to stay off the beaten path in Mexico and avoid American Colonies. He implied he had gone to Mexico twice to cool off after robberies and had once lived with peasants on the outskirts of Campeche, near the Yucatan Peninsula, where he rented a three-room shack. Ray continually emphasized his desire to make one big score and then live frugally in Mexico. He said Mexico City and Acapulco were too expensive; however, he made reference to Torreon in North Central Mexico where he said there were low priced prostitutes in the red-light district.

Ray also told [REDACTED] he had earned money smuggling appliances such as television sets and washing machines which he sold to peasants in Mexico. The smuggling was done from Brownsville, Texas, by a fishing boat owned by [REDACTED] or [REDACTED] who formerly lived in the United States and spoke English. Ray could speak very little Spanish.

[REDACTED] believes Ray went to Mexico in the late nineteen fifties by car and on another occasion went by boat from Brownsville. The Legat, Mexico City, and the San Antonio Office are conducting appropriate investigation concerning the information provided by [REDACTED]

[REDACTED] states he knew Ray in Missouri State Penitentiary from 1962 until August, 1966, but only saw him about once a week. He described Ray as a loner with no close friends, having a bad nervous condition and definitely having a mental problem.

[REDACTED] suspected Ray of using large quantities of amphetamine when it was available and bases this opinion on the rapidity with which Ray's weight would fluctuate with losses or gains of ten to fifteen pounds in very short periods of time. [REDACTED] says such a weight loss is characteristic of the use of a large amount of amphetamine and the subsequent rapid gain would occur when amphetamine was not available.

It is noted Ray gave a Montreal, Canada, address when he enrolled in a correspondence locksmithing course, 7/31/67. The address is in an apartment project which does not maintain accurate records and no record of Ray's tenancy can be found. Employees of the apartment project recall Ray resided there about six weeks paying \$150 when he arrived. He left about Labor Day and a week or two before he left he had been gone for two or three days, supposedly on a trip to the United States.

Investigation is being conducted to determine if Ray was more closely associated with Stein than Stein has admitted.

Louis Lomax was at the penitentiary at Joliet, Illinois, on larceny charges from 2/19/50 until 5/9/56. Ray was at Joliet from 6/13/52 until 7/19/52. It is not known whether they were acquainted.

Louis Lomax has released another story for publication in which he claims he and Charles Stein found the telephone booth in Texas from which Ray made a call to the "cashman" in New Orleans at 8 p. m., 12/16/67. Lomax states that with this clue Ray's New Orleans contact will be identified as soon as telephone company officials can locate the record of the call. We have previously determined that no call to New Orleans was made from this telephone during the entire month of December.

[REDACTED] knew Ray at Missouri State Penitentiary from 1963 to 1966. [REDACTED] says there were two gangs in the prison and Ray associated with the leaders of the St. Louis gang. He also says Ray was close to an inmate who was the main supplier of drugs within the prison. He does not remember this prisoner's name but believes he was serving a long sentence for killing a St. Louis policeman. [REDACTED] alleges this prisoner had six or eight other prisoners selling drugs for him. [REDACTED] believes the drugs were obtained from a guard and says on one occasion one-half pound of amphetamine was found in this prisoner's cell.

In December, 1966, Ray was examined by a psychiatric consultant for the Missouri Board of Probation and Parole. The examiner described Ray as an interesting and rather complicated individual who stated that within the past year he had various physical complaints including "pain in the 'solar plexes,' tachycardia and 'intracranial tension'." The examiner commented to Ray that he was using rather large words and Ray replied that he had been reading medical literature.

The psychiatrist found that Ray's basic problem appeared to be an increasingly severe obsessive compulsive trend. Ray had stated that at the age of ten he awoke one night believing he had lost his eyesight and became quite fearful. It was stated that various fears confront Ray from time to time "in a typical obsessive compulsive way" and he feels he must do certain things to avoid what he feels will occur and harm him. For instance, Ray described a feeling of fear which could be alleviated if he took a glass of water from which he was drinking, placed it on the table and moved it back and forth several times.

The psychiatrist found evidence of a rather deep underlying obsessive compulsive personality trend. The psychiatrist stated that Ray's problem was not psychotic but was severely neurotic and Ray was fearful that his anxiety and tension might lead him into more serious difficulties. The psychiatric report expressed the opinion that Ray was in need of psychiatric help.

ABSTRACTS

413, 498 pertain to an alleged threat<sup>s</sup> against Dr. King, of 1966. The entire abstract for 498 is withheld under (b)(1) claim and the representation that there is nothing reasonable segregable in it. Although (7)(C) claim is made for 413, the name Henriquez Lora is disclosed in the abstract. In all, including the underlying records, these claims were made: (b)(1), (3), (6), and (7)(C) and (D), plus referral to CIA. OPR disclosed what the FBI withheld, that the phoney allegations of this source of "unsavory Reputation" involved the allegation of Cuban involvement in the assassination. In ~~fact~~ fact, the CIA did release the record, both pages, with excisions, so the claim to withhold the entire abstract is baseless and the withholding improper.

618. This abstract is one of a number in which the improper withholdings in the underlying records are not repeated. Of 8 file numbers originally withheld, 7 are of 9 files, which is important information because of the ellipsis of the record and abstract. (However, many unjustifiable withholdings are repeated.)

819. In this abstract and the underlying record a (7)(D) claim is made for information that the FBI itself placed within the public domain. The Chicago items appear to pertain to the Superior Bulk Film Co.

665. Despite the total withholding of this abstract under (b)(1) claim and the representation that there is nothing reasonably segregable in it, what the OPR has disclosed proves the representation to be false. The record (and abstract) pertain to Ray's 10/7/67 trip to Mexico, using his Galt alias. This information is reasonably segregable and the disclosed information does not qualify for (b)(1). (San Antonio TT)

705. This is one of a series of total withholdings of abstracts under the claim "Information furnished by a confidential source." All information from such a source is not within the (7)(D) claim and some information is reasonably segregable.

~~TT~~ 711. To withhold in toto the FBI claims "Name and identifying information of a confidential source and the information obtained from the source." That some is reasonably segregable is established by OPR disclosure of its note, which describes the record as a Newark airtel: "ERIC S. GALT - letter postmarked Montreal, Canada, by

Galt to locksmithing institute, Little Falls, New Jersey. This is not confidential, not the only source available to the FBI, and in fact the FBI itself ~~disclosed~~ disclosed all of this and more. <sup>It</sup> also is in the guilty plea hearing the entire transcript of which was published in 1968. Here the withholding is designed to hide the improper withholding in the underlying record, one of many such cases. Can it be that Supervisor Wood knows so little about the facts of the case and the prosecution? I doubt it.

856. Entirely withheld, (B)(1) claim

860. The abstract is entirely withheld because on 3/17/71 the underlying record was referred to the CIA.

516. Above the 44-36861 file number on this abstract another number, of a file not searched, is written, 9-222-9-55.

534. Discloses Community Relations Service and Criminal Division records not provided in this case.

1110. The FBI claims this abstract is missing. <sup>It</sup> was misfiled. I provide a copy.

999. The (B)(2) claim is baseless because this is not an FBI personnel matter. The abstract begins, "(obliterated) has already been checked..." Two different versions of the underlying record have been provided. In the first the entire first paragraph is withheld but is disclosed in the second except for the language quoted above. In the second paragraph, "a Social Security Number" was originally withheld, as it pertains to three of Ray's aliases only. This is (b)(2) material? Or subject to any withholding within the Act?

927. This abstract requires examination along with the underlying record because there is an unreal element. It is stated that the owner/manager of the flophouse at which Ray stayed in Atlanta contacted SA Donald Burgess at the flophouse and, according to the underlying record, told him that if Galt showed up looking for his TV, Burgess should do nothing about the suspect but should phone Garner, who would be "at his place of employment," obliterated. Perhaps some of what else is obliterated can make sense of this. Burgess was undercover, not as an SA but as a tenant, at the Garner

flophouse. Garner's "place of employment" sounds like an FBI ellipsis for what it has disclosed elsewhere, that Garner also ran a cafeteria. He ~~was~~ appears to have owned it, not to have been employed by it. My appeal is related to the withholdings in the underlying record, not the abstract. What is withheld in the penult. graf after "It is noted that SA" appears to relate to the black bag job. The withheld content could pertain to SA Burgess being undercover there, disclosed, and his pulling a black bag job, also disclosed. (I attach the abstract and the serial as provided.)

The derring-do OPR investigation played it straight and made no reference ~~as~~ in its notes to Burgess being undercover or pulling a black bag job. ("Memo 4/15 Atl to Bureau one Garner came to Galt's address to tell Agent staying there that Galt should contact Garner to get his TV set.") There is further reference to this matter in Serial 1074, which I provide not as an appeal related to the abstracts but because your Mr. Mitchell was misled into inaccuracy in his affidavit, based on which you provided an affidavit. More recently SA Martin Wood testified untruthfully with regard to the Atlanta "Arrow" map. He testified that it was not of evidentiary value and was destroyed. This makes it clear that the map had considerable value and was distributed in copies for investigative purposes. Instead of providing copies of all records, as specified in the Stipulation, the FBI asked me to indicate what <sup>I</sup> might not want, ostensibly to save me money I did not have, and I then said not to copy the Los Angeles map. Its description, in 1074, leads me to ask again for a copy of it. Whether marked up by Ray or another, it, like the Atlanta map, was ~~as~~ marked up.

1133. Checking this, although nothing is withheld in the abstract, led me to another black bag job record. The ~~same~~ language in the abstract, saying that Garner "advised a source," not in any way identified, took my attention. The underlying record employs the same evasive language. It makes clear that the FBI's "source" is the FBI itself, SA Burgess, of the black bag job. The teletype describes the Atlanta and other maps. What the FBI later got in the overt search is listed in 1167, attached. (The junk is to be preserved but Wood testified that the evidence was destroyed.) ~~XXXXXX~~ FBI use

of the black bag job evidence is reported in 1267, which I also provide. While I do not expect any Department of FBI people to correct unfactual affirmations to a court, I provide these records, which are not all but are only those I searched and read on reading the abstracts, to suggest that the source of honor and integrity requires correction of error, which has been hurtful to me and can cause more hurt.

1276. The (b)(2) claim certainly and the (7)(D) claim probably are spurious.

I provide the underlying record with the abstract to show that there is no FBI personnel matter involved.

1097. Entirely withheld under (b)(1) claim. From the worksheet description of the underlying record at least some is reasonably segregable, not less than enough to identify it.

1153. The above is also true of this abstract.

1196. Above also true of this abstract, which was probably withheld in its entirety in an effort to hide the improper withholding of the entire underlying record. That some of it is reasonably segregable and within the public domain, despite the so-called national security withholding, is disclosed by the OPR note. According to the worksheet this is a teletype from Legat, Mexico. OPR's note read "Puerto Vallarta: (1) Hotel Rio (a) ESC stayed from 12/19/67 to 11/6/77" (ESC = Eric Starvo Galt, or Ray.)

1219. Above also true of this. Worksheet identifies Legat Mexico TT, 2 pp, all withheld under (b)(1), the same claim as for the abstract. What is not reasonably segregable and is currently and properly classified, according to the 1980 FBI is, in the words of the OPR's note: "Invest. Puerto Vallarta, Jalisco(.) Moved into Tropicana Hotel 11/7/67 after leaving Hotel Del Rio and stayed until 11/13/67 - alone - from Hh, Aln. Bartender Luis Garcia, Hotel Oceana acquaintance with w/ESC: reports that ESC complained of one larger tire. Also owned portable typewriter." All the foregoing is within the public domain, including via FBI disclosure, so naturally the (b)(1) claim is required and the FBI claims nothing is segregable.

1266. Except for the Mexican details all re 1219 applies to 1266, which withholds entirely under (b)(1) claim what the FBI itself disclosed, from the OPR's note: "Canada:

(1) Clerk, 2589 Rue Notre Dame East, Montreal, located (2) FNU Quintell Windsor, Ontario  
(a) ESG stayed in Apt. 18 ca. 1 1/2 days in 8 or 9/67."

1371. Referred to CIA 2/17/77.

1427. Withheld under (7)(C) and (D) claim as "Information of a personal nature regarding a third party; information obtained from ~~was~~ a confidential source." Bagwash on both counts. The personal information is about Ray and through the FBI's leaking it left no confidentiality for its source, who was interviewed by other writers because of the leaking. Dr. Mark Freeman is identified in Gerald Frank's book (remember the item of my requests asking for the information given to other writers?) and in the New York Times, together with what both writers wanted to use of the 3 pp of LA's TT. OPR identifies the content for me: "Dr. Mark Freeman, L.A., Calif. - patient - James E. Ray; six appointments; Nov 27 - Dec 14." While on the lam as an escapee Ray used his name rather than an alias in seeing the shrink, who ~~was~~ reported to the FBI what it wants to withhold because it is inconsistent with the FBI's preconception. Thanks to the FBI's propaganda operations it can't even make an only source claim for using (7)(D).

1505. Similarly, the FBI <sup>withholds</sup> ~~withholds~~ this abstract to protect the improper withholding of the underlying record (already disclosed to the "third party"), which was withheld to protect the FBI and withhold information that is responsive to a specific item of my requests, an <sup>item</sup> ~~item~~ not complied with. The worksheet, by the way, makes a (7)(D) claim for what the abstract is withheld under (7)(C) for - "Check phone calls Albert Pepper as of 4-19-68 since Mrs. Pepper is Ray's sister." FYI, the FBI was so concerned about Albert Pepper's privacy that it sought him out at his place of work rather than his home. This didn't pressure Pepper, who knew nothing and had never met Ray, but it succeeded in convincing his wife not to trust the FBI. She felt they were trying to get her husband fired. (They tried to get her indicated on local charges but failed.) Both claims are spurious.

1529. To withhold the abstract the FBI claims (7)(D). OPR withheld its note under (7)(C). The worksheet claims both.

1549. referred to CIA 3/17/77.

1685. This was referred to the CIA, which made partial disclosure, although it is an FBI record. Claims made to withhold the abstract are (b)(1), (3) and (6) and (7)(C). Despite this abundance of claims for a single, short abstract, that some was reasonably segregable and is not within any of the four claims is established by the OPR, which describes the record as "CIA Report from Panama City, Panama." (Perhaps content, not the record, which is a memo to Sullivan 3/22/68 memo.) If the CIA's caution that the report might be a hoax, as apparently it was, was in the abstract, that, too, is reasonably segregable and, like the description above, is not within any of the four claims.

1804. Entirely withheld as "Identifying information of a third who furnished information." (Sic) OPR states, "Western Union tapes examined in Detroit." This is the kind of info the FBI generally does not withhold and in this and the JFK case hasn't. However, having withheld the underlying record ((7)(C) and (D)) the FBI did the same with the abstract. Moreover, as the records show, the source was not secret.

1876. Abstract entirely withheld, as was underlying record, both (7)(C) and (D). OPR discloses that this included request for a telephone trace.

2000. Entire abstract withheld, as were four pages of the underlying record, <sup>all</sup> ~~of~~ Indianapolis TT, under (7)(C) and (D). That it relates to John Ray (who served time in Indiana) is disclosed by OPR. Moreover, John has become a public person.

2057. Abstract entirely withheld, (7)(D). That some if not all is reasonably segregable is indicated by the OPR: "LAWRENCE EUGENE WRAY - former prison mate. RAY (sic) stated he will assist FBI with underworld contacts if Bureau desired such help." In fact this information also was disclosed by the FBI and I recall it and the error in the name.

2165. Abstract entirely withheld as information of a personal nature and from a confidential source. The OPR identifies the subject as one Dyrell Dennis. The FBI has disclosed so much about her if she ever had any privacy the FBI destroyed it. She was a prostitute who took \$20 from <sup>Ray</sup> Ray, got scared and returned it. She was travelling with another (named) man when the FBI interviewed them and disclosed those records, too. The abstract is withheld because the underlying record was and is being covered up.

2297. Withheld entirely but OPR discloses some reasonable segregable. ("close friend of King; negative.") Again, consistent ~~with~~ with withholding of underlying record.

2341. Entirely withheld; outstanding CIA referral of 3/17/77. CIA not identified on "deleted page information sheet."

2383. Entire abstract withheld, (7)(C) and (D) to be consistent with initial improper withholding of all 7 pages of underlying record. That at least some is not exempt is established by OPR, the note reading, "Interviews in New Orleans re telephone calls and Ray's and Stein's trip from Los Angeles to New Orleans and return." Much of this description has been released by the FBI and was public domain before FBI release.

2481. Abstract entirely withheld, (7)(D). OPR's note states, "Undercover contact <sup>(Ray)</sup> w/John Larry/requested by Memphis." (All surveillances of all Ray's is an item of my request not complied with.)

2595. Withheld. Referred to CIA 3/17/77.
