also known as Muslim Cult
of Islam, Muhammad's Temples

In January, 1957, a source, who has furnished reliable information in the past, advised that Elijah Muhammad had described his organization on a nation-wide basis as the "Nation of Islam" and "Muhammad's Temples of Islam." ✓

On May 18, 1960, another source, who has furnished reliable information in the past, advised that the NOI is an all-Negro organization which was originally organized in 1930 in Detroit, Michigan. Muhammad, its present national leader, claims to have been selected by Allah, the Supreme Being, to lead the so-called Negro race out of slavery in the wilderness of North America by establishing an independent black nation in the United States. ✓

Members following Muhammad's teachings and his interpretation of the "Koran" believe there is no such thing as a Negro; that the so-called Negroes are slaves of the white race, referred to as "white devils," in the United States; and that the white race, because of its exploitation of the so-called Negroes, must and will be destroyed in the approaching "War of Armageddon." ✓

In the past, officials and members of the NOI, including Muhammad, have refused to register under the provisions of the Selective Service Acts and have declared that members owe no allegiance to the United States. ✓

On May 5, 1958, the first source related that Muhammad, upon advice of legal counsel, had tempered his personal statements and instructions to his ministers concerning the principles of his organization in order to avoid possible prosecution by the United States Government. However, he did not indicate any fundamental changes in the teachings of his organization. ✓

On May 16, 1960, another source, who has furnished reliable information in the past, reported that Muhammad early in July, 1958, had decided to de-emphasize the religious aspects of the teachings of Islam and to stress the economic benefits to be derived by the Negroes who joined the NOI. This policy change, according to Muhammad, would help him to acquire additional followers and create more interest in his programs. ✓

Subject resides at 23-11 97th St., East Elmhurst, (Queens), NY, and has Social Security Number 376-16-3427, FBI #4 282 299, and drives a 1959 black Oldsmobile sedan, 1960 NY license 8U6131. It should be noted, however, that most of his travels is by common carrier.





One source believes subject desires to take over NOI on death of ELIJAH MUHAMMAD and that he also is considering running for public office, possibly US Congress. Subject contacted Cuban Premier FIDEL CASTRO while latter in NYC, during September, 1960, to attend the UN General Assembly.

Subject stated that the "mother plane" is in the air for the sole purpose of destroying America, and that America is the only country that will be destroyed. Subject added that many of the white people of other countries will be driven to this country where they will be destroyed.

[redacted] advised that at the NOI meeting held on May 1, 1960, subject was the speaker and he said that the south and the north is no different as far as the white race is concerned. He said the white are all devils. Subject further stated that in the south we have the rattlesnake but here in the north you have a different snake but they are all snakes.

[redacted] advised that at the NOI meeting held on May 6, 1960, subject was the speaker and in response to a question concerning the selective service, subject answered, according to the informant, "anyone who goes in the Army and does not kill a few crackers (whites) is a fool, first of all you are a fool to go in at all, but after you are put up front just remember that war is legal and you can get a few crackers. Don't be a fool, fight for yourself."

[redacted] advised that at the NOI meeting held on May 15, 1960, subject was the speaker and he stated that the future of the black man in North America is to become the leader of the world, and this is nothing new since the black man is the true leader. According to the informant, subject further stated that "by our god-given right the whole earth belongs to the black man. The white man on the earth is only a passing fancy which will fade away. The black man can live without the white man but the white man cannot live

without the black man. The white man is a weak walking sore on the earth and he must be destroyed. We, the black men of the world created the white man and we will also kill him. According to [REDACTED] subject further stated that there are no good white people on the face of the earth and that when the time comes to kill all of the white devils, all of our black brothers and sisters who think that there are some good ones will die right along with them.

[REDACTED] advised that at the NOI meeting held on June 5, 1960, the subject was the speaker and he stated that we must have some land of our own so that we can deal with other nations around the world, since Mr. MUHAMMAD has an agreement with every black nation all over the world. Subject also stated that if you have something that is not doing you any good then get rid of it and with this, according to source, subject threw the holy bible on the floor and said "that's where it belongs".

[REDACTED] advised that at a NOI meeting held on August 3, 1960, subject was the speaker and he said that the black man has come a long way since the dark days of slavery and is now taking back all that is rightfully his by birth. All over the world today, he is fighting and killing the white man and soon the white man will be no more. It will be wonderful to have peace on the earth again. The source advised that subject further stated that the black man is God and the white man is the devil, so you all know who will win this last great war.

The Black men are slaves and only have jobs given to them by the white man. The time is here and now for the black man to get what he wants.

Subject then added that any Negro that comes to the defense of the white man ought to be killed.

[REDACTED] advised that at the NOI rally held at the Chicago Coliseum, 1513 South Wabash Avenue, Chicago, Illinois, on July 14, 1960, ELIJAH MUHAMMAD was the speaker and he said that the white people have loved ones in the Arabian countries and many other places in the Far East and for every Muslim the white man mistreats, the Muslims of the Far East would kill ten of the white man's people, mostly the white leaders.

At Cleveland, Ohio

[REDACTED] advised that at the NOI meeting held at the Cory Methodist Church in Cleveland, Ohio, on August 21, 1960, ELIJAH MUHAMMAD was the speaker and he said that he must have some land or a state. That at one time all of the land was ours but that the devil (white man) fooled our forefathers until he got the land. He is having his heaven now but in just a few more days his time will be ended.

LITTLE also stated he was the only member of the committee available at the time of the visit, hence, he went to the meeting with CASTRO accompanied by ~~the~~ NOI members and ~~three~~ members of the Negro press. visited by MALCOLM X, leader of the New York Muslim population, who in his role as a member of the 28th Precinct Community Council constituted a one man welcoming committee.

The "Pittsburgh Courier", a weekly newspaper published in Pittsburgh, Pennsylvania, dated October 1, 1960, New York edition, contained an article headlined "Malcolm X Explains Wee-hour Visit to Castro at Theresa." This article reflected that subject stated that he went to see CASTRO in his capacity as a member of the 23th Precinct Community Council which had been formed to greet prominent United Nations members who visited Harlem.

This article further reflected that subject denied any connection with CASTRO, and subject also stated, according to the article: "Premier CASTRO has also come out against lynching, which is also more than EISENHOWER has done. CASTRO has also taken a more open stand for civil rights for black Cubans. He wants to see CASTRO as a Muslim."

Earlier in the article, subject was quoted as saying: "FIDEL CASTRO has denounced racial discrimination in Cuba which is more than President EISENHOWER has done here in America."

This same "Pittsburgh Courier" in their New York edition dated October 15, 1960, contained an article which reflected that subject had tendered a bitter resignation from membership on the Welcoming Committee of the 26th Precinct Community Council, which committee had been designated by the 28th Precinct of the New York City Police Department to welcome ruling heads of state to Harlem during the General Assembly session of the United Nations for the purpose of avoiding any embarrassing incidents.

This article quoted the subject as saying that he resigned because the police and newspapers had failed to refute "barefaced lies, labeling us as lawless terrorists, subversive Communists, seditious, etc."

C. Other Miscellaneous Activity

On April 2, 1960, subject appeared as the guest on the radio program of ~~JERRY WILLIAMS~~, radio station WHEX in Boston, Massachusetts, where he discussed the NOI with WILLIAMS. WILLIAMS has his own radio program nightly, except Sunday, from 10:00 p.m. to 1:00a.m., and on Saturday evenings, he frequently invites a guest with whom he discusses some controversial subject and permits his listeners to telephone questions to the guest.

The "Los Angeles Herald Dispatch", a weekly newspaper published in Los Angeles, California, dated May 12, 1960, contained an article catelined New York, which reflected that subject spoke on May 4, 1960, at New York's Queens College where he defended the documents of Islam as taught by ELIJAH MUHAMMAD. The article indicated that the meeting was sponsored by the Queens College chapter of the National Association for the Advancement of Colored People (NAACP).

The "Pittsburgh Courier", a weekly newspaper published in Pittsburgh, Pennsylvania, New York edition dated August 6, 1960, contained a photograph of subject talking with two others on New York City radio station WLIB. The caption under the photograph indicated that the subject appeared on the WLIB program "The Editor Speaks" which is on each Saturday from 11:30 a.m. to noon.

Subject discussed the Muslim movement in the Negro community, and was questioned by GEORGE SCHUYLER, the "Pittsburgh Courier" New York reporter, and GEORGE W. GOODMAN, WLIB's news director, who were the other two persons in the photograph. The date of this Saturday appearance was not shown.

The Los Angeles Herald Dispatch", a weekly newspaper published in Los Angeles, California, dated August 11, 1960, contained a photograph of subject shaking hands with the Honorable JAJA ANUCHA WACHUKU, Speaker of the Nigerian House of Representatives, following a meeting by the latter with representatives from Harlem in the office of a New York attorney where they discussed Negroes giving technical aid to newly independent African states.

The "Yale Daily News", a daily - except Sunday newspaper published by the students of Yale University at New Haven, Connecticut, dated October 17, 1960, contained an article which reflected that the subject was scheduled to speak at the Yale Law School auditorium at 7:30 pm. on October 20, 1960. This article indicated that subject would put forth his demands for "immediate and complete freedom, justice and equality for American Negroes". The article indicated that the speech was sponsored by the Yale chapter of the NAACP and the John Dewey Society.

The same "Yale Daily News", dated October 21, 1960, contained an article which reflected that there was standing room only in the Law School auditorium where "Malcolm X, New York Black Muslim leader, confronted Herbert Wight, NAACP National Youth Secretary in a debate of the effectiveness of the NAACP".

The article indicated that the two Negro leaders presented totally different plans to achieve a "decent and self-respecting life" for American Negroes. Mr. WRIGHT was quoted as citing the progress of the NAACP, and advocated the continuing struggle for civil rights by the methods of litigation, education and legislation. ✓

Subject on the other hand, completely rejected racial integration and demanded instead the complete separation of the two races. ✓

The article further described the subject as a teacher of the religious prophet ELIJAH MUHAMMAD, who was instructed and sent to us by ALLAH. ✓

The article further indicated that following the meeting several of the followers of the subject moved through the crowd passing out black Muslim literature and selling a 45 r.p.m. record entitled "A White Man's Heaven is a Black Man's Hell". ✓

The "New Jersey Herald News", a weekly newspaper published in Newark, New Jersey, dated October 29, 1960, contained an article setting forth, in condensed form, the information attributed above to the "Yale Daily News". ✓

FRUIT OF ISLAM (FOI)

On May 18, 1950, a source advised that the Fruit of Islam (FOI) is a group within the Nation of Islam (NOI) composed of all able-bodied male members of the NOI. The purpose of the FOI is to protect officials and property of the NOI, assure compliance of members with NOI teachings and to prepare for the "War of Armageddon." Members of the FOI are required to participate in military drill and are afforded the opportunity to engage in judo training. The FOI is governed by a military system wherein the members are controlled by general orders similar to those issued by regular military organizations.

APPENDIX~~CONFIDENTIAL~~MUSLIM GIRLS TRAINING (MGT)

On May 19, 1960, a source advised that the Muslim Girls Training (MGT) is a group within the Nation of Islam (NOI) and is composed of all female members of the NOI. The MGT is similar in structure to the Fruit of Islam, which is composed of all male members of the NOI, in that the MGT has officers, similar to military organizations, to whom other female members are accountable. MGT members receive instructions in homemaking, hygiene, calisthenics, and other subjects such as Muslim history and the English language. There also exists a Junior MGT which is composed of female members of the NOI who are between the ages of 15 and 19 and who are afforded military-type drill.

Since 1957 various officers and "sisters" of the MGT have, at meetings of the MGT, used the term MGT so that it also means General Civilization Class. General Civilization Class refers to classes conducted within the MGT.

The above refers to activities of the MGT at Muhammad's Temple of Islam No. 2, 5335 South Greenwood, Chicago, Illinois.

On May 16, 1960, another source advised that the MGT is a group within the NOI which is composed of all female members of the NOI. The MGT is similar in structure to the Fruit of Islam, which is composed of all male members of the NOI. In theory the MGT exists in all Temples of the NOI and is patterned after the MGT at Muhammad's Temple of Islam No. 2, Chicago. General Civilization Class refers to the collective group of classes held within the MGT.

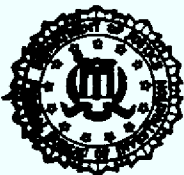

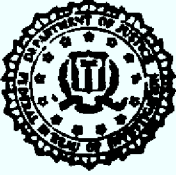

A confidential source, who has furnished reliable information in the past, advised on [redacted] 670 1961, that Malcolm X. Little, Minister of Nation of Islam (NOI) Temple #7, New York, New York, stated on February 20, 1961, that he and the NOI are very upset over the fact that the NOI has been accused of being behind the recent demonstrations at the United Nations over the death of former Prime Minister Patrice Lumumba of the Congo, when in fact they had absolutely nothing to do with them. Malcolm X. stated that this publicity, which has ruined the good name of the NOI, has appeared in numerous United States and foreign newspapers which he himself has reviewed. Malcolm X. claimed that this false accusation is based on a false statement attributing the demonstrations to the NOI by New York City Police Commissioner Stephen Kennedy and that the NOI plans some retaliatory action unless an apology is forthcoming from Commissioner Kennedy and a retraction is printed in the newspapers.

This source advised that Malcolm X. did not say what retaliatory action would be taken by the NOI, but that this action would be decided upon at the forthcoming NOI Convention to be held at Chicago, Illinois, on February 25 and 26, 1961. 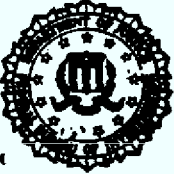

According to this source, during December, 1960, Minister Malcolm X Little of Nation of Islam (NOI) Temple #7 in New York City made the following statements:

The white man is the enemy of the Black man. The Czarist Government suppressed the people and the same kind of revolution as occurred in Russia will take place here in the United States. This revolution will start in Harlem and that "we" are the leaders of this Black man Revolution.

Russians because they are non-white; it will be race against race and we American Black men will support the Russians. We will kill all the white men in the United States.

We Blacks have good leadership and we will build a fighting organization. We have Russian experts, good Communists, who are helping us to organize a fighting group in Harlem.

Malcolm X criticized the United States Department of State and stated that the United States Government does not want free Africans but the Africans will be free with the assistance of the Russian army right in Africa. On Friday, March 24, 1961, at 8:00 p.m., the Harvard Law School forum presented a program "The American Negro: Problems and Solution." This program was in the nature of debate with MALCOLM X (LITTLE), identified as a "black Muslim leader," presenting the point of view in favor of complete segregation between the Negro and the white man, as the solution to the Negro problems. WALTER CARRINGTON, a member of the National Association for the Advancement of Colored People and the Massachusetts State Commission Against Discrimination, spoke in favor of integration of the Negro and the white man as a solution to Negro problems.

SA [redacted] attended this affair which was held in Sanders Theatre, Cambridge, Massachusetts, before an estimated audience of 1600 persons, about 20 per cent of whom were Negroes. Most of the Negro audience were judged to belong to the NOI based on the headdress worn by the females and the golden emblem worn in the lapel of the men's suits.

The speakers were introduced by ROGER D. FISHER, Professor of Law, Harvard University, Cambridge, Massachusetts.

The first speaker was MALCOLM X, introduced as one of the leading figures in the "black Moslem" movement and minister of that movement's mosque in New York City, New York. Professor FISHER gave a background sketch of MALCOLM X and stated MALCOLM X was brought up in Michigan, was the only black pupil in his school classes and his ability and brilliance in school often brought down the resentment of his white classmates upon him.

MALCOLM's home burnt to the ground while the local Fire Department refused to fight a fire in a Negro home. MALCOLM X traveled all about the country committing all types of illegal acts and was confined in Massachusetts State Prison where he became converted to Islam and became a follower of Elijah Muhammad.

MALCOLM X commenced his talk by stating that it must be appreciated that the movement he is a part of is not political in nature, but entirely religious. He explained that the followers of ELIJAH MUHAMMAD believe ELIJAH is one of the prophets mentioned in the Bible and is as great as the prophets JESUS or MOHAMMED. ELIJAH MUHAMMAD's followers believe that he is the last and greatest of the prophets. As a prophet, God, whom Muslims call ALLAH, speaks through ELIJAH MUHAMMAD. When ELIJAH MUHAMMAD sets forth a program of any sort, such as segregation of the Negro from the white man, his followers must accept it as coming directly from ALLAH. They have no choice but to accept it as right and as the will of ALLAH.

MALCOLM X's talk continued in a religious vein. He discussed the 300 years of slavery of the "so-called American Negro," who are denied the opportunity to be taught or to practice the Muslim religion which MALCOLM X claimed was the religion of their forefathers. MALCOLM X discussed the great Negro civilizations from which the forefathers of the "so-called American Negroes" were brought into slavery. He pointed out that many accusations are made against ELIJAH MUHAMMAD as not being a true Muslim and as not practicing the true Muslim religion. He repudiated these accusations by pointing out that ELIJAH MUHAMMAD recently traveled to the Far East, even visiting the Holy City of Mecca and was every where received by Muslim leaders and welcomed as a true Muslim.

MALCOLM X discussed the program demanded by ELIJAH MUHAMMAD that the United States give land to the Negroes in this country in which the Negroes can set up their own government, be segregated from the white race and build their own economy. MALCOLM X stated that the United States government should assist this new country in any way necessary for a period of 45 - 50 years until the country can get on its feet and make its own way.

MALCOLM X claimed that God plans to destroy all opposition to ELIJAH MUHAMMAD. This will come about through the War of Armageddon which will end with black supremacy. He mentioned this war as a prophecy in the Bible and made no mention of Muslim participation in it. MALCOLM X referred to his group on several occasions as "the black masters." This reference appeared to describe the position the followers of ELIJAH MUHAMMAD would be in following the War of Armageddon.

WALTER CARRINGTON was introduced as a Negro graduate of Harvard College and Harvard Law School, a member of the Massachusetts Bar and a practicing attorney in Massachusetts. Mr. CARRINGTON attacked MALCOLM X's position of segregation of the Negro as "the greatest boon to the Klu Klux Klan since the invention of the bed sheet." He pointed out that the "black Moslems" claim to number 100,000. He stated that this is a relatively small and insignificant group when the entire twenty million Negroes are considered as a group. Mr. CARRINGTON believes that the remaining nineteen million, nine hundred thousand Negroes are not in sympathy with the "black Moslems" and wanted integration and want it now. Mr. CARRINGTON pointed out that ELIJAH MUHAMMAD has figured out that the War of Armageddon was to take place in 1914, but God has given seventy years grace to the Negro to afford him an opportunity to join ELIJAH MUHAMMAD. This would place the date of the War of Armageddon at 1984. Mr. CARRINGTON stated that the Negro doesn't want to wait until then, but wants integration and civil rights now. He called the "black Moslems" a segment of the Negro race which has done nothing to advance the Negroes position. CARRINGTON stated that MALCOLM X has stated his beliefs and explained his religion, but he has not told the audience what he actually teaches inside the temples which the white man is forbidden to enter and what he is teaching on the streets of Harlem in New York City.

It was noted that the NOI members in attendance did not applaud CARRINGTON during his talk except upon the rare occasions when MALCOLM X applauded. At the conclusion they offered no applause for CARRINGTON's address until MALCOLM X finally started to clap. The entire audience was orderly and no incidents were noted.

[REDACTED] advised that at the NOI meeting held at Atlanta, Georgia, on January 29, 1961, subject was the speaker and said that it is time for the black men of America to get something of their own. There are 20 million of them and they are all too scared to stand up and demand something for themselves. MALCOLM then stated that it was time for the black man to wake up, stand up, and demand what he wants and stop begging the white man because for 400 years "we" have waited and begged and the white man still says give us a little more time. b7D

[REDACTED] advised that at the NOI meeting held at NOI Temple Number 7, New York City, on February 19, 1961, Minister MALCOLM was the speaker and he spoke about a plane up in the sky which has 35 thousand small planes, each carrying three bombs on it. This plane is for the sole purpose of destroying America which has been given time to save itself by giving ex-slaves a place of their own and assistance for 20 years. b7D

[REDACTED] advised that at the main meeting of the NOI Annual Convention held at Chicago, Illinois, on February 26, 1961, subject spoke and accused the white man of everything from mass rape to mass murder along with mass robbery. He then introduced ELIJAH MUHAMMAD, the main speaker. b7D

According to [REDACTED] ELIJAH MUHAMMAD said that the whites were granted 6,000 years to rule and their time has expired. He spoke of whites as murderers, thieves, and liars, and added that the whites could compensate for their ways by giving the black man 25 states of his own and helping him for 25 years. b7D

[REDACTED] advised that at the NOI meeting held at New Haven, Connecticut, on March 9, 1961, the subject was the speaker and said that a Muslim is quiet at all times unless provoked, and if provoked, he is to resist to the death and take a white person with him. b7D U

[REDACTED] advised that at the NOI meeting held at Temple Number 7, New York City, on March 19, 1961, subject was the speaker and said that the Honorable ELIJAH MUHAMMAD is teaching the Negroes in America today that America not only belongs to them, the whole earth belongs to them. Subject further stated that soon we will have to push the white man off of "our" earth. He then added that God is destroying the Devil today with earthquakes, tornadoes and floods and that America will be destroyed by fire in a 12 hour period. b7D

D. Subject's Tour Through The South

Subject made an extended tour throughout the southern part of the United States during December, 1960, and also returned for several appearances during January, 1961. Information relative to subject's appearance during this

[redacted] advised on [redacted] 1960, that an announcement was made at the NOI meeting held at Temple Number 7, New York City, on December 14, 1960, that subject attended by invitation the Interdenominational Ministerial Conference in Alabama, at which several colleges were represented, including Clark, Moorehouse, and Atlanta University. The date of this conference was not furnished. b7D

The December 17, 1960, issue of the "New Jersey Herald News", a weekly newspaper published at Newark, New Jersey, contained an article datelined Atlanta, Georgia, which reflected that subject was touring the deep South organizing followers of ELIJAH MUHAMMAD and lecturing before church, civic and fraternal groups. The article further indicated that subject had lectured to divinity students at Gammon Theological Seminary, Atlanta, Georgia, and to students at Moorehouse. U

[redacted] advised on [redacted] 1960, that at an NOI meeting held on December 23, 1960, at Temple Number 7, New York City, subject was the speaker and spoke about his recent trip through the South and stated he had visited the following states, among others: b7D

The December 31, 1960, edition of the "New Jersey Herald News" contained an article datelined Birmingham, Alabama, which reflected that subject was touring the South and had spoken in Birmingham, and had also spoken at the NOI Mosque in New Orleans, Louisiana, and at Pensacola and Tampa, Florida.

The "New Crusader", a weekly newspaper published in Chicago, Illinois, contained an article in their December 31, 1960, issue datelined Birmingham, Alabama, and captioned, "Malcolm X Hits 'Tom' Preachers." The article stated that in speeches throughout the South, subject has "charged repeatedly that Negro preachers are making 'religious cowards' of the oppressed black masses by preaching a gospel of 'non violence and peaceful suffering' in the face of increasing white hostility and attacks."

This article indicated that subject had visited Birmingham, Alabama, Tampa and Pensacola, Florida.

The "New Jersey Herald News", in their January 7, 1961, edition, contained an article under the headline, "Dixie Negro Will Revolt" and "Malcolm X Foresees Southern Negro Rebellion in 1961." The article, which was datelined Newark, New Jersey, reflected that subject, who had just returned from an extended tour of the deep South, visited the paper's office and stated that 1961 may witness a violent climax to the South's continuing racial problem. He described the South as a "tinderbox about to explode" and predicted that "this may be the year in which the young Southern Negro, forced to the wall, is going to hit back, and hit back hard!

Everywhere I went I saw signs that the new Negro they talk about, the young Negro, has had just about all he can stand." The article further stated that subject was enthusiastic about the growth of Muslim influence in the deep South.

The February 4, 1961, edition of the "New Jersey Herald News" contained an article datelined Atlanta, Georgia and captioned, "Muslims Give JFK Man A Fit." The article explained that Dr. ARTHUR SCHLESINGER, JR., Economic Advisor to the President, spoke on January 17, 1961, at Sisters Chapel, Spelman College Campus, Atlanta University Center, and during his talk compared the black Muslims with the Ku Klux Klan (KKK). During a subsequent question and answer period, subject, who was present and identified himself only as a Muslim, sharply questioned Dr. SCHLESINGER about the basis for the above statement and forced him to state that he had insufficient evidence to go into the subject any further. (See page 18 re KKK)

The January 24, 1961, edition of the "New Jersey Herald News" contained a photograph of subject talking with students after a speech at Davage Auditorium, Clark College, Atlanta, Georgia.

E. Other NOI Matters

[REDACTED] New York City Police Department, Bureau of Special Services, New York, New York, advised on November 16, 1960, that all bills of NOI Temple Number 7, New York City, are paid in cash and he has personally observed subject take cash from the safe in Temple Number 7 Restaurant, 113 Lenox Avenue, New York, New York, and pay bills therewith. 67D

the NOI meeting at Temple Number 7, New York City, on December 23, 1960, a mass trial was conducted by subject concerning several moral violations by members of the Temple. The violations included smoking reefers, adultery, fornication, taking narcotics and selling narcotics. In regard to the member of Temple Number 7 who allegedly sold narcotics, MALCOLM stated that he was lucky that he was caught by the Muslims instead of the law, because the law would "blow this up and use it against Elijah Muhammad." All of the violators were expelled from the Temple for periods lasting from 90 days to 5 years.

The December 3, 1960, New York edition of the "Pittsburgh Courier", a weekly newspaper published in Pittsburgh, Pennsylvania, contained an article which reflected that the NOI had filed a \$3,000,000 suit for libel and slander against the Hearst Newspapers Consolidated charging a misrepresentation in an article published in the September 25, 1960, edition of the "New York Journal American" of the Hearst chain. According to this article, the article involved contained inaccuracies and misrepresented the meeting between New York Muslim Minister MALCOLM X and FIDEL CASTRO. The article falsely charged that the NOI was deeply involved in some international intrigue with NASSER of Egypt, CASTRO of Cuba and KHRUSHCHEV of Russia in a plot to win the mind of America's 20 million Negroes and use them in winning the allegiance of the newly independent African nations.

The "New York Amsterdam News", a weekly newspaper published in New York, New York, contained an article in their city edition of February 25, 1961, which reflected that subject vowed to take legal steps against United States Ambassador to the United Nations, ADLAI STEVENSON and New York Police Commissioner STEPHEN P. KENNEDY, for their statements that the disorder at the United Nations in February, 1961, was caused by the NOI.

The March 11, 1961, edition of the "New York Amsterdam News" contained an article which reflected that the United States Muslims sued two New York daily newspapers, "The World Telegram" and the "Journal American", for \$6,000,000 in libel as a result of stories put out last February involving a demonstration by Negroes at the United Nations Security Council hearings. The suit was filed on behalf of ELIJAH MUHAMMAD, head of the NOI, and MALCOLM X, head of the New York City NOI Temple.

III. MISCELLANEOUS

A. Public Appearances

The "New Jersey Herald News" in their February 25, 1961, edition, contained an article datelined Washington, D.C., which reflected that the Howard University student chapter of the National Association for the Advancement of Colored People (NAACP) had to withdraw an invitation to subject to speak on February 14, 1961, for their "Negro History Week" because his appearance had not been registered in advance with the Student Activities Office.

On March 29, 1961, [REDACTED] [REDACTED] WBZ TV, 1170 Soldiers Field Road, Boston, Massachusetts, advised that subject was interviewed on his TV station relative to the NOI views and beliefs on March 23, 1961, by a member of the WBZ TV staff.

The "Los Angeles Dispatch", a weekly newspaper published in Los Angeles, California, in their April 20, 1961, edition, contained an article which reflected that due to illness, ELIJAH MUHAMMAD was forced to cancel a speaking engagement at Embassy Auditorium on April 16, 1961, and that

subject substituted for him. Subject also filled in for ELIJAH MUHAMMAD at three other scheduled meetings, according to the article.

The "TV Guide", a weekly publication that lists local New York area television programs, in their edition covering the period from April 22 to 28, 1961, reflected the following:

On Sunday, April 23, 1961, at 4:00 p.m., the program, "Open Mind", on NBC TV had a discussion on "The Black Muslims in America." Participants in the program included Professor C. ERIC LINCOLN, author of the book, "The Black Muslims in America"; JAMES BALDWIN, author, GEORGE S. SCHUYLER, Associate Editor of the "Pittsburgh Courier"; and MALCOLM X, Minister of Temple Number 7 in Harlem.

67D [redacted] advised on [redacted] 1961, that subject reportedly is to speak on the programs of the NOI at Wheeler Hall, University of California, Berkeley, California, on May 3, 1961.

B. Debates With NAACP Representatives

"The New Crusader", in their edition of October 29, 1960, contained an article datelined New Haven, Connecticut, which reflected that subject engaged in a debate at Yale University Law School with HERBERT WRIGHT, National NAACP Youth Secretary. They debated whether "separatism is better for Negroes than integration."

The "New Jersey Herald News", in their November 12, 1960, edition, contained a photograph of subject debating on racial matters with an NAACP representative on radio station WBAI, New York City, on November 7, 1960.

The March 11, 1961, edition of the "Pittsburgh Courier" contained an article which reflected that subject engaged in a debate with HERBERT WRIGHT, National Youth Secretary of the NAACP, at City College, College of the City of New York, New York, New York, on March 2, 1961. The article stated that subject said that the United States government still owes back pay to the Negroes for 310 years of slave labor, and he rejected the NAACP's contention that integration was working. Instead, according to the article, the subject proposed that the American Negro set up his own nation with land and grants from the federal government. The article quoted subject as saying, "It'll take more than a cup of tea in a white restaurant to make us happy."

The March 25, 1961, morning editions of the "Boston Herald" and the "Boston Globe", daily newspapers published in Boston, Massachusetts, reflected that the Harvard Law School Forum presented a program at Sanders Theater, Cambridge, Massachusetts, on March 24, 1961, in the nature of a debate between subject and WALTER CARRINGTON, NAACP member. The article indicated that CARRINGTON favored integration while subject favored complete separation.

The "Yale Daily News", a daily newspaper published by undergraduate students at Yale University, New Haven, Connecticut, in the April 19, 1961, edition, contained an article which reflected that on April 19, 1961, at Yale University, subject would debate with LOUIS LOMAX. LOMAX was described as the author of "The Reluctant Africans" and a former reporter for the "Chicago American." The meeting was sponsored by the Yale chapter of the NAACP.

C. Contact With The KKK

The KKK has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

[redacted] advised on January 30, 1961, that certain Klan officials met with leaders of the NOI on the night of January 28, 1961, in Atlanta, Georgia. One of these NOI leaders identified himself as MALCOLM X of New York, and it was the source's understanding that MALCOLM X claimed to have 175,000 followers who were complete separationists, were interested in land and were soliciting the aid of the Klan to obtain land. During this meeting subject stated that his people wanted complete segregation from the white race, and that land obtained would be occupied by them and they would maintain their own businesses and government. Subject further stated that the Jew is behind the integration movement, using the Negro as a tool. Subject was further quoted as stating that his people would do anything to defend their beliefs and promote their cause and in his opinion there would be violence some day. Subject was further quoted as saying at this meeting that if one of his people went against their teachings, he would be destroyed. Subject also stated that if his people were faced with the situation that the white people of Georgia now face, that traitors, meaning those who assisted integration leaders, would be eliminated.

D. Comments and Contacts With Communists And Russia

The Communist Party, USA, (CP, USA), has been designated by the Attorney General of the United States pursuant to Executive Order 10450.

[redacted] advised on [redacted] 1960, that during December, 1960, Minister MALCOLM X LITTLE of NOI Temple Number 7, New York City, made the following statements:

The white man is the enemy of the Black man. The Czarist Government suppressed the people and the same kind of revolution as occurred in Russia will take place here in the United States. This revolution will start in Harlem and that "we" are the leaders of this Black man Revolution.

MALCOLM X expressed himself as a great admirer of NICOLAI LENIN and JOSEPH STALIN and stated that they were actually non-white men. He explained that LENIN was of the yellow race descending from the Mongols and STALIN descending from Semitic-Arabs and a Muslim mixture with dark skin. The Americans who are white will fight the Russians because they are non-white; it will be race against race and we American black men will support the Russians. We will kill all the white men in the United States.

We blacks have good leadership and we will build a fighting organization. We have Russian experts, good Communists, who are helping us to organize a fighting group in Harlem.

MALCOLM X criticized the United States Department of State and stated that the United States Government does not want free Africans but the Africans will be free with the assistance of the Russian army right in Africa. He stated that the United States was responsible for encouraging England, France and Israel to invade the United Arab Republic in 1956.

[REDACTED] described subject as shrewd, canny and at times smart but further stated that he actually was a "mad dog" temporarily on a lease. According to [REDACTED] subject is violently anti-white and insists that the whites must be destroyed.

[REDACTED] on [REDACTED] 1961, advised that on February 13, 1961, WILLIAM L. PATTERSON contacted various

Harlem community leaders and Negro "nationalist" leaders to discuss some united front action regarding the "murder" of former Congolese Premier PATRICE LUMUMBA. According to ██████████ PATTERSON knew these individuals would probably do something on their own and he wished to coordinate their activities with the CP. Out of these contacts grew the plans for the "Memorial meeting" to be held on February 26, 1961, at Hotel Theresa in New York City's Harlem. b7D

"The Worker", December 11, 1960, issue, page 12, identified WILLIAM PATTERSON as a full-time member of the New York State CP in the capacity of Vice-Chairman.

"The Worker" is an East Coast Communist weekly newspaper.

██████████ advised that on February 15, 1961, a meeting of the Harlem CP members was held in Harlem to discuss continued participation in pro-LUMUMBA affairs, and it was decided that the CP should do everything to keep the "memorial meeting" on February 26, 1961, under control. It was also announced that a meeting to make final plans for the "memorial meeting" would be held in Harlem on February 19, 1961. According to ██████████ a discussion was then held as to whether or not subject should be invited to this planning meeting, but it was finally decided that he should be invited only to the "memorial meeting." b7D

It is to be noted that on February 26, 1961, according to information set forth above under Section II, paragraph B, subject was in Chicago, Illinois attending the Annual NOI Convention.

FRUIT OF ISLAM (FOI)

On May 13, 1950, a source advised that the Fruit of Islam (FOI) is a group within the Nation of Islam (NOI) composed of all able-bodied male members of the NOI. The purpose of the FOI is to protect officials and property of the NOI, assure compliance of members with NOI teachings and to prepare for the "War of Armageddon." Members of the FOI are required to participate in military drill and are afforded the opportunity to engage in Judo training. The FOI is governed by a military system wherein the members are controlled by general orders similar to those issued by regular military organizations.

MUSLIM GIRLS TRAINING (MGT)

On May 19, 1960, a source advised that the Muslim Girls Training (MGT) is a group within the Nation of Islam (NOI) and is composed of all female members of the NOI. The MGT is similar in structure to the Fruit of Islam, which is composed of all male members of the NOI, in that the MGT has officers, similar to military organizations, to whom other female members are accountable. MGT members receive instructions in homemaking, hygiene, calisthenics, and other subjects such as Muslim history and the English language. There also exists a Junior MGT which is composed of female members of the NOI who are between the ages of 15 and 19 and who are afforded military-type drill.

Since 1957 various officers and "sisters" of the MGT have, at meetings of the MGT, used the term MGT so that it also means General Civilization Class. General Civilization Class refers to classes conducted within the MGT.

The above refers to activities of the MGT at Muhammad's Temple of Islam No. 2, 5335 South Greenwood, Chicago, Illinois.

On May 16, 1960, another source advised that the MGT is a group within the NOI which is composed of all female members of the NOI. The MGT is similar in structure to the Fruit of Islam, which is composed of all male members of the NOI. In theory the MGT exists in all Temples of the NOI and is patterned after the MGT at Muhammad's Temple of Islam No. 2, Chicago. General Civilization Class refers to the collective group of classes held within the MGT.

NATION OF ISLAM (NOI)

In January, 1957, a source advised that ELIJAH MUHAMMAD had described his organization on a nation-wide basis as the "Nation of Islam" and "Muhammad's Temples of Islam."

On May 18, 1960, another source advised that the NOI is an all-Negro organization which was originally organized in 1930 in Detroit, Michigan. MUHAMMAD, its present national leader, claims to have been selected by ALLAH, the Supreme Being, to lead the so-called Negro race out of slavery in the wilderness of North America by establishing an independent black nation in the United States.

Members following MUHAMMAD'S teachings and his interpretation of the "Koran" believe there is no such thing as a Negro; that the so-called Negroes are slaves of the white race, referred to as "white devils," in the United States; and that the white race, because of its exploitation of the so-called Negroes, must and will be destroyed in the approaching "War of Armageddon."

In the past, officials and members of the NOI, including MUHAMMAD, have refused to register under the provisions of the Selective Service Acts and have declared that members owe no allegiance to the United States.

On May 5, 1958, the first source related that MUHAMMAD, upon advise of legal counsel, had tempered his personal statements and instructions to his ministers concerning the principles of his organization in order to avoid possible prosecution by the United States Government. However, he did not indicate any fundamental changes in the teachings of his organization.

On May 16, 1960, another source reported that MUHAMMAD early in July, 1958, had decided to de-emphasize the religious aspects of the teachings of Islam and to stress the economic benefits to be derived by the Negroes who joined the NOI. This policy change, according to MUHAMMAD, would help him to acquire additional followers and create more interest in his programs.

WORKERS WORLD PARTY

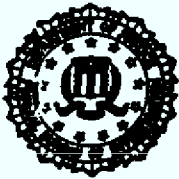
On April 17, 1959, a source advised that on February 12, 1959, a Socialist Workers Party (SWP) minority group, under the leadership of National Committee member SAM BALLAN, known in the SWP as SAM MARCY, split from the SWP.

The source stated that this minority group, referred to as the Marcyites, after many years of program and policy differences on varied issues concerning tactics and interpretation of political events, split from the SWP on the grounds that the Party was liquidating itself by departing from the Marxist precepts of LEON TROTSKY and retreating from the fight for the world socialist revolution. The final issue which ultimately forced the split was the minority's opposition to the SWP regroupment policy which involved cooperation with the Communist Party (CP) periphery - individuals characterized by the minority as petty-bourgeois.

The minority program, according to the source, advocates the unconditional defense of the Soviet Union and has as its goal the building of a revolutionary party with a complete proletarian orientation for the purpose of overthrowing capitalism in the United States and throughout the world.

On May 12, 1960, the source advised that this minority group had chosen the name Workers World Party with headquarters located at 46 West 21st Street, New York, New York.

The SWP and the CP have been designated by the Attorney General of the United States pursuant to Executive Order 10450.

Re San Francisco airtel 5/5/61, regarding appearance of MALCOLM X (LITTLE) in San Francisco area April 29 to May 8, 1961.

Following information is set forth for information of Bureau, New York and Chicago to record events and publicity surrounding the conclusion of the visit to Northern California by MALCOLM X.

The 5/7/61 edition of the "San Francisco Chronicle," daily newspaper, carries an article reporting that the University of California decision to ban a campus talk by MALCOLM X was vigorously attacked by the American Civil Liberties Union (ACLU) on 5/6/61. The ACLU is quoted as calling the University's ruling a perversion of the meaning of the law and a sham.

The 5/6/61 edition of the "San Francisco Examiner," daily newspaper, printed a news item setting out that SLATE, University of California political organization, on 5/5/61 protested the cancellation of the scheduled campus speech by MALCOLM X. RICHARD FALLENBAUM, Vice Chairman of SLATE, is reported to have said that to deny MALCOLM X the right to speak, after allowing other religious speakers to be heard on campus, is clearly an inconsistent and discriminatory application of University regulations.

The 5/4/61 issue of the "Sacramento Union," daily newspaper, contains a story revealing that on 5/4/61 ANWAR ALI KHAN, a leader of the Sacramento Moslem League, told a gathering of 350 persons at Sacramento, including MALCOLM X, that the Negro Muslim group are members of the true Moslem religion. At the same time, KHAN denounced the policy of certain California officials, including Sacramento County Sheriff JOHN MISTERLY, for "persecution of the black Muslim."

The 5/9/61 issue of the "San Francisco Chronicle" published a news release stating that on the evening of 5/8/61 MALCOLM X addressed an audience of 200, the majority of them white, at Stiles Hall, the University of California YMCA (off campus.) He criticized the University administration for refusing to let him speak on campus and likened himself to President EISENHOWER when the latter was forced to cancel his visit to Japan. In his talk, MALCOLM X demanded land for the black people in exchange for 300 years of slavery. The newspaper release concludes with the statement that MALCOLM's remarks were enthusiastically received by the overflow audience.

On the evening of 5/11/61, from 9:30 p.m. to 10:15 p.m., MALCOLM X appeared on Television Station KQED, Channel 9, San Francisco, on the program "Bay Area Profile." The program was on video tape and appeared in the form of a debate between MALCOLM X and TERRY FRANCOIS, prominent San Francisco Negro attorney and President of the San Francisco Chapter of the NAACP. Acting as moderator was the program host, CASPER WEINBERGER, who gave a brief history of the Black Muslim Movement in his introductory remarks. Each speaker presented a brief statement and the remainder of the time was devoted to questions and answers. During his talk and also in answering questions, MALCOLM X stated that the Muslims are not black nationalists and are not political in nature as charged in recent publicity. He referred to himself as a "follower" of ELIJAH MUHAMMAD and not the number two man of the movement. He said all of MUHAMMAD's followers are number two men. MALCOLM defined the group as religious in essence, devoted to the moral reformation of black people in America, seeking unity, harmony and economic independence from "our former slave masters." He pointed out that "we" are not a hate group but "we" hate suffering and oppression as second class citizens. He decried the use of integration as a panacea, and he cited the meager gains made since the 1954 Supreme Court ruling as an indictment of integration and as a need for complete separation, not segregation. MALCOLM called ELIJAH MUHAMMAD a modern MOSES and the hope of the black man in America. He mentioned that the FBI spends untold sums to harrass "us black men" and has yet to charge "us" with sedition or cite "us" as a subversive organization under Executive Order.

TERRY FRANCOIS agreed that the Negro in America should improve his condition in society and that the common bond of the black race is oppression. However, he said, the Black Muslim philosophy of separation is not the answer and the idea of a division of the races smacks of race superiority. FRANCOIS said that the Muslim philosophy of hatred of all white men encourages violence and he feels the Black Muslim movement appeals to social rejects and ex-convicts principally.

██████████ reported on 5/18/61 that MALCOLM X (LITTLE) left San Francisco on 5/8/61 following his appearance at Stiles Hall, Berkeley, California.
