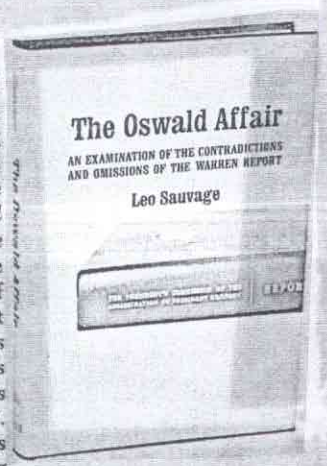
**The Oswald Affair:**

*The Oswald Affair* is a completely factual and unemotional account of the legal investigation of the century's most shocking crime. In this book, Leo Sauvage examines the startling inconsistencies of the Warren Report. He carefully sifts the collection of evidence assembled by a commission that the author claims set out to show that Lee Harvey Oswald *could* have killed John Kennedy rather than seriously to seek the true identity of the assassin. The author, by pointing out the errors, omissions, and discrepancies of testimony, much of which he maintains would not have been admissible in a court of law, systematically shoots holes into the major assumptions made by the Warren Commission in substantiating Oswald's guilt. This carefully researched and well-reasoned study poses a simple but troublesome question about the death of John F. Kennedy: "How much longer can we all fail to honor his memory through the elementary homage of seriously seeking the truth about his assassination?"

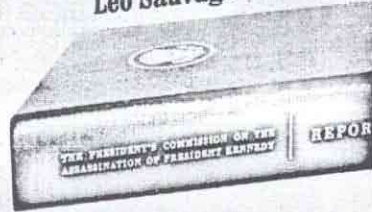
