I am thoroughly convinced that the most important issue facing our country today is the current investigation into the assassination of our late President,

For me, this case must take precedence over any and all issues from the war in Vietnam to the feared guerrilla warfare on

All of the corruption, degradation, and hopelessness that we find in our country sooner or later seems to find its roots in common soil. RESPONSIBILITY DEPT: Roger Craig is a former Dallas Deputy Sheriff. He was on the force for eight years; and in 1960 was the recipient of the Man of the Year Aware for heroism and courage. On the day of the assassination he was about fifteen yards from the steps of the book depository building in Dealey Plaza,

Craig was a guest on my radio show on March 3 with author Penn Jones. Among other things he informed us that at the time of Jack Ruby's arrest in the Police base-

ment an enormous amount of cash (over ten thousand dollars) was discovered both on his person, in his pad and in the trunk of his

He said that Sheriff Decker informed his men on the day of the assassination that the secret service and FBI would handle all of the local security.

When Craig wanted to rap about Edgar Eugene Bradley, I told him that I rather he did not. Craig agreed and Bradley's name

never came up.

One day later I am watching Baxter Ward's version of the news and suddenly Roger Craig is being interviewed by an ABC reporter. It's one of those staged news sequences in which the illusion is given that Craig has just observed some ABC film of Bradley in one of the studio's screening rooms.

Roger Craig makes a positive identification that the man he saw in the film (Edgar Eugene Bradley) is the same man he observed in Dallas on the day of the as-

sassination.

I was genuinely disturbed by the fact that an innocent man (until proven otherwise) was being tried on TV in absentia, Bradley was not able to cross examine this most convincing and seemingly reliable witness. There was no equal time rebuttal in evidence and Craig's comments were not labeled opinion or speculation. It was truly a frightening moment.

Now, I know you're going to say that they never give Garrison equal time and Bradley was parading all over the place with his, lie detector expert and former FBI attorney. You'll tell me about his refusal to go to New Orleans to clear his name and all the rest

Yeah, sure I'm hip to that. But let us not lose sight of our objectives here. Aren't we concerned with the pursuit of justice? Don't forget that Lee Oswald was denied all of his legal rights in Dallas and the press had determined his guilt within hours after his capture. And he was innocent of all charges against him.

In our over-zealousness to function in the interest of the people let us not lose sight of the rights of all the people.

Upon reflection, it occurred to me that surely ABC must have realized the danger in doing what they did. Surely they are aware of the fact that the publicizing (in this manner) of such an inflammatory piece of testimony might tend to damage the District Attorney's efforts. Didn't they understand that Bradley's attorneys could at some future date stand before a judge and claim that the four minutes of ABC film might tend to prejudice a perspective juror and make it impossible for Edgar to get a fair trial?

And then I remembered that this is America, And the American Broadcasting Company is in business to sell deodorant cream and dog food. The Baxter Ward news hour as well as the Joey Bishop show were not set up to help our country get its things together. And at the risk of sounding slightly paranoid, perhaps the word came down from the Ministry of Truth that the network shouldinform all of its local News Outlets that a man named ROGER CRAIG #H52768 would be in Los Angeles on Sunday, Feb. 25 and, well you know the rest.
