

# Chief Justice Satisfied With Warren Commission Findings

LIMA (UPI)—Chief Justice Earl Warren said Friday he knows of not one single fact that might change the conclusions of the Warren Commission report on the assassination of President John F. Kennedy.

Warren emphasized at a press conference that he was personally satisfied with the conclusions of the Warren report. The report identified Lee Harvey Oswald, acting alone, as Mr. Kennedy's assassin.

Warren refused to comment on the New Orleans investigation by Dist. Atty. Jim Garrison.

He said he did not know Garrison, had never heard from him in connection with the assassination, and was not well acquainted with the most recent developments because of his absence from the United States. Warren and his wife are on a private visit to Peru.

Warren said if any new evidence were uncovered it should be examined and the "law permitted to follow its course."

Responding to questions from newsmen who filled the auditorium in the U.S. Embassy, Warren said he did not believe revision of the Warren report or a new investigation was warranted on the basis of the known facts.

"Nobody is more interested in truth than myself. Nobody should be afraid of the truth," Warren said.

He answered a number of technical questions about the assassination by referring to the conclusions of the commission that he headed. He said the report was "the most we could do." **END**

# Fourth Witness Called by Garrison

NEW ORLEANS — A surprise witness who seemed more amused than concerned by being subpoenaed was questioned for a little more than an hour Friday by Dist. Atty. Jim Garrison's investigators.

Exactly what Dante Marochini contributed to Garrison's free-wheeling personal investigation into the assassination of President John F. Kennedy is not known.

Investigators barred the door to Garrison's office after Marochini emerged. Afterward, Marochini was engulfed by a wave of newsmen and television cameramen.

"Let me by, let me by," said Marochini, losing his composure for the first time since his arrival at the Criminal Courts Building. Then Garrison's investigators swept past the swarm to a car waiting outside.

When Marochini, a slight, dark-haired man, appeared during the late afternoon at the Courts Build-

ing, he was smiling and affable. He laughed at photographers and said:

"I don't know what this darn thing is all about."

One Garrison investigator, asked a series of questions about the witness, replied, "I can't say anything about it."

Three other men have been subpoenaed by Garrison's office this week. Two left after being questioned. The third, civic leader Clay L. Shaw, was arrested Wednesday and accused of plotting with Lee Harvey Oswald and others to assassinate Mr. Kennedy.

Shaw, who was freed on bail, has denied all of

## Garrison's charges.

Marochini reportedly once was employed by the same firm as Oswald.

Oswald, named in the Warren Commission report as the sole assassin of Mr. Kennedy, was the employe of a coffee firm whose subsidiary Marochini reportedly once worked for.

Since then, Marochini reportedly has owned one or two small New Orleans nightclubs and presently is employed as a planning and specifications man in the National Aeronautics and Space Administration's Michoud complex, down river from the city.

Marochini's name does not appear in the Warren Commission report.

He is married, lives in a

modest house in the Gentilly section of the city and has three or four children.

Sheriff Louis Hyde Jr. said Marochini was notified that he had been subpoenaed and asked if he wished to have papers served on him at work, or

whether he would appear voluntarily.

"He was totally cooperative," said Hyde. "He asked where he should appear and what time. He even said 'I don't get off work until 5 o'clock—is it OK if I'm a little late?'" (EW)

## KENNEDY: Arrest in New Orleans 'Plot'

New Orleans Dist. Atty. Jim Garrison last week continued his enigmatic investigation of what he has called a plot behind the assassination of President John F. Kennedy.

His office subpoenaed four men, and one was arrested after questioning. He was retired business executive Clay Shaw, a prominent New Orleans figure listed as one of the 35 most important men in town in the March issue of Town and Country Magazine.

Garrison said he had an informant who told him that Shaw, Lee Harvey Oswald (who, the Warren Commission found, killed the President), David Ferrie (who died two weeks ago—Garrison said he committed suicide to avoid arrest, the coroner said of natural causes) and others met in Ferrie's apartment in September 1963 to plot the assassination of the President.

### Why Did FBI Investigate?

Acting U.S. Atty. Gen. Ramsey Clark said in Washington that an FBI investigation after the assassination cleared Shaw of any involvement, but the FBI declined to say why Shaw was investigated in the first place.

Shaw posted bond, and in a brief news conference denied so much as knowing Oswald or Ferrie, much less plotting with them.

The other men subpoenaed and questioned by Garrison and his staff were Dean Andrews, assistant district attorney in suburban Jefferson Parish; James Lewallen, a missile plant employe who once roomed with Ferrie, and Dante Marachini, another missile plant worker.

Garrison said his still-secret informant was given sodium pentothal—truth serum—after reporting on the plotters' meetings and that he repeated and confirmed his original testimony.

The probe continues. **END**
