Dear Jim

Herewith the list of titles I referred to during my presentation on 8th May. As far as I know none of these titles are currently available in bookshops here but I think nearly all are held by main libraries, including Harold Weisberg's books. Weisberg, Roffman, Meagher and Newman are all totally reliable in terms of what evidence they refer to and how it is interpreted. I cannot say the same for the authors of the Warren Report.

Weisberg is absolutely critical and objective, and ruthless in following matters through mountains of files until he has nailed down what is real and true in terms of the commission's own evidence. His books are a must for anybody who wishes to peel back the layers of official cover up and look at what is hidden underneath.

John Newman is now a professor of history at the University of Maryland and his research into JFK's Vietnam policies started while he was still a Major in US Army Intelligence. He broke significant new ground with his work on the draft versions of the NSAMs from the Kennedy presidency after they were declassified in 1988. (NSAM = National Security Action Memorandum). Newman's book establishes that the military were deceiving Kennedy, and McNamara, about what was going on in Vietnam during the early 1960s. It is a very disturbing book.

Sylvia Meagher first wrote an index for the unindexed 26 volumes of published evidence from the Warren Commission. Then she wrote her excellent book, <u>Accessories after the Fact</u>, which highlights the most glaring contradictions and omissions in the Warren Report. Her analysis of the Commission's evidence was so acute that most of the things she discovered amiss working only with incomplete files have been confirmed by documents released later that were not in the published volumes.

Howard Roffman, another university professor of history, now at Berkley, wrote the definitive book on the evidence the Warren Commission had levelled against Oswald. This is a very tight work, painstakingly examining the commission's evidence item by item and finding it deficient on every count.

I hope you collected a few questionnaires from the conference on the Tuesday because I only have about twenty that I was given on the afternoon.
