

Re: Clarifications for Session on WC and Its *Case*

1. Oswald showed penchant for violence---WC evidence 91) His attack on General Edwin Walker and (2) plans to take a shot at Nixon
Truth: Neither of these is true. The Walker shooting hoxed up by Katzenbach and then Marina pressured to confirm the story. The same was true with the alleged planned assault on Nixon. (This was concocted by Marina and Martin her lover at the time. Possibility of making \$\$\$\$.
Point here: Even Hoover and Rankin did not but the "Nixon business."

I say a word about the Walker shooting. There is a little in BOT (10 pages) that lays out the lie about Oswald gunning for the general.

2. Brennen testimony. . . .completely bogus. This is the best the WC could do placing Oswald in the frame. It was ludicrous. Recall, for example, I mentioned earlier that the FBI and the Naval Photographic Center examined the Bronson shots of the 6th Floor SE corner of the TSBD in December 1963 and found out that his 90 plus exposures of that window minutes before the shooting revealed no one at the window. Oswald was not on the 6th floor at the time of the shooting.
3. Dallas Police Captain Day lifts Oswald's palm print of C1 (or the Mannlicher/Carcano). . . .so the story goes. This is after FBI print man Latona failed to find a single Oswald print of the alleged murder weapon.
4. Oswald's interrogation sessions. There were at least 4. . .On 11/22 he was interrogated over and over for about 12 hours alone. Point: We are told that (Capt. Fritz who was a cop since 1930s) the Dallas PD had no tape recorder or any other means to capture Oswald's responses. This is the alleged assassin of the President (not some drug pusher or con artist) and there is no record of what he said in these sessions. Moreover, these four sessions over the 22-24th were attended by FBI and SS agents

5. (daaaaah/these are allegedly the best and brightest in protecting the president and dealing with national crime). What are we children? Babes in the woods. Where were the adults. Where was the Main Stream Media. Why didn't raise hell and insist this was not acceptable.
6. The official argument is that Oswald was from the get go a suspect in the shooting because he was the only one of the staff of workers and bosses at the TSBD who was missing when the police set up interviews of the 70 some folks who were in the building at the time of the shooting.

This was plain horse hockey. . . .Oswald was one of 30 or more people who left the building without reporting to any authorities because the police were slow in setting up any semblance of review and questioning. Many just left for home in a state of shock . . . (If you want any source for this let me know).
