Let's be honest and admit there are serious problems with the 9/11 Commission's report and it hardly brings us closer to some clarification of these troublesome areas by lashing out at citizens who insist on considering all the evidence with a fresh and open mind.

A working axiom here is that history is not all about conspiracies but we have to allow that conspiracies do occur in history. The official explanation was that the FAA notified the military about the troubles being experienced by all four airliners but not in time. No one was ever punished for this failure.
