I had taken for granted that Manchester was incorrect in identifying you (as he was incorrect on an appalling number of ascertainable and unambiguous facts) and I am reassured, for the reasons you yourself state, that it was a valid assumption.

... Since you have indicated your interest in Allman's account of the incident to which Manchester referred, I am enclosing a copy of the relevant Secret Service report (Warren Commission Document No. 354, The National Archives, Washington, D.C.).

My sole interest is the determination of the facts and the truth about the assassination—a task which seems to me to demand the most scrupulous and painstaking effort of impartial and disinterested persons. If you do not feel able to make your notes available, I will understand, of course, that there are good reasons for your decision.
