I made some notes re this for another researcher which I might as well share with the rest. Here are some of the reasons I don't believe this document is genuine.

- 1. It's on letterhead used primarily by the FBI. I don't recall ever seeing a CIA document on that letterhead before.
- 2. Information of this nature would be classified a LOT higher than "confidential."
- 3. That particular CONFIDENTIAL reversed stamp is one I've never seen on a JFK document.
- 4. McCone was not in the loop of who Oswald was. It strains credulity that he would know what was there. Helms and Angleton purposely kept McCone in the dark about a lot of their activities.
- 5. The date on the file at NARA is 1978. The date is usually the date of the actual document. This leads me to believe either the document was created in 1978 or planted after the fact, in 1978, to be 'found' and used to discredit those who would say Oswald was a member of the CIA. The RIF for this document indicates there were two pages. Where is the first page?

FYI, there's a precedent for document planting. In the RFK case, a photo comparison was made, ostensibly of a bullet found in the body of RFK and a bullet found in the body of another person wounded in the room that night. A rather sinister memo discusses this photo, and that its existence should be kept secret unless conspiracy buffs managed to get the case reopened. Then it should be used to refute the buffs. What the memo didn't say, that Lynn Mangan discovered later, was that the photo, Special Exhibit 10, was really a test bullet to test bullet comparison. So a lie was planted and surfaced as needed, when a panel was convened to retest the evidence in the 1970s. The panel was convinced that the two bullets came from the same gun and had no reason to believe the bullets were other than as identified. (It came out later that the bullets used did not have the right markings to be the Kennedy and victim bullets.)
