1. Rosen to DeLoach, 10/7/1966 62-109060-4235
Here the FBI still holding to fiction that the wound in JFK's neck was a wound of exit. . . .not entrance as determined by Parkland drs. Point here: FBI fiction was that the Kennedys specifically requested that the autopsy report not be released. Hal notes this was never the case. Critical: Hoover straightens this out: He notes that Kennedys never asked us to withhold and if they had we would have disregarded it."

5. Rosen to Belmont, 11/26/'63 62-109060-426 Notes that at this time not recommended that FBI request the autopsy photos or the X-rays of the JFK autopsy. . .
6. Document from National Archives, RG 87, Secret Service Records, Valuable Documents Collection. . . .Signed by Robert Kennedy with no restrictions or expressed family demands that the X-rays and autopsy pixs be held out of the investigation, etc. . . *****

No mention of the Berkley death certificate which has JFK hit from the front (neck) and at the level in the back of the third thoracic vertebrae.

Rosen to Belmont 11/26/'63, 62-109060-426 Note that FBI not ask for the X-rays and autopsy pixs at this time. . .(while it was preparing CD-1 which was the basis for the FBI conclusion about the assassination . . . In short, don't bother the Bureau with the facts (facts laid out by Dr. Berkley). .

10. Rosen to Belmont 12/17/'63 62-109060-20 Rankin noted that the WC was interested in both the Bethesda and Parkland Hosp. Notes that report from Parkland was readily available but not from Bethesda hosp. . . .because the Kennedy family "indicated a desire that the report be kept confidential." The big lie. . See p. 2 where Belmont notes that WC should be discouraged to go forward with w/its own investigative staff. . . .
