NOTES THAT LAWSON 35-YEAR-OLD SS MEMBER DID THE advance planning alone from 11/13 to 11/18 when he was joined by GRANT, WHO WAS ARRIVING FROM ADVANCE WORK ON JFK'S FLORIDA TRIP. GRANT'S NAME AGAIN. . . . HE HAD TO BE AWARE OF THE TAMPICO THREAT. . . . DOES ANY OF THIS MAKE ANY IMPACT OF THE SS?????????
THE MOTORCADE ROUTE WAS THE WORK OF SORRELS AND LAWSON WITH THE DALLAS POLICE. . . . IT WAS THE ROUTE THAT BEST SATISFIED THE 45 MINUTE MOTORCADE TO ALLOW JFK AND JACKIE THE MAXIMUM EXPOSURE

6. ROSEN TO BELMONT 12/12/1963 62-109060-1970 HE NOTES THAT BOUCK THAT JFK REFUSED THE BUBBLE-TOP IN TEXAS, , , AND THAT KENNEDY ORDERED NO SS MEN ON THE BACK OF THE LIMO. . . . AND THAT NONE BE NEAR "THE CAR DURING THE MOTORCADE." CAN THIS BE TRUE. . . . I NEED TO FIND ACCOUNTS THAT REFUTE THIS. . . . WAS THIS LAID DOWN BY JFK FOR THE ENTIRE TEXAS TRIP OR JUST DALLAS??????
