Importance of above is that Hoover closed down the investigation except for Oswald on 11/23... Waits until 12/1 to talk to Milteet despite the Somersett tape.

 - 8. Copy of a S.B. Stoner letter May 23, 1962 where he identifies Somersett as an FBI "pimp" source Didn't this info ever get to Milteer????? No source for this letter. Must be in Hal's SI.
 - Piece in Phila Inquier 11/23/1994 Cites date of the Somersett tape as 11/5/1963.
 Also a Lt. Everett Kay of Miami PD said he rushed the tape to the FBI but the info never disclosed in the WCR.
 - 10. Bill Barry piece in Miami paper with partial section of the taped recording. Contains a little useful information about the cite and situation of the recording.
 - 11. Some mention of Milteer in his review of "Ultimate Sacrifice" on pp. 12-13
 - 12. SAC, Atlanta, to Director 11/26/1963 62-109060-1292 Has some colorful descriptions of Milteer's physical build and his age in 1963 (he was 61 years old)
