FLOW NOTES FROM KILLEN'S PAPER:

CHAIN OF CUSTODY OF THE PARAFFIN CASTS
DPD OFFICERS DELIVERED TO ANDERSON THE CASTS AT 11:05 A.M. CST
(P. 3/ NOTE 3) BOTH DPD OFFICERS B.G. BROWN AND CAPT. G.M. DOUGHTY.
BROWN NEVER CALLED TO WC TESTIFY; DOUGHTY WAS BUT ON THE
MATTER OF THE CASTS.

THE CASTS WERE MADE OFF OSWALD AT 9:00 P.M. 11/22 SOME ???? HOURS
AFTER HE WAS ARRESTED. . . ***** THAT IS A POINT THAT COULD BE
EXPANDED UPON. WHEN WAS OSWALD ARRESTED? AT LEAST 7 HRS.
BEFORE CASTS WERE MADE.

CASTS RECEIPTED IN BY ANDERSON AT 11:05 A.M. 11/23 (P. 5/NOTE
ATTACHED)

P. 6 HK NOTES THE OFFICIAL DCCIL DOC. WITH THE RESULTS WITH THE
NOTATION "SPECIMEN DISCARDED."

P. 7 HE HAS 2 DOCUMENTS THAT REFUTE THE "DISCARDED" STATE OF
CASTS AND INSTEAD BOTH OF THESE HOLDING THE DATES 1966 CONTEND
THAT THE CASTS WERE TURNED OVER TO FBI AGENT RAY HALL.

HALL WAS A WC WITNESS. CHECK OUT. CAN BE CERTAIN NOTHING HE
SAID HAD ANYTHING TO DO W/ CLARIFICATION OF THE LINES OF
POSSESSION OF THE OSWALD CASTS.

ALSO SEE DOC. 1 IN THIS FILE WHICH CLAIMS THAT ANDERSON DID NOT
DESTROY THE CASTS BUT BROUGHT THEM HOME. THIS ACCORDING TO
FBI REPORT. NOTHING CONFIRMATORY BY ANDERSON. HE WAS NEVER
CALLED AS WC WITNESS.

MY POINT: FBI ALLEGED LACK OF CONFIDENCE IN PARAFFIN TESTING. SE
DOCUMENT IN "PARAFFIN TEST" FILE (#17 BD); FBI SLOPPINESS OR
INDIFFERENCE IN COLLECTING ALL THE EVIDENCE OF PRIME VALUE: JFK
AUTOPSY REPORT/CONNALLY'S CLOTHES, ETC. . . . SPEED TO BUILD CASE
AGAINST OSWALD.

P. 8 HK PROVIDES ARGUMENT FOR SKEPTICISM ABOUT THESE 3 YEAR-
LATER EXPLANATIONS. HE RAISES SOME STRONG OBJECTIONS TO
OFFICIAL ACCOUNT. IN SHORT, FBI BELATTED EFFORT TO COVERUP
FAILURE TO TAKE CHARGE OF THE CASTS.

P. 9 HK MAKES STRONG CASE AGAINST THE STORY THAT HALL RECEIVED
THE CASTS FROM LT. DAY OR ANY BODY ELSE.

P. 10 RAISES POINT THAT THERE WAS NO UNDUE URGENCY ON PART OF
THE FBI TO GET RESULTS OF THE PARAFFIN TEST. IT WAS 14 HOURS AFTER
THE CASTS WERE MADE BEFORE THEY WERE HANDED OVER TO THE
DCCIL. THIS IN FACE OF EVIDENCE THAT THE FBI COLLECTED ALL THAT
THE DPD HAD ON EVENING OF 11/22 AND BACK TO FBIHQ BY FOLLOWING
MORNING.

P. 11 HK NOTES THAT THE TIME FROM WHEN OSWALD WAS IN LOCKUP
AND WHEN THE CASTS WERE MADE ---ABOUT 7 HRS---OSWALD HAD
OPPORTUNITY TO GO TO BATHROOM AND WASH HANDS AND FACE. . .OR
WAS IN CELL WITH A SINK?

PP. 12, 13, 14 DEALS WITH CURRY IMPROPTU NEWS CONFERENCES IN
MORNING OF 11/23. . . 10:00 A.M. AND 10:35 A.M. CURRY TALKS ABOUT THE
RESULTS OF THE DCCIL PARAFFIN TEST. HOW POSSIBLE WHEN THE LAB
DID NOT RECEIVE THE CASTS UNTIL 11:05???????? DO I HAVE ANY NEWS
STORIES ON THIS ??????? CHECK WITH WHITE FILES.

SEE P. 18 FOR WC EXHIBIT CITES FOR CURRY'S THREE STATEMENTS TO
PRESS ON 11/23. THE EARLY MORNING SESSION IS CE 2146 WHERE HE
COMMENTS ON THE RESULTS OF THE PARAFFIN TESTS.

P. 21 HK DRAWS IN GUINN AND HOW I USED HIM IN BOT P. 208. I FOCUSED
ON THE "BLOWBACK" OF A M/C . . . BUT HK REMINDS ME OF THE
RELUCTANCE OF THE FBI TO BRING THE WC INTO THE PICTURE ON NAA
TESTING. . . AND THAT GUINN WANTED TO MAKE COMPARISONS WITH FBI
TESTING OF THE "ORIGINAL" PARAFFIN CASTS . . . I NEED TO LOCATE THIS
CORRESPONDENCE. . . .

P. 22 HK SPECULATES ON GUINN'S REFERENCE TO 2.5 HOURS (WHICH WAS
THE TIME INTERVAL FROM THE SHOOTING OF JFK TO TIPPIT'S KILLING).
GUINN IS SAYING THAT EVEN AFTER 2.5 HR INTERVAL THAT NAA TESTING
WAS UNDERTAKEN OF OSWALD. . . EVEN IF HE HAD TAKEN TIME TO WASH
HIS HANDS AND FACE. . . BUT THEN THERE WAS THE "DISCARDED" ON
THE REPORT.

P. 24HK NAILS DOWN THE ARGUMENT; HE CITES DAY'S WC
TESTIMONY/BELIN. WHEN HE SAYS THE FBI DID COME TO THE DPD AND
WANTED PARAFFIN, NOT PARAFFIN CASTS BUT PARAFFIN AND THE CAN

IN WHICH THE CASTS WERE MADE. ***** THAT'S TELLTALE. .NOTES THAT BELIN DROPPED THIS LINE OF QUESTIONING IMMEDIATELY. . . DID NOT SHOW ANY CURIOSITY IN A FOLLOW UP QUESTIONS.

THE FBI DID NOT GO TO THE DCCCIL LAB BUT TO THE DPD WHERE THE CASTS WERE MADE. TO WHAT END: P. 25 HK MAKES AN ASSERTION THAT APPEARS REASONABLE---THE FBI USED THE PARAFFIN FROM THE SAME CAN TO MAKE CASTS AND THESE ARE THE CASTS THAT WERE TURNED OVER TO THE AEC FOR NAA TESTING. . . THIS WOULD BE NOT INCONSISTENT WITH THE SLOPPINESS ONE HAND WITH THE FBI'S TREATMENT OF CRITICAL FORENSIC EVIDENCE BY IGNORING IT (JFK'S AUTOPSY; CONNALLY'S CLOTHES; THE TEAGUE CURBSTONE, ETC).

STILL THE SUSPICION ABOUT THE DAY LITED PALM PRINT. . . .

PP. 26-29 HK SPECULATES ON FBI GOING TO THE FUNERAL HOME TO MAKE PARAFFIN CASTS OF THE DEAD OSWALD. . . . TELLING THE FUNERAL HOME OPERATOR THAT THEY WERE THERE FOR FINGER PRINTS. HK HAS CITATIONS FOR THIS. . . SPECULATES THAT GALLAGHER DID SPECTRO ON THESE AFTER-DEATH CASTS (NO KNOWING THEY WERE MADE AFTER ORIGINALS WERE DISCARDED) THAT THE NITRATE LEVELS WERE MUCH HIGHER THAN ON OSWALD'S HANDS BECAUSE OF THE COSMETICS APPLIED TO THE CORPSE. . . THEREFORE THEY WERE TOO ANAMOLOUS TO USE. . . . ETC.

HE NOTES ON P. 29 THAT DRAIN GAVE INTERVIEW TO HENRY HURT AND COULD NOT EXPLAIN WHY FBI WANTED A SEPARATE SET OF PRINTS. MREASONABLE DOUBT, P. 107. SAME PUZZLEMENT ON THE PART OF DAY ABOUT WHY THE FBI WANTED THE CAN AND THE LEFTOVER PARAFFIN FROM THE FBI. . . . SEE HIS TESTIMONY TO BELIN. . . .
