DALLAS POLICE CHIEF JESSE CURRY'S WC TESTIMONY (4H 194/5) CONFIRMS THAT THERE WERE AT LEAST 400 ITEMS IN THE EVIDENCE PACKAGE THAT DRAIN TOOK WITH HIM AT 3:00 A.M. ON 11/23 TO WDC.

CURRY NOTED THAT DALLAS WAS GETTING FREQUENT CALLS THAT EVENINMG FROM "SOMEONE IN HIGH AUTHORITY" IN WASHINGTON THAT EVENING ABOUT WHEN THE EVIDENCE WOULD BE READY TO SEND. WHO: NO NAMES JUST SOMEONE HIGH UP IN THE ADMINISTRATION AND THEY WANTED THE EVIDENCED UP THERE ASAP.

BEST QUESS THAT THE CALLS FROM CLIFF CARTER, LBJ'S RIGHT-HAND MAN WHO TOOK CARE OF HIS DALLAS OFFICE. CARTER LEFT DALLAS ON AIRFORCE ONE WITH JOHNSON FOR WDC AFTER THE ASSASSINATION.

CURRY'S COMMISSION TESTIMONY—REVEALED, TO PUT IT MILDLY, THE FBI'S DISREGARD FOR THE NICETIES OF EVIDENCE COLLECTION. . .

CURRY TOLD DULLES THAT THE DALLAS POLICE TURNED EVERYTHING OVER TO THE FBI WITHOUT MAKING A WRITTEN INVENTORY. THYERE WAS NO TIME BECAUSE OF THE PRESSURE FROM WASHINGTON TO GET THE EVIDENCE TO WDC AS SOON AS POSSIBLE.

IN HIS EXCHANGE WITH DULLES CURRY NOTED THAT ALL THE EVIDENCE WAS TURNED OVER TO THE FBI WITH THE PROMISE THAT IT WOULD BE RETURNED.

DULLES ASKED IN THE PERTINENT FOLLOW UP QUESTION: WAS THE EVIDENCE ACCOMPANIED BY A MEMBER OF THE DALLAS POLICE DEPARTMENT. (PARENTHETICALLY: DRAIN WAS ACCOMPANIED BACK TO WDC BY SECRET SERVICE AGENT LAWSON).

CURRY'S ANSWER WAS IN EFFECT: NO. NO AGENT OF THE DALLAS POLICE FORCE ACCOMPANIED AGENT DRAIN TO WDC.

IT WAS CLEAR TO DULLES THAT THE LINE OF POSSESSION WAS BREACHED. HE TERMINATED THE EXCHANGE WITH CURRY AND THE RECORD INDICATES THAT THE COMMISSION BROKE FOR LUNCH.

WHEN THEY RETURNED THE TOPIC SHIFTED TO AN ENTIRELY DIFFERENT SUBJECT.
