MAKE CLEAR THAT WC MEMBERS DID NOT GET THEIR COPIES OF CD 1 UNTIL DECEMBER 9. HOOVER WAS SENDING A CLEAR MESSAGE BY LEAKING BEFORE THE WC MEMBERS GOT THEIR COPIES. . . . NO OTHER SOURCE FOR THE LEAKS EXCEPT THE FBI (DELAOCH AND THE CRIME RECORDS DIVISION).

WC UPSET ABOUT LEAKS. . . . COULD MENTION RUSSELL'S REMARKS TO KATZENBACH ON 12/5 WC SESSION.

WARREN CALLS DC-1 "SKELETAL" AND DURING THE 12/16 WC SESSION WARREWN SAYS THAT THERE WAS NOTHING IN THE FB I REPORT THAT HASN'T ALREADY BEEN LEAKED TO THE PUBLIC.

WARREN CALLS DC-1 "SKELETAL" AND DURING THE 12/16 WC SESSION WARREWN SAYS THAT THERE WAS NOTHING IN THE FB I REPORT THAT HASN'T ALREADY BEEN LEAKED TO THE PUBLIC.

CHAPTER 1 OF THE REPORT IS THE SHORTEST CHAPTER IN THE 900 PAGE REPORT. IN THIS 27 PAGE CHAPTER THE WC LAYS OUT THE EVENTS OF 11/22 AND THE COMMISSION'S CONCLUSION. IT IS THE SHORTAGE CHAPTER IN THE REPORT. THE CHAPTER DOES NOT INCLUDE ANY OF THE EVIDENCE THAT ALLEGEDLY SUPPORTS THE CONCLUSIONS. ACTUALLY THE SAME COULD BE SAID ABOUT THE 900-PAGE REPORT ITSELF. IT WAS NOT UNTIL 2 MONTHS AFTER THE REPORT APPEARED THAT THE SUPPORTING EVIDENCE APPEARED.

MENTION RANKIN COMMENTS AND MCCLOY COMMENTS DURING THE APRIL 30 TH SESSION. THAT OSWALD DID IT AND NO OTHERS INVOLVED. THIS WAS BEFORE THE COMMISSION HEARD A MAJORITY OF ITS WITNEESSES. ZAPRUDER NOT CALLED UNTIL (WAS IT JUNE). HOW ABOUT PHIL WILLIS.? CHECK ON HIM IN WWI OR HAL'S PHOTOGRAPHIC WW.

INSTANCES OF DIRTY WRITING. SEE MCCLOY'S ALLEGED COMPROMISE IN CHAPTER 1, P. 19

IMBECILIC CONTRADICTIONS: WC'S THREE SHOTS AND TWO HITS; FBI (AND SS) THREE SHOTS AND THREE HITS....NO RECONCILIATION OF THE TWO VERSIONS WAS POSSIBLE.
