Re: source is Master Copy List. The choices are selected for "Breach" Introduction.

11/22 Police call has shooting at 12:35 CST (Gemberling report 105-82555-21.

11/22 Plane carrying Cabinet members to Japan learned at 12:45 P.M. <sup>CST</sup> EST that "three shots were fired at President Kennedy's motorcade in Downtown Dallas." Holland, p. ? check if used. .

11/22/'63 Tippit shooting reported at 1:18 CST(Oswald named w/ this crime and killing of JFK at 1:40 P.M. CST. And wounding of Connally.

11/22/'63 Dallas PD arrest report notes at time 1:40 p.m. CST that Oswald is being held for shooting Tippit, Gov. Connally and killing President Kennedy. JFK Dallas Police Department Collection, Records of the City of Dallas Municipal Archives, Witness Statements. Arresting officers McDonald, K.E. Lyons, P.L. Bentley (source: Super Key Docs, Box BB. POINT: OSWALD IN FRAME LESS THAN ONE HOUR AFTER THE SHOOTING. . . .BASED ON WHAT EVIDENCE.

Fritz notes that after "reviewing the evidence" on 11/22 w/ Wade, Alexander, and Jim Allen, a former prosecutor, Fritz at 11:26 P.M. files a complaint that Oswald had killed JFK. What evidence? At this point all the evidence had been shipped to FBI WDC by Drain. Source: F. 13.doc. # 1 in Oswald as Sole Suspect. (Check)

For example, Hoover all points bulletin to round up all suspects, etc on 11/22-11/23

11/22/'63 Hoover to all offices 62-109060-6 at 2:16 EST ( 1:16 CST) "Get everyone involved in the shooting and get them fast."

11/22/'63 Belmont to Tolson 62-109060-99 (sect. 2), p. 2 where Shanklin announces that at 2:55 that police have shooter in Tippit case and believe he also the assassin in the JFK murder. . . Point: it's the Dallas PD and authorities who are pushing Oswald as the single shooter. . .Shortly after Oswald was in City jail a little after 2:15 CST his pix was sent to all TV stations and newspapers that subscribed to the AP Press in the USA. . .(source: SAC, Dallas to Director).

11/22/'63 Belmont to Tolson, 62-109060-99(S.2) Notes that DPD has Oswald as the shooter. . . .Shanklin called him at 2:55 P.M. (EST) or 1:55 CST that Oswald shot Tippit and "he may have killed the President." ✓

11/22/'63 Belmont to Tolson (62-109060-1431) Time of memo was 8:18 P.M. Notes that LBJ wants Hoover to solve the case.\*\*\* That was already established earlier. . . (The case now was in play: Oswald was the guilty party according to the Dallas authorities on the scene. . .

11/22 Oswald charged with Tippit murder at 6:00 P.M. (CST). Formally charged with killing JFK early hours of 11/23

11/23 ASAC Sylvester to SAC, New Orleans, (989-69-29) This is the Main New Orleans Oswald File. . . .called off the drag net. Focus totally on Oswald w/ JFK murder and murder of Tippit. \*\*\*\*\*

The point here is that LBJ assigned the case to Hoover on AF-1 and Hoover "inherited" the solution to the case by the Dallas authorities. . .Oswald acted alone. . .(case closed).
