HE GETS INTO THE MAGIC BULLET BUSINESS. WECHT IS WRONG ON SOME OF THE DETAILS. . . I THINK THE DRS KNEW OF THE THROAT WOUND THAT EVENING. . .

HE NOTES THAT CE399 LOST ONLY 1.5 % OF ITS WEIGHT DESPITE ALL THE DAMAGE IT INFLICTED ON THE TWO MEN, ESPECIALLY CONNALLY. HE MENTIONS THE TESTS RUN AT EDGEWOOD ARSENAL. ✓

P. 231 LOCATION OF THE KENNEDY BACK WOUND CANNOT LINE UP WITH THE NECK. . .

P. 232 KENNEDY'S HEAD MOVEMENT WHEN STRUCK AT Z 313 WAS VIOLENTLY BACKWARD. TISSUE AND BLOOD ON THE DALLAS BIKE JOCKEYS RIDING TO THE REAR OF THE LIMO.

P, 232 WECHT MAKES INTERESTING POINT: THE BETHESDA DRS PLACE THE HEAD WOUND AT ABOUT THE OCCIPITAL PROTUBERANCE. SUGGESTING A FLATER TANGENT FOR A BULLET FROM THE REAR. BUT THE RAMSEY CLARK PANEL HAS THE WOUND FOUR INCHES HIGHER. THIS TRAJECTORY POINTS DEFINITELY TO MEET THE NEEDS OF A BULLET COMING FROM THE 6TH FLOOR OF THE TSBD. WECHT SIDES WITH THE BETHESDA DRS. 233. THEY SAIS THE BRAIN MATERIAL WAS CEREBELLAR. . .WHICH IS LOCATED AT THE BASE OF THE BRAIN SUGGESTING THE LOCATION OF THE REAR SHOT WAS AS STATED BY THE BETHESDA DRS.

P. 235 MENTIONS THE FRAGS STILL IN CONNALLY'S BODY/MORE THAN LOST IN THE MAGIC BULLET. ✓

KEY MEDICAL EVIDENCE THAT WENT MISSING: CHECK THIS AGAINST MY FILES. ✓

MISSING WERE JFK'S BRAIN. SOME X-RAYS OF HIS CHEST. AND MICROSCOPIC TISSUE SLIDES. (THESE COULD DETERMINE WHETHER THE WOUNDS WERE EXIT OR ENTRANCE. PP. 235/6
