THORNLEY STATED ONLY KNOWLEDGE OF OSWALD SINCE NINETEEN FIFTY NINE WAS THROUGH NEWS MEDIA. HE STATED HE HAD MADE A DRAFT OF A BOOK CONCERNING A MEMBER OF THE ARMED FORCES WHO HAD GONE TO RUSSIA AFTER BEING DISCHARGED AND LATER RETURNED TO UNITED STATES. HE STATED THAT HE DID NOT HAVE OSWALD IN MIND WHEN HE STARTED DRAFT OF HIS BOOK, BUT THAT IN VIEW OF RECENT ACTIVITIES OF OSWALD HE WAS THINKING ABOUT USING OSWALDS BACKGROUND AS THE CENTRAL THEME OF THIS BOOK.

THORNLEY STATED HE LEFT NEW ORLEANS, LA., MAY ONE LAST BY TRAILWAYS BUS, PROCEEDED TO WHITTIER, CALIFORNIA WHERE HE VISITED HIS PARENTS FOR SHORT PERIOD. HE THEN PROCEEDED BY BUS TO TIJUANA, MEXICO AND MEXICO CITY, WHERE HE STAYED FOR SHORT PERIOD OF TIME. HE RETURNED TO UNITED STATES BY BUS THROUGH MATAMOROS, MEXICO AND ARRIVED IN NEW ORLEANS ON AUGUST ONE LAST. THORNLEY STATED MADE TRIP ALONE AND EMPHATICALLY DENIED THAT OSWALD ACCOMPANIED HIM FROM NEW ORLEANS TO CALIFORNIA OR FROM CALIFORNIA TO MEXICO.
