Shooting of President Kennedy  
November 22, 1963  
December 3, 1963

Mr. J. E. Gurny

Sir:

The following was recorded on channel two, from 10AM to 5PM. This report includes information prior to the arrival of the President's plane, progress of the motorcade, the shooting, and the escort to Parkland Hospital. Also included are events concerning the shooting of officer Tippit.

10:25AM 30-531 Crowd estimate: 500. Weather: clearing  
11AM 21 and 32 dispatched to old terminal building to west  
23 for assignment. Crowd estimate 1200.  
11:20AM 531-30 When you receive information from the tower on that  
plane, notify 531.  
11:26AM 5-39 They changed landing directions on us, did you notice. ✓  
30-4  
11:30AM 4-30 Yes, sir.  
We will have to set up on Mockingbird.  
11:28AM 30-532 Air Force One is airborne.  
11:30AM 9-2 Talking about man power on Main.  
50-531 Air Force One turning on final approach.  
20-21,32 Cut your traffic, 21 and 32 10-4  
2-9 Talking about man power on Main  
531-2 Air Force One on final approach now  
30-531 One plane down, second coming in, Air Force One right  
behind.  
11:34AM 2-9 Talking about man power.  
531-30 Is Air Force One down yet?  
30-531 No, just coming in.  
5-531 One is on the ground.  
531-21,32 All clear.  
11:35AM 30-531 Air Force One not on the ground yet.  
531-21,32 Return on your assignments.  
540-531 He is crossing down town Dallas now.  
11:37AM 30-531 Air Force One is on the ground.  
531-21,32 Return to service.  
11:39AM 531-30 Weather and crowd estimate  
30-531 Good and approximately 2,000  
20-531 Quite a crowd at Lemmon and Mockingbird near the  
Coca Cola plant.  
250-125 Talking about re-assignment of officer to Lemmon and  
Hartshel.

11:45AM 531 Station Brook  
5-1 Just checking communications, I'm at the front gate now.  
1-5 Local and client.  
280-9 Hwy 56 is completely blocked with pedestrians. Completely cut off of control.  
9-280 I've got two reserves I'm bringing down now.  
280-9 I have three or four three wheelers and I can't get the people off Hwy, it's completely closed.  
9-280 10-4 I'm on my way.  
15-2-531 Progress report.  
531-15-2 Stand by a few minutes.  
531-5 Are they moving yet?  
5-531 No.  
531-15-2 Have not started yet.  
1-5 Moving out very slow.  
11:50AM 5-1 Lot of traffic up there around Mockingbird, might send a motorcycle out over to one side.  
1 Escort motor send two men to Mockingbird and Cedar Springs to help clear traffic.  
5-1 About what's the location now.  
1-5 Just made the turn out of the field on to Cedar Springs traveling 15MPH at this time.  
531-15-2 Are you reading all right?  
15-2-531 No.  
531-15-2 Leaving the field on Cedar Springs at 15MPH.  
5-1 Might need a motor at Manor Way and Lemmon. Quite a few people on Lemmon on both sides of the street, curb, and median strip.  
5-1 Location now  
1-5 Mirrorm and Mockingbird  
531-9 Mirrorm and Mockingbird traveling 15MPH.  
12:00 1-531 Approaching Inwood Rd. on Lemmon Avenue traveling about 12 to 15MPH.  
531-15-2 Given information on location.  
12:01PM 15-2-531 Three request information if ambulances are standing by.  
531-15-2 601 is standing by at Love Field, as soon as he completes that assignment, he is going to your location, also a transfer ambulance will be at that location.  
1 To motorcycles leading, drop back closer, hold up so about fifty feet ahead of us, about fifty feet ahead of us. OK, go ahead.  
531-15-2 601 is enroute to your location.  
5-1 Location  
1-5 Approaching Cotton Belt underpass near Noma Alta.  
12:05PM 531-15-2 Given location Cotton Belt and Noma Alta.  
1 Escort three or four miles faster. Pull those cars off the street. Cut traffic at Oak Lawn.  
5-1 Pretty good crowd of people on Turtle Creek, down to two lanes of traffic.  
1-5 10-4 Got a good motorcycle escort, got the traffic off of it.  
531-1 Are you nearing Oak Lawn?  
1-531 We are a block away at Knight Street.  
531-15-2 Lemmon nearing Oak Lawn.  
1 Escort drop down cut traffic at Turtle Creek.

1-531 Crossing Oak Lawn.  
531-1 10-4  
15-2-531 Advise three the ambulances have arrived and are standing by.

12:11PM 1-531 Turning on Turtle Creek from Lemon 12MPH.  
5-190 Location  
190-5 Just crossing Cedar Springs.  
531-1 Location  
1-531 Next underpass at Turtle Creek.  
15-2-531 10-4  
1 Escort three or four miles per hour faster. Lets try it.  
Station Break  
531-9 On Cedar Springs off Turtle Creek.  
1-531 Cedar Springs and Fairmount  
12:16PM 139-531 For information, cars are lined on both sides of Stemmons on the shoulders from Commerce to Oak Lane.  
5-1 A good pedestrian crowd Ross and Harwood  
2-1 Everything in good shape out here at Market Hall. Traffic moving well, not any crowd on the side of the street, good crowd along the sides of the barricades.  
531-1 Given information about Stemmons.  
1-531 Now at Harwood and McKinney.  
15-2-531 Advice keep crowd over about Harwood to Ross, they are getting out in the street here.  
1-5 We've got them.  
Ross and Harwood.  
5-1 Crowd on Main Street in real good shape. Got them all back on the curb.  
1-5 Good shape, about to cross Live Oak.  
12:22PM 1 Escort drop back, go real slow speed now approaching Main.  
531-15-2 You reading?  
15-2-531 10-4  
1 Hold up escort. Oh, move along.  
1-531 Check to see if we've got everything in top check with the rear car.  
531-2 Who is in the rear car?  
158-531 Advise everything is OK.  
1-531 Where is 158?  
158 Just crossing Erway Street.  
531-1 Location now.  
1-531 Field  
12:26PM 1-531 Crossing Lamar Street now  
531-1 Is there in a pretty crowd? *Good*  
1-531 ~~15-2-531~~ Big crowd, yes.  
5-531 Notify Captain Souter the location of the convoy now.  
531-15-2 On Main probably just past Lamar.  
1-531 Just crossing Market Street.  
4-125 Talking about the traffic at Love Field.  
1-531 Hearing triple under pass  
12:30PM Station Break  
1 Go to the hospital, officers, Parkland Hospital, have them stand by. Get men on top of the under pass, see what happened up there, go up to the over pass. Have Parkland stand by.

Dallas-1 I'm sure it's going to take some time to get your men in there. Put everyone of my men there.  
531-1 Report One, I didn't quite understand all of it.  
1-531 Notify station five to move all men available out of my department back into the railroad yards and try to determine what happened and hold everything secure until Homicide and other investigators can get in there.

12:31PM 531-1 Any information whatsoever?  
1-531 It looks like the President has been hit, have Parkland stand by.  
531-1 Parkland has been notified.  
4-531 We have K-9 units in that vicinity, don't we?  
1 Straight to Parkland.  
5-1 What disposition do you want me to make with these men I have with me?  
1-5 Just go on to Parkland Hospital with me.  
1 Get out of the way, something about trucks, hold everything, get on the way (KBB's Record not too clear)  
531-15-2 There is a motorcycle officer on Stemmons with his mike stuck open on channel one, could you send somebody up there and tell him to shut it off.  
12:34PM 190-531 You want me to still hold traffic on Stemmons until we find out something?  
1 Keep everything out of the Emergency Entrance.  
136-531 A passer-by states the shots came from the Texas School Book Depository Building  
1 Get everything out of the way.  
531-136 Get all the information.  
142-531 I talked to a guy at the scene who says the shots were fired from the Texas School Book Depository Building with the Hertz Rent A Sign on top.  
531-142 Get his name, address, phone number and all information you can.  
12:35PM 15-2-531 Advice all emergency traffic to use some other route besides Industrial and have 233 cut traffic at Hines and Industrial.  
531 Broadcast same.  
12:36PM 260-531 Witness says shots came from fifth floor Texas Book Depository store at Houston and Elm. I have him with me now and we are sealing off the building.  
220-531 Where do you want traffic cut in the area.  
531-220 Keep all traffic off Industrial and the emergency entrance at Parkland.  
125-531 No have the emergency entrance secure.  
142-531 Get men to cover the building Texas School Book Depository, believe the shots came from there, facing it on Elm St. looking at the building it will be the second window from the end in the upper right hand corner.  
531-142 How many do you have there?  
142-531 One guy possibly hit by a ricochete off the concrete and another seen the President slumped.  
12:38 137-531 A witness says he saw 'em pull the weapon from the window off the second floor on the south east corner of the Depository building.

12:38PM 531-537 Do you have the building covered off  
137-531 I'm about three fourths of a block away.  
531-137 Report there.  
137-531 I'll leave the witness here.  
2-531 Can you give us any information as to what happened for  
these people out here.  
531-2 Evidently there has been a shooting with the President  
involved. I do not know the seriousness of it. One is  
at Parkland along with Dallas Cm. We have information  
the shots came from the fifth or fourth floor of the  
book Depository Store on the corner of Elm and Main.  
officers are now surrounding and searching the building.  
Where did it happen? At Main and Elm?  
12:40PM 2-531 No, sir, the triple under pass between the triple under  
531-2 pass and Stoenens. Possibly six or seven more people may  
have been shot.  
Believe the Presidents head was practically blown off. ✓  
12:40PM 303-531 What hospital did the President go to?  
531-303 Parkland Hospital. Where are you?  
303-531 300 is enroute.  
531-303 Is 300 in route to the store Elm and Houston?  
303-531 300 enroute to the Hospital.  
295-531 Disregard what I said.  
531-295 Do you know the extent of the injury?  
295-531 It's not for me to say. I can't say, disregard that remark. ✓  
531-295 Where did you get your information.  
295-531 I was at the car.  
260-531 Send me a squad for a prisoner at Elm and Houston.  
531-260 Do you have the suspect?  
260-531 No.  
15-2-531 Did they advise they have the suspect.  
531-15-2 No. They do not have the suspect.  
9-531 We need more men power down here at the Texas Book Depository  
there should be a bunch on Main if somebody can pick them up  
and bring them down here.  
250-531 I'll start down Elm and pick up as many as I can.  
190-531 I've got myself and five motorcycle officers holding traffic  
on Stoenens, do you want me to release traffic or hold it?  
531-190 Release traffic and report code three to Elm and Houston.  
15-531 Are you having them contain the block surrounding the building.  
531-15 Yes, we are sealing the building until it can be searched.  
15-531 Extend it out to include two or three block area.  
9-531 The wanted person in this is a slender white male about thirty  
five feet ten, one sixty five, carrying what looked to be a  
30-30 or some type of Winchester.  
531-9 It was a rifle?  
9-531 Yes, a rifle.  
531-9 Any clothing description?  
9-531 Current witness can't remember that.  
531 Attention all squads, description was broadcast and no further  
information at this time.  
12:45 15-531 Could nino determine whether the man was still supposed to be  
in the building or had he left?  
531-15 He didn't know for sure and the witness he had didn't have a  
description. We have the building saturated by now and we  
should know something before long.

- 9-531 From this building it is unknown if he is still there or not  
Unknown if he was there in the first place.  
531-9 All the information we have received indicates it did come  
from the fifth or fourth of that building.  
531-1 Which building?  
531-5 Texas School Book Depository Elm and Houston.  
260-531 We had an epileptic seizure just before this, send a squad  
to Parkland and get all the information they can from that  
person.
- 12:46PM 125-531 Do you have any information that the Governor was also hit?  
531-125 Not yet. I'll check in just a minute.  
15-2-531 Is One on the air?  
531-15-2 He is at Parkland.  
157-531 Did you notify DPS on the suspect?  
531-157 I haven't had time yet but will.  
15-2-531 Two civics attempt to contact station 401 at Parkland  
ccm if one can (second is not clear)  
2-531 Find out from Parkland the situation and see if the  
President will be able to appear out here. Got all these  
people out here, need to know whether to feed them or what  
to encourage out here.  
531-2 Yes, two, as soon as we can obtain that information.  
211-531 Numerous people are asking us what happened, can you give  
us any information at all?  
531-211 There was a shooting involving the President and his party  
The extent of it is not known.  
12:51PM 211-531 Was he shot or do you know?  
531-211 Understand he was involved in it, yes.  
125-531 The Governor was also shot.  
531-125 Can you obtain information from one if the president is  
going to appear at the Trade Mart.  
125-531 I'll check now.  
1-531 Very doubtful.  
2-531 Can you tell us whether or not the President will appear,  
what his condition is so that we can decide what to do  
with those people at this luncheon.  
531-2 One civics his appearance is very doubtful.  
2-531 Do you know what his condition is?  
531-2 No.  
190-531 Send rope to Elm and Houston, we're getting a tremendous  
crowd down here.  
12:54PM 531-190 What else do you need?  
190-531 Lots of rope.  
531-190 I'm going to send fire department rescue equipment with  
rope to that location.  
1FM Station Brook.  
31-531 Need a squad to go to the Community Blood Bank pick up  
some blood and bring it to Parkland ccm three.  
531-31 Have they been notified?  
31-531 10-4 People at Parkland have notified them.  
15-2-531 Two requests information as to the extent of injury to the  
President and also if the Governor was hit.  
531-2 The Governor was hit but the extent of injury is not known.

1:12PM 9-531 We have found empty rifle hulls on the fifth floor and from all indication the man had been there for some time.  
1:16PM 531 Attention all squads, for information, we have a report an officer has been involved in a shooting in the 400 block of East Tenth.  
594-280 Notify CIO we have an officer involved in a shooting at Tenth and Patton, we don't know the extent of it yet.  
1:21PM 10-531 Orders from CIO got twenty more uniform officers to the entrance of Parklan immediately.  
531-15-2 Some twenty men to Parklan dole two.  
1:28PM 531 Contacted some officer at Parklan. Notify CIO the officer involved in the shooting who we believe to be officer J. D. Tippit was LOA at Methodist.  
1:30PM-1:45PM Most conversations were routine.  
1:45PM 531 Gave a laundry tag number to Homicide which came from the jacket the suspect dropped at the scene of the shooting involving officer Tippit.  
1:54PM 531 Was advised the suspect had been apprehended in the Texas Theatre.  
1:58PM 550-531 We're bringing the prisoner straight to the City Hall.  
1:58PM-5:00PM Most conversations were routine.
