It was not until 4:30 to 5:00 P.M. before any film shot by camera appeared on WFAA. An AP photographer stated that he got a pix of Oswald being taken into City Jail about 2:10 P.M. The caption of this pix was "Gunman kills policeman-Lee H. Os wald, 24, was arrested in Dallas today for shooting a policeman, and was questioned in the murder of JFK. . .****** Key document. . \mathcal{M} 5. SAC, Dallas to Director 1/9/'64 105-82555-1354 (Sect. 64). See Fritz comment that it was about 2:15 P.M. when Oswald was brought to the Homicide Bureau....P. 2 Fritz adds that Oswald was the guy "missing from the TSBD building." Here is that manufactured story again . . and Fritz goes onto say that he "was probably the individual who shot Pres. Kennedy and wounded Governor Connally." All nicely wrapped up all part of the lynching of Oswald..

- 16. Belmont to Tolson 11/24/'63 62-109060-368 (Sect 5)... ATMOSPHERE in Dallas...notes that Police Chief Curry's wife received a threat on her life and now she and the family are quartered in Dallas police hqers...
- 17. Handley to Rosen 11/23/'63 62-109060-128 NBC news story at 8:20 p.m. had Curry referencing a pix of Oswald holding a rifle. . . . The Police Chief says that "This clinches it." When questioned further: as to whether this rifle is the one that killed JFK Curry responded "I do not know." Asked if said gun was sent to the FBI and id as the gun in the murder Curry responded I do not know."
