Eg., While the WC planned to have its Report finished by June it had not brought forward for questioning Abraham Zapruder and Phil Willis and neither were brought before the WC. Neither was deposed until July. James Altgens, the AP photographer who took the best-known professional photograph was not questioned until June... Jim Tague was not questioned by a member of the WC staff until July. . .
- Allman, Ford, and Carolyn Arnold never questioned at all (Oswald's alibi).PP 123
