

Notes w/ Oswald's Interrogations Source: Folder entitled "Interrogation of Lee Harvey Oswald."

Oswald was taped by KDLD TV, NBC TV, and KLIF TV (see transcripts in WC Vol. XXIV, p. 817, CE 2166, p. 2 while being escorted to one of his interrogation sessions Oswald's in answering newsmen's questions said he didn't shot anybody.

Note from Hal that WCR cites Oswald as a liar on at least 6 occasions R, 118, 130, 180, 182, and 185\*\*\* Check references.

Interrogation session 2:25 to 404 P.M. LHO says "I was never in Mexico City." He denied he ever owned a rifle. P. 3

6: 30 P.M. on 11/22 On way to a line up Oswald hollered to press people in the hall "I never killed anybody."

7: 10 P.M. Arraignment State of Texas vs. LHO for Murder of Officer J.D. Tippit of the Dallas Police Dept. Line up issue. Oswald was only one in line at this time without a jacket. Assume he was I his T-shirt (was he in cuffs? Not dealt w/ here) The other individuals in the lineup had jackets. Oswald wanted a jacket.

7:50 at a second lineup he was still wearing the "same old clothes" he was arrested in and he protested this. . .She notes at this time Oswald shouted out "I am only a patsy."

Third interrogation: 7:55 P/M.

8:55 Fingerprints and paraffin tests all in Fritz's office.

11:00 -11:20 P.M. He noted he was in Russia for 3 years. He gavehis stats: I am 5'9 inches, weigh 140 lbs.

11:20-11:25 Asked if he shot JFK . . ." did not shot anyone."

Saturday 11/23/'63

1:35 A.M. on 11/23 Arraigned for murder with malice of John F. Kenendy.2:15 P.M. a new line up and Oswald still only had on a t-shirt while the others were "dressed differently. This is unfair."

6:00-6:30 P.M. interrogation, Fritz's office . . . .Oswald denies that he is the one on the back yard holding the rifle. . .His head was super imposed on someone else's body. It is his face but not his body. . . Oswald knows photography and will prove this so-called evidence as a phony. . .

Sunday 11/24

9:30-11:15 A.M. Oswald was man in the doorway when Ford and Allman came rushing into the TSBD looking for a phone. Much discussed business about the map he used to locate possible job sites. . .(Ruth Paine later acknowledged she marked out the sites on a map for him . . He denied shooting Tippit and JFK ..
