1. As stated in old sheet (look at 89-43 files in 6 boxes for LHO in New Orleans w/ emphasis on anti-Castro activities w/ Dallas PD. .
2. List of LHO's activities 89-43 files pertinent to LHO's New Orleans activities
3. As stated in Original Data Sheet (Belmont exonerates Oswald as shooter)
4. Kelly 2piece on railroading of Terri Pike.
5. Meagher piece as stated What Lovelady was wearing on 11/22/'63 ✓
6. Key notes by Meager on Oswald's interrogations 11/22-11/24 ✓
7. This is my original doc. # 3 citing Wrone's book pp. 171-172 where he cited Hal's ERDA suit which showed all FBI shooters of K1 experience significant blowback & positive paraffin test results. . .(LHO had none on face)

14. Powell photo. . . gives a ground up view of so-called "sniper's window" on the 6th floor. . . 14 A Dallas PD arrest report re: Oswald. . . Note time was 1:40 p.m. —just 30-40 minutes after JFK was pronounced dead. . .
15. Belmont to Tolson, 9/23/'63 62-109060-section 91 EBF serials 3811-3845. . . notes that paraffin tests cleared Oswald of shooting a rifle on 11/22. . . p. 2
16. Clark to Dallas, SAC, 11/22/'63 89-43-56 the business of the chicken bones found on the 6th floor. . . recommended that FBI do a fecal exam on Oswald.

20B Brennan description of the "man in the 6th floor SE corner window w/ rifle. . ." described by Brennan. See WCR p. 99 for pix of FBI agent at the 6th floor SE corner window. . . window raised about 15 to 16 inches. . . There was no way that Brennan 6 floors below could have estimated "Oswald's vital signs" with only lower half of his body exposed.

21. FBI does not get a copy of Bethesda Hosp. autopsy report until 12/23/63 after CD-1 was send to the White House and circulated at the top of the govt. 21 A Notes that Drain took possession of evidence in Dallas on 11/24/63 at 3:40 PM CST RG65 Box 56, section 149, section 22A

22. Willens before the HSCA . . . FBI did not believe that Oswald used the rifle in the JFK assassination . . .See item 15 above Belmont to Tolson . . .He admitted that the WC had no evidence that Oswald fired the rifle on 11/22. . .since LHO was alleged to own the rifle he must have used it. . .This argument wouldn't have passed muster in first year Law School tort court. .

Belmont ready to prepare a memo to AG Kennedy that Oswald was the shooter. The case is solved. . . (no trial therefore evidence not tested).

24. SAC to File, 11/23/'63 89-69-54 Shanklin notes not able to connect Oswald to the rifle (K1). . . Notes Marina who said he had a rifle in Russia (that was not possible. He may have had a shot gun or use of one). . . He noted that one smudge on rifle but "did not feel optimistic in regard to the possibilities of this smudge." Could not connect it to Oswald. This was 11/23. . . 11/24 and everything was different—Oswald did it and he acted alone, etc. . . What a difference a day makes. . .

25. FBI report by Agents Thompson and Lish on 11/23/'63 105-82555-505 (section 21), p. 12. Here is the manufactured account attributed to Brennan. . . The basic Brennan apocryphal account. . .
