The Strange circumstances of the Murder of LEE HARVEY OSWALD

I know of no one who does not regret the assassination of President John Kennedy. Though he was a minority president, elected under conditions bordering on the scandals that elected Lyndon Johnson a United States Senator, no American would wish his assassination.

The first hysterical cries of the anti-anti-Communists, that call themselves "liberal," were shrill in the implication that it was undoubtedly the premeditated work of the John Birch Society.

The self-styled "Voice of America" notified the world that the President had been killed in Dallas, "center of the extreme right wing movement." This set the tone of other European broadcasters—hymns of hate against all who believe in freedom, and the liberty of the individual under law.

Political clergymen and politicians, who have never been noted for casting a ballot in behalf of principles or constitutional government, were herded to America's microphones, and while decrying "hate," dripped the crimson venom of Marxist objectives upon all who are opposed to the subjugation of America into a one-World government.

The immediate effort to head off The House Committee on Un-American Activities from investigating the assassination of the President, and dragooning it into the hands of a scared cow political clique calls for both a Senate Judiciary Committee and a House Committee investigation. Every American with the life of his country and his family at stake from "Directives" already made and

"treaties" already enacted should ask his Congressman and his friends and neighbors a number of questions.

Why was Texas picked for the assassination of the President? This was no hot headed spur of a moment assassination. Who picked the location and why Dallas instead of San Antonio? Why not Washington or Boston?

Why did the Voice of America suddenly stop referring to the right-wing extremists in Dallas and fail to inform its listeners that Oswald was an admitted Communist. Why the marshmallow-mouthed reference to him as a "Marxist?" Why did Lyndon Johnson on November 26th order the FBI to make a thorough investigation of the case and promise that FBI reports would be made public immediately? Why did Lyndon Johnson, three days later, reverse himself and follow the Communist Worker's recommendation that he appoint a special commission under Chief Justice Earl Warren to handle the investigation?

The best documentation on this strange situation has been covered by Dan Smoot in his December 9 report.

My space is limited this issue. I suggest that you inform yourself as to why a President follows the recommendation of the official voice of the Communist party in America. When in the same editorial calling for such action they fail to tell the people the truth that Oswald has been a lifelong Communist and instead put the blame on the "Ultra-right."

Why is the Council on Foreign Relations represented on such a

Of all the honorable and respected men in America why were only "liberal" Democrats and Republicans named to the commission? Did the Worker also supply the names and if so how did the name of Senator Russell of Georgia manage to get on the list?

Who furnished Oswald with information that caused him, in the middle of the night, to rent a room a mile from the route and the next day get a job in a building on that route?

Remember that this was SIX WEEKS before the route was published in the Dallas papers!

Has your local newspaper or radio identified the slayer of Oswald as Jack Rubenstein alias Jack Ruby? Martin Dies of the Dies Committee has identified a Jack Rubenstein as coming to his attention during his chairmanship of the Committee.

Will the investigation into the murder of Oswald make public why in May of 1962, the U.S. Embassy in Moscow renewed Oswald's passport to return to this country, included his infant daughter, gave his wife a non-quota visa and advanced him \$435.00 for travel expenses?

What was the source of all of Oswald's travel money? How did it happen his wife was destitute in New Orleans with two children when she was picked up by a friend and brought to the Fort Worth area, but that when arrested he had \$150.00 dollars in his possession?

Why has the Communist party, after enactment of Congress-

sional legislation requiring it to do so, never been required by Bobby Kennedy to register its members?

Why were innocent citizens, registering their right of protest by carrying picket signs, thrown into jail and held for four days?

Is there to be an investigation into the State Department, the CIA and the Executive branch of the government in this case?

Why did the State Department renew Oswald's passport and pay his way back to the country after he had renounced his American citizenship?

Why did they, a year later, grant him another passport to return to the Soviet Union? Who is it in the State Department that accommodates known and admitted Communists but plots the firing of a loyal American such as Otepka at the State Department.

Who was the mastermind behind Oswald who furnished him the exact route of the President six weeks before it was published?

Where was the source of his money?

With Chief Justice Earl Warren heading up a "commission" to supposedly investigate the assassination of President Kennedy, will they now turn the full force of government toward the investigation of the murder of Lee Harvey Oswald?

On December 2, 1963 the Dallas News made public the news that the FBI reports will not be made public, as President Lyndon Johnson promised on November 26, 1963.

Do you believe that an honest full and impartial report of the

murder of John Kennedy and Lee Harvey Oswald will ever be made public?

Does the death of John Kennedy make any less obnoxious the Communist aiding legislation proposed by the Kennedy Administration now than when he was its mouth-piece?

Motives

As one reviews the circumstances and activities of Jack Rubenstein, alias Jack Ruby, it is impossible to dismiss the Kennedy assassination as the unrelated acts of two psychotics. Dan Smoot in a recent report has summed it up succinctly... "circumstances gave rise to the presumption that Jack Rubenstein and Oswald were involved together, with others unknown, in a plot to assassinate President Kennedy, and that Rubenstein murdered Oswald to silence him. Indications now are that this presumption may never be proved."

Perhaps only a totally new administration will ever be able to give the people the truth of the Oswald murder. Only an honest investigation of the State Department will probably ever disclose the murder of President Diem and his brother. The betrayal of the China mainland into the Soviet slave labor dynasty, the unseating of Sigmond Ree and every other anti-Communist that has been an obstacle to Communism's dream of world domination.

There is nothing that Communism fear more than an informed American. Why is the American press afraid to expose the full truth of the Kennedy and Oswald assassinations?

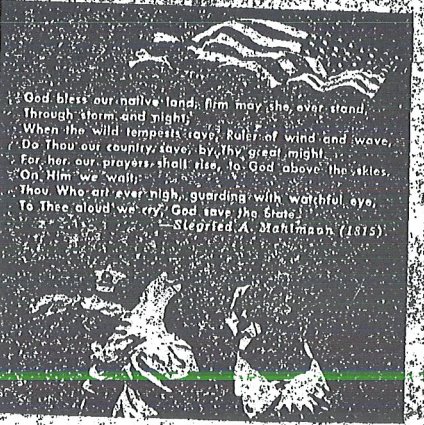
Oswald Attacked Walker With Words Before Gunshot
