

Walker Notes (New docs), FOLDER # 10

1. Notes made by Mike Clark and Mike Simmons RG 64 NARA Key doc.  
Based on evidence they agree w/ Walker that Q188 in evidence with the Commission and FBI is not the slug found in Walker's house. \only initial they could find on Q188 was that made by Lt. Day. . . .They agreed with Walker. Also (not in this doc. but Walker claimed he made his own mark on the bullet. . . \*\*\*\*Key document. .
2. Latona to Trotter 12/5/'63 reports that he could not lift Lee or Marina's fingerprints off the note. . . .there were 7 latent prints on the letter but none belonged to Lee or Marina. . .
3. There is a batch of docs dealing with the pix of a car that was outside Walker's residence. This is Hoover to Rankin June 16, 1964 105-82555-4107.....p.2 under Note: . . . . . that FBI engaged in "intensive inquiries" in the Walker case . . . but "our investigation did not establish whether Oswald did or did not make the attempt on General Walker's life." (This of course was not included in the Hoover note to Rankin . . . \*\*\*\*\*)
4. Branigan to Sullivan 2/2/'64 105-82555-76 centers around pics of Walker's house. . .query: Were they taken by Oswald. . .
5. SAC, Shanklin to File, 12/'6/'63 89-43-2613a Section chief James Handley called to see if the Dallas PD had Oswald as a suspect in the Walker shooting. Shanklin gets back and says no that Oswald was not a suspect. This was 11:20 P.M.
6. DeLoach to Mohr, 12/6/'63 62-109060-1691 Notes that Katz called to tell DeLoach that Sandy Smith of Chicago Sun-Times called to get confirmation whether Oswald was a suspect in the Walker shooting. . .DeLoach said he heard of that story but the FBI has not been the source, etc. . . .Katz then remarked that Salinger at WH was calling Katz. . . .Katz then told Salinger that since the story was out to "merely confirm the fact that apparently there was evidence that Oswald had made an assassination attempt upon General Walker." \*\*\*\*\*) Key to develop/Katz's launching the Oswald as suspect fits like a glove with his Memo on 11/25. . . .\*\*\*\*\*) Perhaps that is where to develop. . .
