Two members to express grave reservations about their church becoming deeply involved in the Poor People's Campaign. By th indicated to that they desired a meeting of the Board to air the Issues Involved. In the evening of 18 Harch 1963, the Board of Directors wet to discuss their participation. A "blanket endorsement" of the Poor People's Compaign was proposed. The Board split four to four. Assecond proposal called for the Church's Social Responsibilities Committee to serve as the focal point for receiving and reviewing all requests for support by the Poor People's Campaign whether from the SCLC or the Virginia Council on Human Peletions. The proposal called for the church to examine each request and situation as it developed and to decide on the support to be rendered—or not rendered. This second proposal was approved by a seven to one vote, the solo dissenter being

The first request to be considered under the Board's approved guideline was that requesting the church to act as a store-house for food supplies. The Board agreed to honor the request.

Because of his deep concern that the Arlington Unitarian Church and its Board might be duped or exploited by elements of the Poor People's Compaign, the source has indicated a willingness to provide additional information as the Campaign develops.
