Also attached is a copy of Mexican Immigration form setting forth descriptive data on ALVARADO UGARTE. The photographs, fingerprint card, and form were made available to this office by Lic. SANTIAGO IBANEZ LLAMAS, head of the Inspection Section of the Mexican Immigration Service.

It is requested that the fingerprint card be searched through the files of the Bureau's Identification Division and this office furnished with four copies of any identification record which may be found for him.

When it was pointed out to her that the letter from was dated 9/1/63 and postmarked 9/2/63, she herely commented that probably the communists have facilities for falsifying postmarks.

When was interviewed, he was unable to fix the date of the party but he believed it was probably early in September and neither he nor the two acquaintances of his who accompanied him to the party could recall any Americans having been present.

Officer Claimed that the party where she had met of as held at the home of RUBEN DURAN "in September 1963, shortly after her return from abroad" as reported in memorandum of 12/10/65.

In her conversation with reported in his memorandum of that date, claimed that she believed the party was about September 2 of 5, 1963, "a few days before the visit of Soviet astronaut GAGARIN".*

Inasmuch as the Bureau is in possession of all of memoranda concerning story except his memorandum of 12/10/65 (his memorandum die dated the date of his conversations and not the date typed), copies of that memorandum are enclosed herewith for the completion of the Bureau's files. The Bureau will note that all the pertinent information contained therein is set forth in Mexico City cablegram of 12/17/65.

Observations

The following is submitted in response to the Bureau's request regarding my observations of statements in his memorandum furnished to the Secretary of State:

* Mexico City newspapers show that Soviet astronaut GAGARIN was in Mexico from February 8 to 23, 1963.
