PROBABLY SUNDAY, NOV. 14, 1976, OR POSSIBLY AS LATE AS SUNDAY NOV. 21. 1976. WHICH IS THE DAY BEFORE THE 13TH ANNIVERSARY OF THE ASSASSINATION. KESSLER STATED HE HAS INTERVIEWED A PERSON OF PERSONS FAMILIAR WITH THE OPERATION OF THE INTELLIGENCE DIVISION. FRIHO. AND MAS OUESTIONED THEM AS TO WHAT THE FRI WOULD HAVE DOME IF FRING MAD BEEN IN POSSESSION OF ALL OF THE IMPORMATION AVAILABLE TO THE CIA ON OSWALD'S VISIT TO THE SOVIETS IN MEXICO CITY.
