It appears that staff members will be present at the meeting this afternoon. Several of them wished presented the question of whether Marina Oswald should be further cross examined. As a matter of fact, when she was examined the second time a list of questions were prepared, but the Chief Justice gave instructions that cross examination should not be pressed beyond a discussion (primarily) of the Nixon-bathroom episode. My understanding is that these were given directly to Mr. Rankin who so informed other staff members. It was requested that the question be brought up before the full Commission; Mr. Rankin indicated he could not do so; no other staff member wants to "beard the lion" but I think some of them might speak out if the issue were raised. - (c) A prior lie is involved in Marina giving answers to the US Embassy in Moscow to the effect that she belonged to no Communist organizations except the Trade Union group, which was in fact exempted because membership therein was necessary for her to obtain employment. She did in fact belong to C'MOSOL, the youth group which gives instruction preparatory to going on to the Communist Party membership, which Marina was not eligible for at the time she left Russia because of her age.
- left to get sighted at Dyal Rider's Trying Sports Shop early in November (not the same rifle as that used to shoot the President) with the name "Oswald" on the repair tag. Intensive investigation turned up no other Oswald who admitted to leaving a rifle there. The testimony of the Sport Shop employee may be fabricated, but it is supported by that of two women who say that three persons, whose descriptions match those of Oswald, Marina, and the baby Rachel, came to the store inquiring directions to a gun repair shop and that they were sent to Irving Sports Shop. Marina stated definitely that she never went out with the baby, Rachel, during this time.

of information as to Oswald's alleged decisions to shoot General Walker and Vice President Nixon. I believe she is the only person to identify as Oswald's the camera which made the snapshot showing Oswald holding a rifle and with a pistol strapped to his belt. (These weapons resemble but cannot be absolutely identified as being the weapons in question.) Marina is the only source of much damaging testimony, such as that Oswald wanted to hi-jack an airplane to go to Cuba, that the letters written by her to the Soviet Embassy seeking a Soviet visa were under duress from him; that she knew in advance of the Mexico trip and thought he was probably intending to go to and remain in Cuba (of course we know he did contact the embassies there with this destination in view); that he forced her to sign the name "Hidell" to one of the forged identification cards; that he took the rifle out to practice, and so on.

Further, Marina Oswald has contradicted herself many times. She first told the FBI she did not know Oswald was planning to go to Mexico. She said she did not know about "Hidell" until the FPCC debate in New Orleans in August; later admitted she signed the card before that. (Tapes of the debate show no mention of "Hidell"). She first said she locked him in the bathroom the morning of the Nixon episode;

is strengthened in this by his conversation with the Governor. He finds it difficult to believe, however, that the bullet which was recovered could have traversed the Governor's body, the wrist and penetrated the thigh without showing more marks of distortion.

(5003) The Governor's reaction would be expected to be very prompt in view of the bullet hitting bony structure. Dr. Shaw performed the operation closing the chest wound. Aside from technical details the testimony is primarily interesting due to the fact that after being shown the bullet he seems to have changed his mind markedly as to whether the three wounds suffered by the Governor had been caused by the same missile.
