LEE HARVEY OSWALD, AKA. IS DASH R DASH CUBA. OO--DALLAS.

MR. AND MRS. DECLAN P. FORD INTERVIEWED DALLAS FEBRUARY TWENTY LAST CONCERNING MARINA OSWALD'S ESCAPADE WITH JAMES HERBERT MARTIN IN WASHINGTON.

MR. FORD ADVISED AS FOLLOWS: HE AND HIS WIFE MET MARINA AND LEE OSWALD SUMMER, SIXTY-TWO. IN NOVEMBER SIXTY-TWO, MARINA, WHILE ESTRANGED FROM HUSBAND, VISITED IN THEIR HOME. MARINA AND LEE OSWALD ALSO ATTENDED PARTY AT FORD HOME LATE DECEMBER SIXTY-TWO. MRS. FORD SPEAKS RUSSIAN AND IS A FRIEND OF MARINAS. FORDS WERE AWARE MARINA WAS LIVING AT MARTIN HOME FOLLOWING ASSASSINATION. IN EARLY JANUARY LAST AND AGAIN SHORTLY BEFORE SHE WENT TO WASHINGTON TO TESTIFY, MARINA AT HER REQUEST VISITED AT FORD HOME ON WHICH OCCASIONS SHE WAS ACCOMPANIED BY SECRET SERVICE AGENTS.

ON FEBRUARY TWELVE LAST MARINA REQUESTED MRS. FORD IF SHE COULD STAY AT FORD HOUSE. SHE RETURNED FROM DENION, TEXAS, TO THE FORD HOUSE ON FEBRUARY THIRTEEN LAST.

MARINA ASKED MR. FORD WHAT SHE SHOULD DO CONCERNING HER BUSINESS ARRANGEMENT WITH MARTIN. MR. FORD TOOK MARINA TO ATTORNEY THORNE-S OFFICE ON FEBRUARY THIRTEEN LAST AND OBTAINED COPIES OF CONTRACT BETWEEN MARINA AND THORNE AND MARINA AND MARTIN, ALSO A TRUST AGREEMENT WITH FIRST NATIONAL BANK OF FORT WORTH, FORT WORTH, TEXAS. ON FEBRUARY THIRTEEN LAST. MR. FORD TOOK MARINA TO ROBERT OSWALD-S HOME IN DENTON, TEXAS WHERE SHE PICKED UP HER CLOTHES AND HER BABY DAUGHTER AND AT WHICH TIME ROBERT OSWALD SAID HE HAD MADE APPOINTMENT FOR MARINA TO SEE ATTORNEY WILLIAM A MC KENZIE. MR. FORD ACCOMPANIED MARINA TO MC KENZIE-S OFFICE THAT DAY AND ALSO ON FEBRUARY EIGHTEEN LAST FOR PURPOSE OF CONFERENCES WITH MC KENZIE. MARINA CONTINUES TO RESIDE AT FORD HOUSE.

MR. FORD STATED THAT ALTHOUGH HE WAS AWARE THAT SOMETHING HAD HAPPENED BETWEEN MARINA AND MARTIN IN WASHINGTON, HE DID NOT KNOW THE DETAILS UNTIL THIS INVESTIGATION BEGAN.

ON FEBRUARY FOURTEEN LAST MR. FORD WROTE OUT REGISTERED LETTERS DIRECTED TO THORNE AND MARTIN ADVISING THEM THEIR SERVICES

AS ATTORNEY AND MANAGER WERE TERMINATED. MARINA SIGNED THE LETTERS. THESE LETTERS SENT BECAUSE MR. MC KENZIR HAD ADVISED HE COULD NOT REPRESENT MARINA WHILE SHE WAS REPRESENTED BY ANOTHER ATTORNEY. MC KENZIE IS NOW MARINA'S ATTORNEY.

MRS. FORD ADVISED SUBSTANTIALLY THE SAME AS HAD MR. FORD WITH CERTAIN ADDITIONAL INFORMATION. DURING JANUARY LAST, WHILE MARINA RESIDING MARTIN HOUSE, MARINA CALLED HER ON PHONE SEVERAL TIMES. ON ONE OCCASION, MARINA SAID WHILE SHE WAS TALKING ON PHONE, MARTIN WAS THROWING KISSES TO HER AND MRS. FORD GOT THE IDEA MARTIN WAS MAKING PASSES AT MARINA.

WHEN MARINA RETURNED FROM WASHINGTON, MARTIN CALLED MRS. FORD ON PHONE, FEBRUARY EIGHT OR NINE LAST, STATING ROBERT OSWALD HAD TAKEN MARINA TO HIS HOME AND MARTINE WAS AFRAID ROBERT WOULD TAKE MARINA MARINA'S MONEY AS HE (ROBERT OSWALD) WAS MORE INTERESTED IN MONEY THAN MARINA. MARTIN ALSO TOLD HER, THAT MARINA HAD TOLD ROBERT ABOUT LOVE AFFAIR BETWEEN MARTIN AND MARINA. A DAY OR SO LATER, MARTIN CALLED REQUESTING MRS. FORD TO ACCOMPANY THORNE TO SEE MARINA AT ROBERT OSWALDS HOUSE,

WHICH SHE AGREED TO DO. ENROUTE, THORNE TOLD MRS. FORD MARTIN WAS A HELL TO HAVE DONE WHAT HE DID TO MARINA. THORNE SAID MARTIN WANTED TEN THOUSAND DOLLARS TO ALLOW MARINA TO CANCEL CONTRACT WITH HIM BUT HE, THORNE, HAD TALKED MARTIN DOWN TO FIVE THOUSAND DOLLARS. THORNE SAID THIS HAD BEEN HARD TO DO BECAUSE MARTIN SAID HE WOULD USE WHAT WAS BETWEEN HIM AND MARINA TO RUIN HER IF SHE DID NOT PAY HIM. THORNE AT THIS TIME TOLD MRS. FORD THAT MARTIN AND MARINA QUOTE HAD [REDACTED] IN WASHINGTON UNQUOTE WHICH SHE TOOK TO MEAN THAT THEY HAD HAD [REDACTED]

MRS. FORD STATED SHE, MARINA, NEVER ACTUALLY TOLD HER THE DETAILS OF HER ESCAPE^{AD} WITH MARTIN AND SHE DIDNT KNOW UNTIL THIS INVESTIGATION BEGAN. MRS. FORD ACTED AS INTERPRETER IN INTERVIEW WITH MARINA BY FORREST SORRELS, SECRET SERVICE, DALLAS.

ON ABOUT FEBRUARY TWELVE LAST, WHEN SHE WAS IN DENTON, TEXAS WITH THORNE, MRS. FORD WAS REQUESTED BY MARINA IS SHE, MARINA COULD STAY AT THE FORD HOUSE. MRS. FORD AGREED AND MARINA HAD STAYED AT THE FORD HOUSE SINCE THAT DATE.
