Memorandum dated 12/31/63 from J. F. Bland to Mr. Sullivan set forth information received that Norman Redlich, a professor of Constitutional Law at New York University, might be working with the President's Commission.

Today, while discussing other matters with Mr. J. Lee Rankin of the President's Commission, it was mentioned it was understood Mr. Redlich was either working or might be going to work for the Commission. Mr. Rankin advised that Redlich was actually working with the Commission at the present time. The memorandum prepared by the Bureau detailing the ~~_____~~ of Redlich was made available to Mr. Rankin for his information. When he had finished reading this memorandum, Mr. Rankin was asked whether he was aware of the background information that had been supplied to him. He stated he was not and that he appreciated the information which had been furnished to him. He gave no indication of what action he would take relative to Redlich and no further questions were asked of him concerning Redlich.
