MEMORANDUM FOR MR. TOLSON

On November 18, 1953, Assistant Attorney General
Warren Olney called to see me.

He stated he first wanted to congratulate me upon my
appearance before the Jenner Committee on the previous day. I told him
I appreciated his expressions but that it was a most distasteful experience
to have to go through; however, I felt that in view of the insistence of the
Committee upon my appearance and the further fact that there had been
a false presentation of the Bureau's position in this matter by certain
elements, that it was imperative that I appear and set the record straight.

Mr. Olney stated that he was desirous, if possible,
of obtaining the services of someone from the Bureau who could set up a
proper records system in the Criminal Division. I told Mr. Olney his
request could not be granted because the Bureau needed its present
staff to handle its current responsibilities. Mr. Olney then asked if I
could recommend anyone who had been formerly in the Bureau who
might be able to advise and counsel them in this problem. I told him
the only one I knew of off-hand was [redacted] who had been an Inspector
in the Bureau and at the present time was working as a consultant with
[redacted] in the State Department. I stated [redacted] was an
expert; having been an accountant and having been an Inspector he had a
knowledge of the operation of a records system. Mr. Olney indicated he
intended to contact [redacted] to see whether he could obtain his services
in the particular matter.

During the course of our conversation, Mr. Olney advised
[redacted] was now beginning to talk and he believed they would
develop some very valuable information from him and be able to
bring up other cases for prosecution.
