SUBJECT: LEE HARVEY OSWALD

Assistant Director JOHN MALONE stated that the following is the answer of ANATOLE A. BOGUSLAV to Bureau airtel 11/27/64 to Dallas and New York:

"I have reviewed the portions of Mrs. OSWALD's testimony, as provided on pages 79,80 of Vol. I of the hearings before the President's Commission on the assassination of President KENNEDY.

"I wish to emphatically state that I or no FBI representative in my presence or to my knowledge under any circumstances took a position with Mrs. OSWALD that if she did not answer questions or cooperate, she could not stay in the United States or in this country.

"At all times during the interrogation of Mrs. OSWALD, a business-like, polite approach was taken by me and by Special Agent WALLACE R. HEITMAN when we talked with Mrs. OSWALD.

"Her status in this country was discussed with Mrs. OSWALD by a representative of Immigration and Naturalization Service, with SA BOGUSLAV serving only as an interpreter.

"No questions posed by Immigration and Naturalization Service, as interpreted by me could be classified as threatening her with expulsion or deportation if she did not cooperate."

The liar is Boguslav. Shanklin could pretend no personal knowledge. Marina's allegations to the Commission are both truthful and understated. The Secret Service leaned on her on its own and for the FBI. I have the proofs. (It became so much a Secret Service scandal they had to have an internal investigation, which I also have.) The FBI could hardly have been more explicit in giving her the choice between "cooperation" and deportation. (The Secret Service added enrichment and a bed-mate.) As a result Marina contradicted herself on everything she was asked to say the opposite about and explained this before the WC by saying to them she had not been under oath so under oath they could depend on her not lying any more.

The FBI played hardball from FBIHQ. First it arranged to be with her alone except for an INS official of FBI choice. Although she was in Secret Service custody the FBI got rid of SS too. Then it spelled out exactly what Marina testified to. Using the INS man for this. I have the FBI's own records on this. It was their HQ idea, not Shanklin's or Heitman's.

If you read Boguslav carefully he falls short of saying no threat was made. Only that the FBI made no threat and that he only "interpreted."

I don't know if ousting SS made any problem for the FBI. I doubt it. But if it did in short time the FBI had all it needed to get whatever it wanted from SS - Marina's sex life. (A reporter I know was told by Sullivan of the FBI's taping of her bed noises and conversations. The FBI has given indication of only her then business agent, Martin. However, at one time in the Willard she took on two or both of her "guards," then under SS "protective custody.")

From what I knew early on I titled my Marina chapter in Whitewash II "Scheherazada." Mybe it could be improved now but is was accurate!
